**1. APOLOGIES**

Apologies for absence were received and accepted for The Mayor and Councillors Chen, Cotter, Gough, Jones and Turner.

Councillor Scandrett arrived at the meeting at 11.11am and Councillor Clearwater at 11.14am.

**2. SUBMISSION**

The Panel **resolved** on the motion of Councillor Buck, seconded by Councillor Lonsdale, that the Council adopt the draft submission on Proposals for Regulations Under the Food Act 2014 as amended to note that as representatives of its community the Council feels very strongly that all imported foods must have clear, easily readable and standard format labels which include:

- country of origin
- country of manufacture
- the salt and sugar content
- clear descriptions of added chemicals which are able to be understood by consumers
- whether the food is genetically engineered, or irradiated or has undergone any other unorthodox process.
