2. Approve that the stopping of vehicles be prohibited at all times on the south side of Armagh Street commencing at its intersection with Colombo Street and extending in an easterly direction for a distance of 32 metres.
3. Approve that a Loading Zone (restricted to a maximum period of 5 minutes) be installed on the south side of Armagh Street commencing at a point 32 metres east of its intersection with Colombo Street and extending in an easterly direction for a distance of 14 metres.
