Dear Mr Croucher

I was very surprised to get your email letter of 17 January 2017. It is a complete reversal of the information that I have been given by Council staff, both in writing and verbally (phone), over the preceding months.

The content of your email is a total and unacceptable back-flip. It came right out of the blue, without any indication that the path this was going down was now being abandoned.

I had been told that a sound-proof fence would be erected. I was told the date on which this work was due to commence with the fence posts being put in on the 15 and 16th December, and the wooden pailing would be going on the 20 and 21 December 2016, I was also told that plantings would be put in to soften the visual impact of the new fence and in keeping with the park. Of course, none of this actually happened.

I have been told many times by Council staff that signs don't work – and that was more than adequately proven by the placement of a sign at this court early in 2016. So why will a sign work now?

I have real concerns about the validity of the sound-testing you describe. It does not say so but it must be assumed that someone bounced one basketball an undefined number of times, during daytime and the sound level was measured from that.

Such a "test" is a significantly different situation from the real world. My complaints are that there are often multiple basketballs, multiple "players", with a combination of the bouncing sound and the noise of people running around and verbalising – loudly – over prolonged periods during the evening, often after dark and often late into the night. It is not just one basketball bounced a few times. This is a continuous barrage – much more different than one basketball being bounced a few times. One night two youths arrived at 11pm and woke me up. I couldn't go back to sleep, so I stayed up. This is not acceptable!

I'm all for the kids playing, but they show no respect or regard for anyone else and become a nuisance late at night. Sound in this situation carries through the quiet of the evening and is a very different proposition to the sound of the short-term bouncing of a basketball, without the accompanying human sounds, against the background noise of daytime traffic and normal community activity.

That sort of noise is acceptable during the day. It is not acceptable at night, particularly when it infinges on my ability to sleep. Even one basketball with one "player" in the evening is a very different and unacceptable intrusion than the same thing during the day.



Just as someone made an arbitrary decision to create this nuisance, it seems that they are now able to make an arbitrary decision as to what they think is an acceptable daily timescale for this nuisance to occur.

I'm sorry but I do not agree. The basketball court should not have been put there in the first place.

As we all know – and Council staff confirm - signs do not work. So, assuming that the arbitrary timeframe chosen by Council staff is posted on a known to be ineffective sign, I have two questions:-

- a) What powers of enforcement does Council have to ensure that those hours are not breached and if they are breached, to take action against offenders?
- b) Who do I call after the 9.00 p.m. cut-off time to have the timeframe enforced? Your email makes it clear that the noise level is not, in Council's opinion, exceeding any noise standard and therefore the usual noise abatement process available to me is clearly not going to be available in this situation. Will you be providing me with the telephone number of the staff member responsible so that they will immediately come out, irrespective of the time of night, to have the offenders cease and desist?.

I have several other questions:-

- a) Why does the basketball facility at the corner of Joy Street and Pagoda Street (Pagoda Playground) in Shirley have a soundproofing fence but one will not be erected at the Fairway Park facility only a few kilometres away? What is different there to here?
- b) Why is that some staff members within the Council recognise that these facilities are a nuisance and actively oppose them in the "planning" stage but are ignored?

This all gives the impression of a situation where Council staff have a "bright" idea, make decisions which do not affect them personally and then irrespective of whether they might be right or wrong, will defend that decision to the bitter end, knowing full well that the resident / ratepayer has virtually no ability to challenge those decisions or to protect their rights to the natural and peaceful use and occupation of their home. It makes the Christchurch City Council a very bad neighbour indeed.

The decision you are recommending to the Board, to take no action (except for signage) to effectively remove the nuisance created by Council, as outlined in your email is not acceptable and does not bring this matter to an end.

As I stated in my letter dated 5 April 2016, the Council needs to recognize and take responsibility for the nuisance it has created. The Council has put this thing there. Council should get rid of it, or at least do everything they can to arrive at an acceptable solution for all.

7. Fairway Reserve Basketball Court - Noise Complaint

1. Purpose of Report

1.1 This report fulfils the previous Board's request for staff to investigate options for mitigating the noise issues from the Fairway Reserve basketball court backboard and to bring the investigation results back to the Board.

2. Staff Recommendations

That the Coastal-Burwood Community Board receives the information in the report noting that noise levels at the Fairway Reserve basketball facility are compliant with City Plan standards.

3. Key Points

- 3.1 On 18 April 2016 the Burwood/Pegasus Community Board received a deputation from Linda Callaghan, resident of Giles Place who was concerned at noise from the Fairway Reserve basketball facility, especially at night. The Board requested that staff investigate options for mitigating the noise issues and to bring the investigation results back to the Board. In a customer service request lodged the year prior, Linda Callaghan had noted that noise from the basketball court in the Reserve behind her house goes from around 9-10pm at night and sometimes starts around 7am.
- 3.2 The Council's Environmental Health Officer has provided the **attached** noise assessment which was carried out to determine whether or not noise from people using the basketball court, i.e. bouncing a ball on the concrete and against the backboard, would comply with City Plan noise standards at Linda Callaghan's Giles Place property. The report concludes that noise levels taken by the fence line during use of the court are compliant with those standards and the Council is not in a position to take further action in response to basketball noise complaints.
- 3.3 Staff have replaced old bolts to stop the basketball ring from rattling. At the time of this report's preparation, it is intended to reinstall signage following vandalising which will be either be concreted in place or become part of the entrance signage. The sign will request users of the Fairway Reserve Basket Ball Court to restrict their use to between 8am and 9pm.
- 3.4 There have not been any similar noise complaints from other residents who border the Reserve.

Fairway Reserve – Basketball Noise Complaint Investigation

- 1. A visit was made to Fairway Reserve on Wednesday 21/12/2016 at 10:15 am. The purpose of the visit was to determine whether or not noise from people using the basketball court (i.e bouncing a ball on the concrete and against the backboard) would comply with City Plan noise standards at 2/12 Giles Place. I was accompanied by Simon Curtis, Parks Advisor.
- 2. At the time of the visit it was approximately 22-23°C, fine and sunny, with a light breeze blowing in from the east.
- 3. The general environment was very quiet; with the following noise sources noted:
 - Distant traffic noise from QE2 Drive;
 - Occasional traffic (i.e 1-2 cars per minute) along Fairway Drive;
 - An occasional slight hum from a 2 tonne excavator on the driveway at 7 Fairway Drive (approximately 95 metres SE of the measurement position);
 - Birdsong.

No aircraft, other park users or dogs were observed or heard throughout the duration of our visit.

- 4. An inspection of the boundary fence (between 2/12 Giles and Fairway Reserve) was also undertaken. The fence is in good, solid condition with no gaps or cracks of concern. Whilst it does not meet the minimum specifications of an acoustic fence it is considered capable of attenuating noise by approximately 5dB.
- 5. A measurement position was selected (see the pink dot on the aerial view below). This point was located approximately 4-5 metres from the western boundary fence.





6. The first measurement was taken between 10:24 am and 10:29 am.

The purpose of this measurement was to determine the 'background' (L_{A90}) noise level, and included those sources that are continuously present; traffic, aircraft, people, animals, birdsong etc. The results were as follows:

L_{A10}: 42dB L_{Aeq}: 41.4dB L_{A90}: 38.5dB

7. The second measurement was taken between 10:33 am and 10:38 am.

During this period Simon was bouncing the basketball and shooting hoops. The purpose of this measurement was to determine how much the noise levels above increased as a result of activity on the basketball court.

The results were as follows:

L_{A10}: 48.5dB L_{Aeq}: 46.3dB L_{A90}: 41.0 dB L_{Amax}: 61.1dB

The background level (L_{A90}) increased by 2.5 dB as a result of activity on the basketball court. In addition, the L_{Aeq} (i.e the average sound pressure level) also increased; by approximately 5dB.

- 8. The L_{Amax} is a maximum sound pressure level, and represents a more impulsive sound, such as a basketball hitting the backboard, or a car door slam.
- 9. This site is zoned Living 1, therefore the Group 1 Zone day time development noise standards (i.e the most noise sensitive) apply.

These noise standards are as follows:

10. The results indicate that compliance with the applicable noise standards is being achieved.

A noise level of 46.3dB L_{Aeq} is compliant with the 50dB L_{Aeq} day time standard. A noise level of 61.1dB L_{Amax} is also compliant with the 75dB L_{Amax} day time standard.

- 11. It should be noted that these levels are indicative of the noise received 4-5 metres inside the western boundary of Fairway Park. It is expected that these noise levels would drop a further 5dB (at least) if a measurement was taken at 2/12 Giles Place; on account of the additional distance and the boundary fence.
- 12. Based on these results, Council is not in a position to take further action in response to basketball noise complaints.
- 13. If a timber fence was erected between the basketball court and the reserve boundary it is not certain if this would provide any further attenuation. It also raises Crime Prevention Through Environmental Design (CPTED) issues, may result in additional noise (children could bounce/throw balls against it) and it may become a target for taggers.
- 14. Finally, under Vol. 3, Part 11, 1.2.3 the following activity is excluded from the noise rules in Clauses 1.3.1, 1.3.2 and 1.3.4.
 - (j) spontaneous social activities and children's play (but not including pre-schools in Living Zones);

Noise from children using the basketball court is likely to fit this description.
