She suggested the Committee write to Central Government for an update on copper free brake pads, and education/communication with brake pad suppliers and installers.

Action: Staff were asked to check if a letter had been sent to Central Government about copper free brake pads, and to follow up on the education/communication with brake pad suppliers and installers.

# 7. Behaviour Change Proposal - Christchurch City Council

Clive Appleton, Natural Environment Team, Christchurch City Council updated the Committee on the Christchurch City Council's Water Partnerships, a new initiative of the Councils working together with agencies and community groups to raise awareness around and to stop contaminants at source so they do not enter the stormwater network.

The following points were noted in the discussion on this matter:

- the Zone Committee can assist by facilitating a workshop for interested groups to understand what assistance they require, either financially or from staff help, and in what areas;
- focus on sustainable water use and wastewater systems, and on sediment, rubbish, copper etc:
- input by Te Rununga, industry, e.g. the paint industry, businesses and school groups;
- requires consistent messages, core information with good explanations.

# 9. Haytons Stream Catchment

Nick Moody's powerpoint presentation on Haytons Stream Catchment, included the following points:

- the stream is spring-fed
- it is at the start of the Heathcote-Ōpāwaho River
- it is the most polluted river
- work is being carried out with the Christchurch City Council regarding land use pollutants;
- restoration of stream banks and beds
- working collaboratively with businesses to ensure behaviour changes.

Nick responded to questions of clarification about his presentation.

## **10. Port Hills Fire Recovery**

James Tricker updated the Committee on the Port Hills Fire Recovery, including information about the bus trip to affected areas, and on the Fire Recovery Plan discussion document.

Tim Joyce of the Operations Land Drainage team, Christchurch City Council will be invited to the next Christchurch West Melton Water Management Committee meeting to discuss issues relating to the Port Hills recovery.

James responded to questions from Committee members about the remediation work being carried out, with discussion on:



- discussion will be held with the company that will remove tree stumps and root zones
- replanting options and regrowth of bracken and native species, e.g. broadleaf species
- strong support by the Zone Committee for the use of sediment traps.

# 11. Avon-Heathcote Estuary Ihutai Trust - Mother of All Clean Ups

Charlotte O'Sullivan advised that a logo had been created and media communications on the Mother of all clean ups to be held on Saturday, 13 May 2017 along the banks of the Ōtākaro/Avon and Ōpāwaho/Heathcote Rivers.

Committee members were asked to inform Lesley Woudberg if they will be attending the Clean up. There was a suggestion about Committee members wearing high viz vests with the Zone Committee name on them.

A suggestion was discussed about the removal of large items of rubbish, e.g. washing machines or vehicles, using a towtruck on the day, or the Snap Send Solve app. Charlotte advised she would discuss the matter at the next Avon-Heathcote Estuary Ihutai Trust.
