#### 1. Purpose and Origin of Report

#### **Purpose of Report**

- 1.1 The purpose of this report is for the Road Closure Subcommittee to consider an application for a proposed road closure for the following event: Lions Tour Fan Zone.
- 1.2 The event organiser proposes four separate events to close Poplar Lane between Lichfield Street and Tuam Street, as well as Ash Street from Poplar Lane to 40 metres west of Madras Street.
