## **10.** Hussey Road - Proposed Bus Stop Relocation

#### Staff Recommendations

That the Fendalton-Waimairi-Harewood Community Board resolve to:

- 1. Approve that all parking and stopping restrictions on the south side of Hussey Road commencing at a point 16 metres east of its intersection with Springvale Gardens and extending east for a distance of 12 metres, be revoked.
- 2. Approve that all parking and stopping restrictions on the south side of Hussey Road commencing at a point 39 metres east of its intersection with Springvale Gardens and extending in an easterly direction for a distance of 100 metres, be revoked.
- 3. Approve that the stopping of vehicles is prohibited at all times on the south side of Hussey Road commencing at a point 39 metres east of its intersection with Springvale Gardens and extending in an easterly direction for a distance of 35 metres.
- 4. Approve that a marked bus stop be installed on the south side of Hussey Road commencing at a point 74 metres east of its intersection with Springvale Gardens and extending in an easterly direction for 14 metres.
- 5. Approve that the stopping of vehicles is prohibited at all times on the south side of Hussey Road commencing at a point 88 metres east of its intersection with Springvale Gardens and extending in an easterly direction for a distance of 51 metres.

#### **Board Consideration**

Some concerns were raised by members regarding possible insufficient lighting in the area of the proposed bus stop.

The Board suggested that staff investigate whether there is sufficient lighting in the area and if required, take steps to rectify this.

Members also requested that staff investigate the possibility of the bus shelter being considered for Adshel advertising given its proximity to the Willowbank Wildlife Reserve which attracts large numbers of visitors to the city.

- 5. Approve that the stopping of vehicles is prohibited at all times on the south side of Hussey Road commencing at a point 88 metres east of its intersection with Springvale Gardens and extending in an easterly direction for a distance of 51 metres.
- 6. That the bus stop be nominated for Adshel advertising due to its proximity to the Willowbank Wildlife Park.
- 7. That staff investigate that adequate street lighting near the proposed bus stop and provide information back to the Board as to the steps taken to improve lighting in the area, if appropriate.
