Dear Peter and Kim.

Many thanks for arranging community consultation with regards to the new landscaping either side of the Bridge St Bridge on 21 April, it is good to see that work has now been done and we greatly appreciate Nevilles efforts to find funding for a modest amount of planting at the gateway to South New Brighton and Southshore. We are grateful Bridge Street has received some attention.

As we discussed at the meeting, we have a number of further suggestions and points of concern regarding Bridge Street as follows:

- We strongly support South New Brighton Residents Association efforts and plans to improve the Bridge Street gateway, and are willing to contribute in any way we can to assist them in meeting those goals. It is our gateway too, and a route all of our residents use regularly.
- The Pohutakawa trees that have been added East of Pine Avenue are a fantastic addition and these will be amazing in a few years, well done for achieving this. We would strongly support adding more similar trees along the whole length of Bridge Street.
- There is very strong international evidence that tree lined streets add significantly to property values and human well being, and for relatively little cost.
 - The dead trees at the former yacht club site are extremely unsightly and depressing for local residents to return home too, apart from being precariously balanced and a serious health and safety concern. We were shocked to learn at the meeting in April that these are permanent and for the purpose of bird nesting. We have never seen any birds near it, and the trees are hazardous and damaging to the mental health and resilience of the residents, The remaining dead trees simply must be removed. We are concerned that the trees could fall on someone and for the ongoing effect on our mental health as the Eastern suburbs continue to be forgotten in the recovery of the city.
- The amount of rubbish in the road along Dyers Road and on Bridge Street is also unacceptable, and has got a lot worse in recent months.
- We miss the forest at Bridge Street. The forest was a distinctive feature of the entry way to South Brighton. We strongly encourage the council to be more vigorous in implementing the development and management plans for the South Brighton Parks so that a replacement forest is established as soon as possible. We strongly urge that landscaping funds be used wisely.

The dead trees at Bridge Street are a very serious concern for us and we seek the urgent removal of these.

The Southshore residents remain committed and available to help regenerate the planting at Bridge Street as we do in our own reserve with planting days.

We want to help.

1. Purpose of Report

The purpose of this report is to resource the Community Board to promote a pro-active partnership approach to decision-making between the Council and Community Boards working together to achieve the best outcomes for the city with decisions being made with a good understanding of community views.

3. Community Board Activities and Forward Planning

3.1 Community Board Plan update against outcomes

It is anticipated that the Community Board Plan for the next two years will be developed and come into effect from mid July 2017.

The Community Board Plan sets the framework that will guide the Boards decision making and actions for the next two years. It informs the Board's decisions on local activities and enables the Board to make decisions on funding and Long Term Plan priorities.

Our communities have told us their views on many issues over the past years as part of the development of a wide range of council plans. This information, as well as information received through specific engagements will be used in developing this Plan.

3.2 Community Services Awards

The Coastal-Burwood Community Service Awards 2017 function was held at the Waitakiri Golf Course on Thursday the 15th of June. There were a total of 18 attendees that received their Community Service Award at the ceremony. Members of the Coastal-Burwood Community Board presented certificates to individuals who had given significant voluntary service to the Coastal-Burwood Community. This was followed by a light supper where recipients and their families had a chance to mix with each other and the Community Board. A Waiata was performed by one of the recipients, Floyd Rudolph. The event was organised by members of the Coastal-Burwood Community Governance Team.





A total of 18 attendees received a Community Service Award at the 2017 Coastal-Burwood award ceremony.

3.3 Annual Plan Finalisation

Changes to the final 2017-18 Annual Plan included additional budgeting for the Port Hills fire recovery, employing extra staff for upkeep of urban parks and trialling a free-entry scheme for pre-schoolers visiting council swimming pools.

The council will work with Regenerate Christchurch to fast-track regeneration planning for Southshore and South New Brighton, with the intention of addressing concerns over estuary flood protection in Southshore as quickly as possible.

An additional \$11.2M has been included in the Annual Plan for the Hot Salt Water Pools. Public consultation saw more than 1000 submissions from the New Brighton community in support of the project.



3.4 Memos/Information reporting back on Community Board matters

3.4.1 Westhaven Tree Assessment

In August 2016, the then Burwood/Pegasus Community Board requested that that problematic trees in the Westhaven subdivision be assessed for suitable replacement trees where necessary due to reported ongoing and increasing damage to infrastructure and private property. That request followed on from two individual tree removal approvals in Wild Dunes Place and Lexington Place.

This is a heads-up that the report is expected to be received by the Board on 18 September. This is a complex report requiring input from the both the Arboriculture and Roading teams – the later in terms of possible disturbance to berms.

3.4.2 Burwood Park - Old Bowling Club Site - Surface Levelling and Repairs: Completed

Contractors were engaged last month to level the existing surface of the old bowling club building site and re-seed (or turf) the whole site (see image below). This work was carried out to make the space useable to the public.

UPDATE: QEII PARK ASBESTOS REMEDIATION

I am pleased to inform you that work to remediate asbestos-containing material (ACM) at QEII Park has now been completed.

Despite some windy weather which slowed the process, 23,000 cubic metres of material – more than twice what was anticipated when the project began – has now been processed, tested and safely disposed of. This has created a safe environment for the continued development of QEII Park as a major destination for the community.

Original estimates put the cost of removing the ACM to the approved Kate Valley landfill as \$8.5 million. With the extra volume of affected soil discovered, costs would have been closer to \$17.8 million. By developing a screening process, our Council team was able to sort through the soil and remove contaminants like plastics, wood and asbestos fragments – when re-tested, the vast majority of the soil came back as safe to re-use. This reduced the cost of disposing of all the waste and meant our team was able to complete the job for \$3.3 million, our approved budget.

New, clean soil has been brought in and the land reinstated. The majority of the site has been tidied and the first areas of grass are starting to grow. Once the weather improves, the contractor will complete the final seeding and tidy-up. They are also contracted to carry out the first cut in spring before handing the site back to the Council.

Specialists responsible for monitoring and protection of environmental standards (AECOM) have been appointed by the Council and have confirmed that the site is safe for the public. However, some areas will be fenced off in stages as other construction projects start and finish in and around the site, and to give the grass time to grow. We expect these grassed areas of the park to be fully established by spring, so the public can enjoy increasing access to QEII Park.

Construction is underway on the Council's new QEII Recreation and Sport Centre, and the Christchurch School of Gymnastics is currently progressing through the leasing process of their planned new facility at QEII Park. The Ministry of Education is also about to start construction of the relocated Avonside Girls' and Shirley Boys' High School campuses at QEII Park.

The ponds created as part of the Knights Drain project present a low risk of attracting nuisance levels midges. That's mainly because stormwater ponds do not have the much higher nutrient and organic loadings that wastewater ponds do.
