1. Purpose of Report

- 1.1 The purpose of this report is for the Fendalton-Waimairi-Harewood Community Board Submissions Committee to prepare a submission for the “Have Your Say” public consultation regarding the proposed changes to Cranford Street and the downstream effect on traffic flows in the ward.

2. Staff Recommendations

That the Fendalton-Waimairi-Harewood Community Board Submissions Committee:

1. Prepare a submission on the ‘Proposed Changes to Cranford Street and the Surrounding Area’ for adoption at the Fendalton-Waimairi-Harewood Community Board meeting of 5 June 2018.

3. Key Points

- 3.1 At the Board’s meeting of Monday 30 April 2018 the Board decided to discuss a possible submission to the Council on the traffic impact arising from the proposed changes to Cranford Street and the surrounding areas resulting from the Christchurch Northern Corridor which will extend the Northern motorway through Cranford Street.
- 3.2 At the meeting Have Your Say pamphlets were handed out to assist the Committee in formulating possible answers to answer the questions which make up the framework of a possible submission.
- 3.3 Although this project is not situated in the ward, the downstream effect on traffic flows will have significant impact for the ward.
