8. Briefings

Board Comment

The Board received a briefing from Glenys Brown and Paula Stevens from Land Information New Zealand (LINZ) about transitional use of the residential red zone.

Some areas in the Residential Red Zone are available to access or temporarily use (up to five years), where all required works have been completed.

When considering these applications, LINZ consider the activity against a range of criteria, including that the proposal:

- is consistent with the Crown's recovery and regeneration objectives
- is consistent with Regenerate Christchurch's vision and objectives for the Otakaro/Avon River Corridor (if relevant)
- would not limit the options for the long term use of the land/area
- is consistent with LINZ land maintenance requirements and objectives
- does not endanger the public or community, or cause any nuisance to neighbours
- does not damage the land, environment or other assets
- complies with legal and/or regulatory requirements

When LINZ receive an application, they will discuss it with Regenerate Christchurch and the Christchurch City Council to seek their feedback.

Examples of transitional projects in the Coastal-Burwood Wards are:

Burwood Pump track - a new track on the corner of New Brighton Rd and Brooker Ave. Te Ara Ōtākaro - a transitional 12 kilometre walking and cycling trail running along the Ōtākaro Avon River from city to sea.

- **12.2** The Board noted the continued public concern over the inconsistent night-time closing of the security gate to Bottle Lake Forest and requested staff to provide an update.
- **12.3** The Board requested an update from staff in regards to the policy for replacement of lost/stolen residential red rubbish bins with particular reference to purchase of vacant premises where bins have been missing for a considerable time.
- **12.4** The Board requested staff to provide an update on remedial road work in Bexley Reserve, particularly in relation to Velocity Karts.
- **12.5** The Board requested staff provide an update on the policy for maintenance of structures at entrances to subdivisions noting the need to inform the Northshore Residents Association.
- **12.6** The Board requested staff to advise when work will be commencing on weeding and tidying up on the stop banks along New Brighton Road and the Anzac Bridge roundabout gardens.
- **12.7** Red Zone Futures exhibition The Board noted that the Regenerate Christchurch Ōtākaro Avon River Corridor Exhibition closes on 30 June, with a feedback opportunity. It was agreed that staff be requested to organise a workshop for the Board to discuss feedback.
- **12.8** Noted the residents association boundaries are being discussed by the relevant associations in Burwood, Dallington and Avondale with a view to ensuring there is full coverage.
