## 7. Petition - Stanmore Road Pedestrian Crossing

### Committee Comment

1. At the Linwood-Central-Heathcote Community Board 16 May 2018 meeting Ms Gillian Sheard presented the Board with a petition with 542 signatories which was referred to the Committee.
2. The petition was signed by 542 residents and the statement of the petition is as follows:  
*I agree that the Stanmore Road pedestrian crossing is dangerous. It needs improving as below (referring to photo in the petition) or getting lights at the Avalon/Stammore Roads intersection – much sooner than later, before we have a death.*
