4. Public Forum

5. Deputations by Appointment

Part B

5.1 Bebe Frayle - Dallington Residents Association

Bebe Frayle, Chairperson of the Dallington Residents Association, spoke on the Association's tabled correspondence at item 7 in the agenda. On behalf of the Dallington Residents' Association, Bebe reported a mixture of residents' concerns about traffic safety in the vicinity of the Dallington Bridge. Bebe explained that since the bridge's rebuild in 2015 visibility issues mean that people do not feel safe at adjacent intersections. In addition there are concerns about the safety of cyclists and pedestrians crossing the bridge, particularly at peak times.

She also pointed out that an increase in traffic in the area if proposals for the future use of red zone land are put in place could result in more issues.

After questions from members, the Chairperson thanked Bebe Frayle for her deputation.

6. Presentation of Petitions

8. Briefings

The Board received a briefing from traffic staff on Dallington Bridge, Gayhurst Road safety concerns. This addressed issues raised in the correspondence and a deputation from the Dallington Residents Association.

The Board was informed that the former bridge was irreparably damaged in the 2011 earthquake and the replacement bridge was built to a design that alters the lines of sight. Staff advised that while the road surface on the bridge is not visible to vehicles on the Avonside Drive approaches, vehicles accessing the bridge from the north can be safely seen. Safety audits of the bridge have been undertaken by Stronger Christchurch Infrastructure Rebuild team (SCIRT) and the Council and it was found to be safe. Some minor improvements to road markings and signage have since been installed.

Staff further advised that police reports on recent accidents occurring on and near the bridge are not yet available but that they would be followed up.

7. Correspondence

Board Comment

The Board received tabled late correspondence from the Dallington Residents Association about traffic safety in the vicinity of the Dallington Bridge.

The Board discussed the issues raised in this correspondence, the deputation and the briefing and it was agreed that an on-site meeting of traffic staff, Board members and representative(s) from the Dallington Residents' Association be held to discuss the issues would be beneficial.

4. requests that staff investigate and provide advice on any Council buildings or any plots of land that may be available and suitable for use as a Menzshed in the greater New Brighton area including advice on the Jellico Marsh Sea Scouts building.

9. Elected Members' Information Exchange

- 9.1 The Board noted that nominations are been sought for Keep Christchurch Beautiful awards.
- 9.2 The Board discussed current proposals by a number of groups for information panels to be erected in the red zone.
- 9.3 The Board discussed local planting proposals for South New Brighton Domain and noted a need for a community conversation on the proposals.
- 9.4 The Board noted that there is to be a survey on Guy Fawkes events in the city and asked that the board be briefed on the survey results when these are available.
- 9.5 The Board discussed the restoration of the clock tower at New Brighton. Staff undertook to seek information about the schedule for repair work and to include this in the 6 August 2018 Community Board area report.
- 9.6 The Board noted that Local Government New Zealand Conference is currently underway in Christchurch.
- 9.7 The Board noted that there are ongoing concerns about the efficiency of storm water drains in Rockinghorse Road.
- 9.8 The Board noted that the Coastal Futures engagement office had opened at 82 Estuary Road to enable residents to provide their feedback or discuss the proposals for Southshore and South New Brighton Regeneration. The office will be open until the end of the year.

Glenn Livingstone left the meeting at 6pm.

- 9.10 The Board noted that concern has been expressed about the closure of the 25 metre pool at Taiora QE2 to the public to allow activities such as water polo. It was noted that these concerns could be looked at in an upcoming Board seminar on the sports centre.
