7. Transfer of Funding to Vbase Ltd Council Resolved CNCL/2018/00168

That the Council:

- 1. Approves the subscription for up to 45 million \$1 shares in Vbase Ltd to meet the estimated repair costs of the Town Hall of \$42.2 million and Horncastle Arena of \$2.6 million following full application of insurance receipts to the Town Hall repair project that were received by Vbase for earthquake damage to its group of facilities;
- 2. Approves the part payment of the new shares in Vbase Ltd to 20 cents per share, at an initial cost of \$9 million to the Council to meet repair costs falling due in August and September 2018;
- 3. Approves the payment of further instalments of the partly paid shares every second month to April 2019 in accordance with a payment schedule from Vbase Ltd;
- 4. Notes the costs totalling \$44.8 million for the repair of the Town Hall and Horncastle Arena are provided for in the Long Term Plan 2018-28; and
- 5. Delegates to the Chief Executive of the Council the responsibility for authorising the payment of further calls against the partly paid shares to the extent needed to meet the total costs of the repairs or to \$44.8 million, whichever is the lowest and to execute the relevant share transfer documentation for each call.

8. Traffic and Parking Bylaw 2017: Administrative Changes to Central City One-Way Streets

Council Resolved CNCL/2018/00169

That the Council:

One Way Streets (Traffic and Parking Bylaw 2008 – First Schedule)

- Revoke the existing traffic movement restriction relating to the movement of vehicles in a one-way westerly direction on Cambridge Terrace from Kilmore Street to Manchester Street (as established per NZ Gazette Notice 2014-go7582, Issue 148), and approve that vehicles be permitted to travel in both directions subject to any other approved traffic signs and/or markings installed on this section of road (noting that the eastern end of Cambridge Terrace does not physically or legally connect to Kilmore Street).
- 2. Retain the existing traffic movement restriction relating to the movement of vehicles in a one-way westerly direction on Oxford Terrace from Manchester Street to Colombo Street



(as established per NZ Gazette Notice 2014-go7582, Issue 148), but approve that this restriction does not apply to cyclists, who are therefore permitted to travel in both directions subject to any other approved traffic signs and/or markings installed on this section of road.

3. Revoke the existing traffic movement restriction relating to the movement of vehicles in a one-way easterly direction on Tuam Street from Barbadoes Street to Fitzgerald Avenue (as established per NZ Gazette Notice 2014-go7582, Issue 148), and approve that vehicles be permitted to travel in both directions subject to any other approved traffic signs and/or markings installed on this section of road.

Expiry of One Way Streets (Traffic and Parking Bylaw 2008 – Third Schedule)

- 4. Revoke the previously notified expiry date relating to the traffic movement restriction of vehicles in a one-way westerly direction on Kilmore Street from Madras Street to Park Terrace (as established per NZ Gazette Notice 2014-go7582, Issue 148), and approve pursuant to Clause 16 of the Councils Traffic and Parking Bylaw 2017 that vehicles be restricted to travel in a one-way westerly direction only subject to any other approved traffic signs and/or markings installed on this section of road.
- 5. Revoke the previously notified expiry date relating to the traffic movement restriction of vehicles in a one-way easterly direction on Lichfield Street from Madras Street to Fitzgerald Avenue (as established per NZ Gazette Notice 2014-go7582, Issue 148), and approve pursuant to Clause 16 of the Councils Traffic and Parking Bylaw 2017 that vehicles be restricted to travel in a one-way easterly direction only subject to any other approved traffic signs and/or markings installed on this section of road.
- 6. Revoke the previously notified expiry date relating to the traffic movement restriction of vehicles in a one-way easterly direction on Salisbury Street from Park Terrace to Barbadoes Street (as established per NZ Gazette Notice 2014-go7582, Issue 148), and approve pursuant to Clause 16 of the Councils Traffic and Parking Bylaw 2017 that vehicles be restricted to travel in a one-way easterly direction only subject to any other approved traffic signs and/or markings installed on this section of road.

 Approve the Shared Zone (laneways) layouts and associated traffic controls relating to the following named laneways within the South Frame, as detailed in Attachments A, C, D, E, F, G (with the engagement details contained in Attachment B), and notes that the Parking Restrictions Subcommittee will consider the parking restrictions relating to the following projects.



Mauri Ora Lane

- Approve pursuant to Section 20(1) of the Christchurch City Council Traffic and Parking Bylaw 2017, that Mauri Ora Lane from its intersection with Tuam Street and extending in a southerly direction to its intersection with St Asaph Street, as detailed in Attachment C be declared a Shared Zone.
- 3. Approve pursuant to Section 27(1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, set the speed limit at 10 km /h on Mauri Ora Lane from its intersection with Tuam Street and extending in a southerly direction to its intersection with St Asaph Street, as detailed on **Attachment C.**
- 4. Approve pursuant to section 17 (1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, that the left turn movement for all vehicles be prohibited from the south approach of Mauri Ora Lane into Tuam Street.
- 5. Approve pursuant to section 17 (1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, that the left turn movement for all vehicles be prohibited from the north approach of Mauri Ora Lane into St Asaph Street.

Lava Lane

- Approve pursuant to Section 20(1) of the Christchurch City Council Traffic and Parking Bylaw 2017, that Lava Lane from its intersection with Tuam Street and extending in a southerly direction to its intersection with St Asaph Street, as detailed in Attachment D be declared a Shared Zone.
- 7. Approve pursuant to Section 27(1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, set the speed limit at 10 km /h on Lava Lane from its intersection with Tuam Street and extending in a southerly direction to its intersection with St Asaph Street, as detailed on **Attachment D**.
- 8. Approve pursuant to section 17 (1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, that the left turn movement for all vehicles be prohibited from the south approach of Lava Lane into Tuam Street.
- 9. Approve pursuant to section 17 (1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, that the left turn movement for all vehicles be prohibited from the north approach of Lava Lane into St Asaph Street.

Te Pohue Lane

- 10. Approve pursuant to Section 20(1) of the Christchurch City Council Traffic and Parking Bylaw 2017, that Te Pohue Lane from its intersection with Tuam Street and extending in a southerly direction to its intersection with St Asaph Street, as detailed in **Attachment E** be declared a Shared Zone.
- 11. Approve pursuant to Section 27(1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, set the speed limit at 10 km /h on Te Pohue Lane from its intersection with Tuam Street and extending in a southerly direction to its intersection with St Asaph Street, as detailed on **Attachment E.**
- 12. Approve pursuant to section 17 (1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, that the left turn movement for all vehicles be prohibited from the south approach of Te Pohue Lane into Tuam Street.
- 13. Approve pursuant to section 17 (1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, that the left turn movement for all vehicles be prohibited from the north approach of Te Pohue Lane into St Asaph Street.



Sugarloaf Lane

- 14. Approve pursuant to Section 27(1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, set the speed limit at 10 km /h on Sugarloaf Lane from its intersection with Tuam Street and extending in a southerly direction to its intersection with St Asaph Street, as detailed on **Attachment E.**
- 16. Approve pursuant to section 17 (1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, that the left turn movement for all vehicles be prohibited from the south approach of Sugarloaf Lane into Tuam Street.
- 17. Approve pursuant to section 17 (1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, that the left turn movement for all vehicles be prohibited from the north approach of Sugarloaf Lane into St Asaph Street.

Mata Lane

- Approve pursuant to Section 20(1) of the Christchurch City Council Traffic and Parking Bylaw 2017, that Mata Lane from its intersection with Tuam Street and extending in a southerly direction to its intersection with St Asaph Street, as detailed in Attachment F be declared a Shared Zone.

- 20. Approve pursuant to section 17 (1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, that the left turn movement for all vehicles be prohibited from the south approach of Mata Lane into Tuam Street.
- 21. Approve pursuant to section 17 (1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, that the left turn movement for all vehicles be prohibited from the north approach of Mata Lane into St Asaph Street.

Nurseryman Lane

- 22. Approve pursuant to Section 20(1) of the Christchurch City Council Traffic and Parking Bylaw 2017, that Nurseryman Lane from its intersection with Lichfield Street and extending in a southerly direction to its intersection with St Tuam Street, as detailed in **Attachment G** be declared a Shared Zone.

Approve pursuant to Section 27(1) (a) of the Christchurch City Council Traffic and Parking Bylaw 2017, set the speed limit at 10 km /h on Nurseryman Lane from its intersection with Lichfield Street and extending in a southerly direction to its intersection with Tuam Street, as detailed on **Attachment G.**
- 24. Approve pursuant to section 16 (1) of the Christchurch City Council Traffic and Parking Bylaw 2017, that Nurseryman Lane be one way north to south except for cycles, from its intersection with Lichfield Street to its intersection with Tuam Street, as detailed on Attachment G.
