Committee Comment

1. The Principal Advisor provided Subcommittee members with a verbal update, covering:
 - a. Community Connector Service for earthquake support – this service run by Christchurch Resettlement Services will conclude in six months' time with any matters requiring attention after that to be dealt with through the Ministry of Social Development.
 - b. Single sex swimming pools for women from other cultures – The Principal Advisor informed the Subcommittee that there is work underway with a plan to engage community further regarding their needs in this area.
 - c. Zhonghua Chinese Society has been provided with a range of empty spaces for them to consider as possible premises for their activities.
 - d. Multicultural Strategy one year celebration – the event will be held in the Christchurch City Council's Function Room on Wednesday 29 August 2018, 5.30pm-7.30pm. Further arrangements are being progressed.
 - e. Some points related to working towards achieving the goals in the Strategy include:
 - discussion about ways to make the Council's Civic Offices more welcoming;
 - Te Reo training available;
 - working with people of different ethnicities;
 - the need for better promotion of interpreting and translating.
