8. George Bellew Road And Ron Guthrey Road - Proposed Roundabout

1. Purpose and Origin of Report

Purpose of Report

1.1 The purpose of this report is for the Waimāero/Fendalton-Waimairi-Harewood Community Board to approve the installation of a roundabout at the intersection of George Bellew Road and Ron Guthrey Road in accordance with Attachment A.

Origin of Report

1.2 This report is staff generated in response to a request from the Christchurch International Airport Limited for Waimāero/Fendalton-Waimairi-Harewood Community Board to approve that a roundabout be installed at the intersection of George Bellew Road and Ron Guthrey Road.

2. Significance

- 2.1 The decisions in this report are of low significance in relation to the Christchurch City Council's Significance and Engagement Policy.
 - 2.1.1 The level of significance was determined by comparing factors relating to this decision against the criteria set out in the Council's Significance and Engagement Policy.
 - 2.1.2 The community engagement and consultation outlined in this report reflect the assessment.

3. Staff Recommendations

That the Waimāero/Fendalton-Waimairi-Harewood Community Board:

- 1. Approve that the intersection of George Bellew Road and Ron Guthrey Road be controlled by a Roundabout.
- 2. Approve that the stopping of vehicles be prohibited at any time on the north side of George Bellew Road commencing at its intersection with Russley Road and extending in a westerly direction to its intersection with Ron Guthrey Road.
- 3. Approve that the stopping of vehicles be prohibited at any time on the north side of George Bellew Road commencing at its intersection with Ron Guthrey Road and extending in a westerly direction to its intersection with Grays Road.
- 4. Approve that the stopping of vehicles be prohibited at any time on the south side of George Bellew Road commencing at its intersection with Russley Road and extending in a westerly direction to its intersection with Ron Guthrey Road.
- 5. Approve that the stopping of vehicles be prohibited at any time on the south side of George Bellew Road commencing at its intersection with Ron Guthrey Road and extending in a westerly direction to its intersection with Grays Road.
- 6. Approve that the stopping of vehicles be prohibited at any time on the west side of Ron Guthrey Road commencing at its intersection with George Bellew Road and extending in a southerly direction for a distance of 163 metres.
- 7. Approve that the stopping of vehicles be prohibited at any time on the east side of Ron Guthrey Road commencing at its intersection with George Bellew Road and extending in a southerly direction for a distance of 163 metres.



- 8. Approve that any previous resolutions pertaining to traffic controls made pursuant to any bylaw to the extent that they are in conflict with the traffic controls described in this report are revoked.
- 9. That these resolutions take effect when parking signage and/or road marking that evidence the restrictions described in the staff report are in place (or removed in the case of revocations).

4. Key Points

- 4.1 This recommendations in this report are consistent with the anticipated outcomes of the Traffic Safety & Efficiency Service Plan in the <u>Councils Long Term Plan (2018 2028)</u>
- 4.2 The following feasible options have been considered:
 - Option 1 Install the roundabout and No Stopping Restrictions (preferred option)
 - Option 2 Do Nothing.
- 4.3 Option Summary Advantages and Disadvantages (Preferred Option)
 - 4.3.1 The advantages of this option include:
 - Reduces the risk of a crash by improving the intersection design at this location
 - Future proofs these roads for identified increase in traffic movements.
 - Supports the industrial development of the airport business park
 - 4.3.2 The disadvantages of this option include:
 - There are no identified disadvantages with this option.

5. Context/Background

- 5.1 Christchurch International Airport Limited (CIAL) have contacted the Council wanting to build a roundabout on Council road. They wish to further develop their land to the south of the intersection forming a fourth leg to the existing three legged George Bellew Road / Ron Guthrey Road intersection.
- 5.2 The CIAL is the largest employer in the South Island and is expanding its current developments to the north and south. The new development will increase traffic volumes on roads leading to and from airport and the proposed roundabout is upgrading and future proofing this intersection.



6. Option 1 - Install Roundabout and No Stopping Restriction (preferred)

Option Description

- 6.1 A cross roads junction in this industrial subdivision on these roads would not meet road design safety standards, therefore the roundabout is proposed.
- 6.2 The CIAL had GHD (an engineering consultancy) model the intersection of George Bellew Road and Ron Guthrey Road for efficiency to confirm the preferred intersection type at this location. A Paramics model was used to derive turning counts for 2031, these were then modelled using SIDRA Intersection software. Level of Service (LOS) was determined from average delay.
- 6.3 A single circulating lane roundabout performed at an overall LOS A and B for AM and PM peaks respectively.
- 6.4 The signals layout option performed at an overall LOS B and C for the AM and PM peaks respectively. However, one approach was operating at a high degree of saturation (0.978) showing no further capacity. Moreover, the signals option would require more land take than the roundabout.
- 6.5 The preferred option is for a roundabout based on the existing concept design developed for the intersection.

Significance

6.6 The level of significance of this option is low and is consistent with section 2 of this report. Engagement requirements for this level of significance includes the consultation with the owner and occupier of any property likely to be injuriously affected by the option.

Impact on Mana Whenua

6.7 This option does not involve a significant decision in relation to land or a body of water or other elements of intrinsic value, therefore this decision does not specifically impact Ngāi Tahu, their culture and traditions.

Community Views and Preferences

- 6.8 The land on all four corners of this intersection is owned by CIAL. Staff have consulted on the proposal with CIAL and their tenants.
- 6.9 Staff personally visited the businesses in the immediate area of the proposed roundabout, of 13 February 2019, delivering plans of the proposal and speaking to property managers.
- 6.10 The Team Leader Parking Compliance supports this option.

Alignment with Council Plans and Policies

6.11 This option is consistent with Council's Plans and Policies.

Financial Implications

- 6.12 Cost of Implementation All costs associated with this option; other than the preparation of this report, will be met by the CIAL.
- 6.13 Funding source CIAL.
- 6.14 Maintenance / Ongoing Costs Covered under the area maintenance contract and effect will be minimal to the overall asset.

Legal Implications

6.15 Part 1, Clauses 7 and 8 of the Christchurch City Council Traffic and Parking Bylaw 2017 provides Council with the authority to install parking restrictions by resolution.



- 6.16 The Community Boards have delegated authority from the Council to exercise the delegations as set out in the Register of Delegations. The list of delegations for the Community Boards includes the resolution of stopping restrictions and traffic control devices.
- 6.17 The installation of any signs and/or markings associated with traffic control devices must comply with the Land Transport Rule: Traffic Control Devices 2004.

Risks and Mitigations

6.18 There are no identified risks associated with this option.

Implementation

- 6.19 Implementation dependencies Community Board approval.
- 6.20 Implementation timeframe Dependent on CIAL development time frames but it understood they want to commence construction this financial year.

Option Summary - Advantages and Disadvantages

- 6.21 The advantages of this option include:
 - Reduces the risk of a crash by improving the intersection design at this location
 - Future proofs these roads for identified increase in traffic movements
 - Supports the industrial development of the airport business park.
- 6.22 The disadvantages of this option include:
 - There are no identified disadvantages with this option.

7. Option 2 - Do Nothing

Option Description

7.1 Retain existing T-intersection.

Significance

7.2 The level of significance of this option is low and is consistent with section 2 of this report.

Impact on Mana Whenua

7.3 This option does not involve a significant decision in relation to land or a body of water or other elements of intrinsic value, therefore this decision does not specifically impact Ngāi Tahu, their culture and traditions.

Community Views and Preferences

7.4 This option is inconsistent with community requests for changes to parking and/or stopping restriction.

Alignment with Council Plans and Policies

7.5 This option is consistent with Council's Plans and Policies.

Financial Implications

- 7.6 Cost of Implementation \$750 for consultation and the preparation of this report
- 7.7 Maintenance / Ongoing Costs \$0
- 7.8 Funding source Existing staff budgets.

Legal Implications

7.9 There is not a legal context, issue or implication relevant to this option.





9. Waimāero/Fendalton-Waimairi-Harewood Community Board Area Report - March 2019

1. Purpose of Report

This report provides information on initiatives and issues current within the Community Board area, to provide the Board with a strategic overview and inform sound decision making.

2. Staff Recommendations

3. Community Board Activities and Forward Planning

3.1 Memos/Information/Advice to the Board

3.1.1 The Board continues to receive strategic, technical and procedural advice mainly through an ongoing programme of Board seminars and/or workshops generally held at the conclusion of the Board's twice monthly ordinary meetings.

3.2 Board area Consultations/Engagement/Submission opportunities

3.2.1 Greers Road at Memorial Avenue: Proposed Intersection Efficiency Improvements

Feedback is being sought on proposed improvements to relieve congestion on Greers Road southbound approach for general traffic and also to assist the Orbiter bus service.

The proposal removes the cycle lane outside Burnside high School on Greers Road at the south approach to the intersection and reduces the width of the footpath creating a shared left turn lane by the use of 'Sharrow' markings. (Attachment A refers)

A report is expected to be presented to the Board at its 18 March 2019 meeting, for consideration.

3.2.2 Breens Road/Harewood Road/Gardiners Road Intersection

The consultation document seeking community feedback on two possible options for the Breens Road/Harewood Road/Gardiners Road Intersection is currently being prepared by staff.

5.1 **Community Facilities (updates and future plans)**

5.1.1 Fendalton Library and Service Centre Closure for Repairs

The Fendalton Library and Service Centre will be closed for repairs on Friday, 2 March 2019 and is expected to reopen at the end of July 2019.

The Fendalton Service Centre will operate out of Shop 6, Fendalton Village, 376 Ilam Road during the closure.

A library bus will visit the Fendalton Library Carpark three time as week while the library is closed:

- Monday 1:30pm-3:30pm
- Wednesday 9:15am-11:15am
- Friday 3.00pm- 5.00pm

Full library services are available at Orauwhata: Bishopdale Library and Community Centre and Papanui Library.

5.2 Infrastructure projects underway

5.2.1 Jeffreys Reserve Pump Station

During the first two weeks of February a topographical survey was carried out within and around the Jeffreys Pump Station compound. This work was part of the preliminary design phase for the replacement water tank and included potholes and soil and groundwater sampling.

The investigation was needed to establish the location of existing services so that the information required for the design and construction of the new suction tank is accurate.





6. Community Issues, Events and Projects in the Board Area

6.1 Community Pride Garden Awards 2019

Judging has been completed for this year's Community Pride Garden Awards 2019. Over 300 award notification cards and 1,002 "Thank you" cards were given out. The number of "Thank you" cards issued this year is over double the number of any other ward area in Christchurch.

To date 190 notification cards have been returned.

Certificates and trophies will be presented to recipients at the Fendalton-Waimairi-Harewood Community Board Community Pride Garden Awards Ceremony on Wednesday, 27 March 2019 at the Russley Golf Club and Function Centre, 428 Memorial Avenue.


