SUMMARY OF ESTUARY EDGE PROGRESS
CHRISTCHURCH 360 TRAIL ANNUAL PLAN SUBMISSION 1 May 2019

15 August 2017

Council advised 360 Trail:

Pleased to pass a resolution to bring forward \$416,160 in capital expenditure from 2018/2019 to 2017/2018 to enable the section of the 360 trail around the Estuary Edge to be completed by 2017/2018

21 November 2017

Project update following a meeting

Council resolved to build a walkway between the Windsurf Park (Humphreys Drive) and Bridge Street along the margins of the Estuary, 2.5 m wide to generally follow the coast along the route....

Fencing required along the route, along with the inclusion of viewing opportunities and planting to protect the wildlife.

The route had been surveyed

Council had been liaising with the Rununga (via MKT).

12 November 2018

Email to 360 Trail

Work progressing on design. While xxx was away data was put into CAD.
