1. Brief Summary


- 1.1 The purpose of this report is provide the Road Closure Subcommittee with information to enable the Subcommittee to make a decision regarding the application for proposed road closures for The Star City to Surf 2020. The report has been written because the Star Media have applied to close a sections of the following roads, for the City to Surf 2020 Event:
 - Rose Street, Lyttelton Street, Cashmere View Street, Ashgrove Terrace, Waimea Terrace, Eastern Terrace, Fifield Terrace, Aynsley Terrace, Grange Street, Port Hills Road, Martindales Road, Truscotts Road and Ferrymead Park Drive.
- 1.2 Public consultation was carried out through standard channels with the period of time allowing for objection to be received meeting the minimum time period of one week. The application was publicly advertised on Monday 2 March 2020 with objections closing Tuesday 10 March 2020.
- 1.3 The initial road closure application form that was submitted by the organiser and publically notified, listed the closure periods as 7.00am to 6.00pm Sunday 22 March 2020. Since then the applicant has requested a change to closure times, applying now for a shorter time period of 6.00am to 1.00pm Sunday 22 March 2020.
- 1.4 At the time of writing this report, no objections had been received from public consultation.
- 1.5 This event has operated in these locations previously with no known issues.
- 1.6 The event organisers are required to undertake notifications to make sure impacted stakeholders are aware of the proposed closures.
- 1.7 At the time of writing this report, the event organiser has indicated that they will be providing a record of any feedback received, from impacted parties, to the Subcommittee. This information will be provided in advance of the scheduled meeting or alternatively they may choose to present the information in person to the Subcommittee.
- 1.8 The Christchurch Transport Operations Centre support the proposed closures and believes the proposed closures will not unreasonably impact traffic.

- f. Eastern Terrace from Birdwood Avenue to Waltham Road
- g. Fifield Terrace from Waltham Road to 32 metres south of southern boundary of 271 Fifield Terrace
- h. Aynsley Terrace from Garlands Road and 77 Aynsley Terrace
- i. Grange Street from Aynsley Terrace and SH73 Opawa Road
- j. Port Hills Road at the intersection of SH73 Opawa Road
- k. Martindales Road from Port Hills Road to Truscotts Road
- I. Truscotts Road from Martindales Road to Ferrymead Park Drive
- m. Ferrymead Park Drive from Truscotts Road to Bridle Path Road


