3.3.2 Northcote Stakeholders Update

The Northcote stakeholders are made up of representatives from St Silas Church, Te Ora Hou - Neighbourhood Links, C.C.C. Community Development, Kainga Ora, Northcote School, Potters Way Church, C.C.C. Papanui-Redwood Libraries), Police, Northgate Community Services Trust, Papanui Baptist Freedom Trust and the Salvation Army

• Neighbourhood Links Building

Further activation by Northcote Stakeholder Community Groups includes:

• Tuesdays: Potters Way Church

Are running a Sharing Pantry at the Neighbourhood Links office next to Redwood Library every Tuesday from 10am to 4pm. There are pop-up sausage sizzles and always time for a cuppa and a chat.

The Potters Pantry is extremely popular. The Potters Kitchen has given out \$150,000 worth of food over past year (initially at Manse Place and more recently at Neighbourhood Links).

• Wednesdays: Papanui Baptist Freedom Trust

As from 21 October the Papanui Baptist Freedom Trust are commencing (free) weekly programmes on Wednesdays at the Neighbourhood Links Centre. There will be a variety of activities: jigsaw puzzles, card and board games, basic tech help, arts and crafts, sewing repairs, bike maintenance and gardening tips on a revolving basis. There will also be ongoing tea, coffee and snacks and anyone is welcome to pop in.

• Northcote School

The Breakfast Club is now operating five days per week and in Term 3 a total of 1,667 student breakfasts were enjoyed by the school tamariki. The Breakfast Club is organised and supported by staff and volunteers from local community organisations.

• The Neighbourhood Links/Toho Paddington Reserve event 'Colour our Community'



This event was held on Friday 16 October at Paddington Reserve from 3.30pm and attended by approximately 130 tamariki and their whānau. There was a sausage sizzle, Canterbury Cricket held a jump and catch class, and when the sausages were all eaten they then held the colour run. The children thoroughly enjoyed the event and the feedback from parents is they would love another one. It was advertised it as a whānau event and there was a large turn-out of

parents and even some grandparents.

• Te Ora Hou have been holding the Hapori Takaro initiative at Paddington Reserve every Friday from 3:30pm which features games and activities for the children.



3.3.3 Recreation Funding

Sport Canterbury is managing Tū Manawa Active Aotearoa fund on behalf of Sport NZ in our region.



Tū Manawa Active Aotearoa provides funding for programmes or projects delivering play, active recreation and sport experiences for tamariki and rangatahi out of school hours. This fund targets those people who are not active and/or living with a disability in higher deprivation communities and girls and young women. The Kiwisport Fund has ceased. A partnership application has been successful between some regional sport associations and the Northwest Cluster. The regional sport associations and the Northwest Cluster organisations will co-design the sport and recreational activities to be delivered.

3.3.4 Neighbourhood Trust Light Party

Papanui-Innes community staff attended another successful Light Party organised by the Neighbourhood Trust and held at the St Albans Baptist Church.



The theme this year was Noahs Ark and children dressed in an array of colourful costumes. Approximately 800 members of the community attended. The activities that were provided included food stalls, face painting, a black light disco, bands, inflatable playground, pets and animals, a sausage sizzle and a café for the adults.



3.3.5 Shirley Community Trust Light Party



Papanui-Innes community staff attended the Shirley Community Trust Light Party which was held at the Emmett Street Community Church. The event was well attended by the local community and the theme of "Under the Sea/Beach" provided the children with the opportunity to dress up.

There were 12 activities for the young ones to be involved in with prizes, entertainment and a sausage sizzle. The event was well attended and children had the opportunity to be photographed in their costume and a copy of the image given to them as a reminder of the day.

3.3.6 Whakaoho

Staff attended the Whakaoho event at Papanui Youth Development Trust on Sunday 1 November 2020. The event was a great success with youth dancers, youth performers and a tight rock band providing entertainment for the audience. Food trucks, rope climbing, bouncy castles, sandstone carving and face painting were also available.



The range of youth performers and local organisations volunteering at the event highlighted the depth and breadth of the collaborative youth sector in Papanui.

Engagement summary – October 2020



- Shirley Recreational Walkers



Where did our submissions come from?










The two most popular uses of the site as it currently is was the pump track, playground and basketball court, closely followed by using the space to relax or part of a walking trip. The recent installation of the temporary pump track has proven to be very popular and based on submissions well used by the young people in the community.

The open green space is also appreciated by the community whether as part of a walk (including the Dudley Creek track) or to take time to relax and enjoy the space.


Submitters who indicated they did not use this space (6) had used 10 Shirley Road when there was a Community Centre on site or they only observed others using the site (2).

We received 29 submissions supporting the replacement of the Community Centre at this location. A number of these submissions also asked that a library be included in the building.


To keep the area as an open green space with the trees and Dudley Creek planting and walkway, creating community gardens and a food forest and also creating a BBQ area/picnic tables there were a combined total of 29 submissions. Also supporting the open space with the existing play area and pump track and installing more recreation activities we received 12 submissions.

Upgrading the existing playground and making the bike track permanent combined with more recreation space and outdoor games received a total of 26 submissions.

There was support for building a new Community Centre on the site with a total of 16 submissions.

As per the previous question, new planting/food forest/community garden and shelter planting received a number of submissions (14), building on what is already there.

Recreation space and installing seating/BBQ/drinking fountain also was noted in submissions (8) with 2 submissions requesting public toilets on the site.

Four submissions requested something for older adults on this site as currently there is nothing for this demographic.



Shirley Community Centre, 10 Shirley Road Christchurch

Thank you for inviting us to make a submission on the future, if any, of Shirley Community Centre.

The New Zealand Society of Genealogists - Canterbury Branch had their home at Shirley Community Centre from February 1990 until the February 2011 earthquakes (21 years). We had the use of one of the old classrooms, with dedicated, lockable space for our large collection of books, computers, microfiche readers, and tables and chairs for small meetings, as well as being able to use the attached hall for our 2 larger meetings every month. Another advantage was that we were fairly centrally placed in Christchurch, and being the Canterbury Branch, the ideal was always for us to be centrally based to cover the region. There are other branches of the NZ Society of Genealogists in Riccarton, Bishopdale and Waimakariri.

We also were hoping that the Community Centre would be replaced, and did indeed have representation on the controlling body for Shirley Community Centre well after we had to move out after the earthquakes. It now seems unlikely in the current climate that a new facility would be built, but how about reusing existing buildings such as schools.

There definitely needs to be plenty of versatile community centres throughout the city. Our city has special needs with what we have been through in the last decade, where the community have shown how strong they can be supporting each other, and desperately need safe and welcoming meeting places to suit all needs.

What we appreciated greatly, and have found difficult to find elsewhere, is the ability to have a large dedicated space to keep and use, for our books, computer, microfiche readers for research, as well as having a large meeting room space, and centrally located. What was also very important was that it needed to be affordable rent as we are a non-profit organisation registered with the Charities Commission.

We have eventually found another home, in Parklands, at another community centre, Parkview Community Lounge, also Council operated, but at a greater distance from many of our members, and no longer centrally based. We have definitely settled in to this facility and value being able to keep functioning with all our resources and meeting space. We are currently enjoying being settled and not having to look elsewhere and have a 'home'. As with everyone in Christchurch, we need to keep options open and be prepared to move as options change. If there was to be a new, suitable community facility in Shirley, we would definitely look to see whether it would work for us.

Some areas in Christchurch have been hit harder than others, Shirley being one of these, and definitely needs really good community facilities at affordable rates. These facilities could be the hub for community BBQs and sports events as well as cultural and artistic. Another value of facilities in Shirley is showing Shirley that they are valued and not forgotten.

It would seem that some of the schools that are no longer used as schools, could be converted into wonderful community centres around the city. We were lucky enough to find space at Richmond Primary School, for a short while, after the quakes, as school rolls in the East were dropping. Unfortunately, the school was repurposed for another use, and we had to move on. This also had both dedicated, lockable space for our Branch resources as well as meeting space. We recently

watched Sockburn Primary School being demolished, thinking what a wonderful resource it could have been for that community as a community centre.

 Central and local government agencies have a major role in enhancing the social, economic, environmental, and cultural aspects of wellbeing within communities. - There is a well-known association between education and wellbeing, which is important throughout the life course. The relationship is complex and it appears that most of it is due to our level of education affecting our employment, income and health. For example, educational attainment strongly predicts health literacy, and the skills, knowledge and confidence needed to access and use health and social care services. Differences in educational attainment between different population groups also provide information about access to education and the equity, or fairness, of the education system. Education is a resource for life that, apart from providing qualifications and facilitating future employment, can have broader beneficial impacts on health and wellbeing through for example developing values, emotional intelligence, self-esteem, and social skills, <u>https://www.canterburywellbeing.org.nz/our-wellbeing/</u> education/

Employment affects the economic status and standard of living of an individual and their family and also has a strong influence on social and emotional wellbeing. Being employed is an important way for a person to meet their material needs and to participate in their community. Employment is also important to an individual's identity and their role in society. Longitudinal studies show that unemployment has a direct negative effect on health, over and above the effects of socioeconomic status, poverty, and prior ill-health. Levels of employment and unemployment differ across population groups, meaning some groups are less likely to experience the positive benefits of employment to employment, they gain in material wellbeing, subjective wellbeing, physical and mental health, and socioeconomic status. https://www.canterburywellbeing.com, subjective wellbeing, physical and mental health, and socioeconomic status. https://www.canterburywellbeing.com, needs and socioeconomic status.

- Individuals with mental health disorders are at greater risk for decreased quality of life, educational difficulties, lowered productivity and poverty, homelessness, social problems, vulnerability to abuse, additional physical health problems, stigma, and suicide. Mental health care in New Zealand has undergone a transformation over the last several decades, moving from an institutional model to a model centred on engagement with services in community settings. In recent years, record numbers of people have accessed mental health and addiction services across New Zealand. Disasters such as the Canterbury earthquakes have well-documented negative impacts on mental health with an estimated five to ten percent of the population likely to experience a deterioration in their psychological health and to seek or require intervention in the long term. These impacts relate both to the immediate effects of the disaster and to ongoing or secondary stressors, such as a continued lack of infrastructure. International literature suggests that approximately eight percent of those affected by mass shootings - such as the March 2019 Christchurch mosque attacks - may have moderate symptoms, and two percent chronic dysfunction. The impact on individuals will be influenced by aspects including pre-existing risk factors, level of exposure to the incident, and different coping strategies. The figures show that the proportion of the Canterbury DHB population accessing mental health services (combined Non- Government Organisations, primary mental health and specialist mental health services) has increased substantially over time. https://www.canterburywellbeing.org.nz/our-wellbeing/health/mental-healthservice-access/

 Key equity issues within social capital: A number of differences are apparent across the social capital indicators, notably: sense of community, personal identity, ioneliness and isolation, and confidence in agencies. Age (particularly the youngest and oldest age groups), having a long-term health condition or disability, and identifying as belonging to certain ethnic groups, appear to be related to lower levels of social capital in greater Christchurch. https://www.canterburywellbeing.org.nz/our-wellbeing/social-capital

- Feeling like one belongs and is accepted in meaningful social groups has been linked to wellbeing and health-related outcomes. Sense of community is a desirable outcome, whereby community members feel a sense of belonging and commitment, and a feeling that members matter to one another and to the group. Sense of community embraces a number of different elements including: community spirit or membership, influence, reinforcement, emotional safety, community boundaries, sense of belonging, trust, shared emotional connections, and quality interactions. These elements are considered to act together to strengthen the social fabric and improve community wellbeing and health outcomes. The figure shows that in the year following the 2010 and 2011 earthquakes, over half of respondents in greater Christchurch (54.5%) agreed or strongly agreed that they felt a sense of community with others in their neighbourhood. A pattern of decling sense of community followed, and the proportion feeling a sense of community with others in their neighbourhood (agree or strongly agree) dipped below 50 percent in 2014. 






• Page 36, "7.4 Shirley Community Centre 10 Shirley Road –Emerging information points to the retention of the site at 10 Shirley Road as community space (land banking). Continue to use the site as an open air community hub or a "longer term gap filler approach" funding has been secured for a pump track and landscaping, with the patential for other outdoor activity features over time. As the site is recommended to be retained there is always to apportunity to re look at the development of a facility with a community partner into the future. Other providers have developed facilities in the area and Council has supported the development of a facility in the near-by Macfarlane Park and is currently developing a facility in St Albans."

Thanks to Council staff I was able to talk to Peter Burley as part of his research for the Community Facilities Network Plan. At our meeting in February, I did not agree with his opinion (as stated above), which is why after our meeting I created the <u>attached_pdf</u>, and emailed it to him. I have also <u>attached my_pdf</u> for the Draft Annual Plan [2019-2020], that shows how my idea for 10 Shirley Road aligns with the different CCC Plans, Strategies & Policies documents "that help us to plan and shape the future of our city." We don't need Shirley Park, we need Shirley Centre. Turning 10 Shirley Road into a park does not address the social issues in our community. We already have more than enough green spaces in our communities. Another park is not the answer.

 We seem to have lost focus that well-being is more than access to a park. The Health Iceberg suggests: What we focus on: physical health (diet & exercise). What we ignore: occupational health, social health, mental health, environmental health, spiritual health, emotional health.

- "Christchurch already has far more park land, sport fields and playgrounds (local parks) per person than the national median and more than other major metropolitan cities in NZ."

The gaps in our communities are not related to physical health opportunities. The gaps that the Council (in partnership with Ministry's) can help with are: occupational health, social health, mental health, emotional health, and environmental health.

participation. Inequality also significantly inhibits economic growth."

"The Local Government (Community Well-being) Amendment Act 2019 restored the purpose of local government, "to promote the social, economic, environmental, and cultural well-being of communities in the present and for the future." This obligates the Council to consider the social and economic wellbeing of all communities in the city." "Community organisations are in a great position to identify the needs of their communities, and to respond quickly to social and economic changes at the local level. They are also often in a position to be able to reach those groups who are 'hard to reach' and address social exclusion."

After living in Shirley for 8 years, and now in Richmond for 3 years, my experience with community organisations/ groups/centres has been varied. I have found them hard to find with no community directory, targeted at certain groups with set specific activities, and open limited hours.

My idea for 10 Shirley Road is to build a new centre for the future, by creating adaptable learning spaces for community groups/organisations to share the resources and become more visible/open/available to those people in the community needing their help and support. They need to be operating from where people already are in our communities: our libraries.

We write on behalf of the Mairehau and wider communities concerned about the future of 10 Shirley Rd, Christchurch. According to the 2013 census North and South Mairehau have a population of approximately 7000. Since then we have had further population growth through the development of Diana Isaac, the Rostrevor estates etc

There are no council community facilities available in our community. Prior to the earthquake we were able to access the popular and central facilities at 10 Shirley Rd. This site is central to Mairehau and is on many public transport routes including the Orbiter, 44,100, and Orange Line.

It would be sensible of the Community Board to consider the communities East of Cranford Street when planning a future facility. Due to poor information from the last census the population data is sketchy at best but we have approximately 25,000 people living in Mairehau North and South, Shirley East and West, Burwood, Richmond North, St Albans East and Edgeware North. These communities are within approximately three kilometres of the 10 Shirley Rd site.

We believe that instead of using arbitrary artificial markers such as ward boundaries, community planning should consider naturally occurring geographical features which cause community separation and severance. One of these will be the CNC motorway when it opens pouring traffic down Cranford Street and through our communities. We need to ensure that these communities east of Cranford, are safe in the future and having an independent accessible fit for purpose community facility will help with this.

We don't need nor want temporary activities – we want a community centre. We want all funding directed to a community consultation to start planning for the future of these areas, and to a rebuild of a modern fit for purpose community hub that will serve the current and future generations surrounding 10 Shirley Rd. We would like the governance and management staff to support our communities actively working towards this.

We look forward to our Community Board and Councillors advocating strongly for this in the next Long Term Plan. It must not take another ten years.
