### 1. Purpose of the Report / Te Pūtake Pūrongo

- 1.1 The purpose of this report is for the Council to approve the appointment of a Director to the CMUA Project Delivery Limited Board.
- 1.2 The decision in this report is of low significance in relation to the Christchurch City Council's Significance and Engagement Policy.
- 1.3 This report presents the formal shareholder resolutions required for the appointment of the directors.

### 2. Officer Recommendations / Ngā Tūtohu

That the Council:

1. Approve appointment of Barry Bragg and as Directors of the CMUA Project Delivery Limited Board.
2. Agree that the report and/or decision can be released at the discretion of the Chief Executive of the Council.

### 3. Reason for Report Recommendations / Ngā Take mō te Whakatau

- 3.1 The Council has agreed to take responsibility for the delivery of the Canterbury Multi-Use Arena as outlined in the Investment Case, conditional on the negotiation of a satisfactory Funding Agreement with the Crown.
- 3.2 The Council has agreed to establish a Project Board to provide independent governance and financial control over the delivery of the Canterbury Multi-Use Arena. Council has appointed Murray Strong, Steve Reindler and Richard Peebles as Directors of the CMUA Project Delivery and approved the appointment of Murray Strong as Chair
- 3.3 This report presents the formal shareholder resolutions required for the appointment of a further director.

- 3.4 Barry Bragg is a Chartered Accountant with extensive governance experience. Mr Bragg has experience as a Director of a number of entities, such as Nga Tahu Property, Canterbury District Health Board, Air Rescue, Flying Doctor Service and property and commercial companies. He has been employed at the Group Manager level in a number of large public entities. He is affiliated to, and his appoint is supported by, the mana whenua.
- 3.5 Barry Bragg was interviewed by the Council Chief Executive and the Chair of CMUA Project Delivery who recommended his appointment.

Section 32(1) of the Companies Act 1993 (**Act**)

**BACKGROUND**

- A. Christchurch City Council (**Council**) is the sole shareholder of the Company.
- B. Under the constitution of the Company (**Constitution**), the Council has the exclusive right to:
  - (a) appoint (and remove) directors, in accordance with clause 10.2; and
