#### 9. Briefing by CCC on Draft Climate Change Strategy

A presentation was given by Emma Davis on the Christchurch City Council's Draft Ōtautahi Christchurch Climate Change Strategy that is currently open for consultation on the Council's website until 25 April 2021, link at:

Discussion was held about the Strategy and Emma responded to queries relating to membership on the Advisory Group. Questions asked related to:

- Whether vulnerable groups/rangatahi have been considered on the Advisory Group.
- Korero with community groups /drop in sessions.
- Highlighting biosecurity through the Strategy.
- National level interaction on climate change, mitigation versus reduction of emissions, e.g. electric vehicles.
- Adaptation planning issues.
- Protection of vulnerable areas.

Consideration was given to the Zone Committee's input about the Strategy. Ideas and examples related to:

- Resilient households, e.g. rain water collection and composting toilets.
- Areas the Zone Committee is aware of that could be evaluated against the strategic ideas.

#### 10. Water Quality Ecosystem Health

Tina Bayer, Environment Canterbury, gave a presentation on water quality ecosystem health.

Tina advised she will include trend analysis in the next update to the Zone Committee. Monitoring data is available on the LAWA website at <a href="https://www.lawa.org.nz/">https://www.lawa.org.nz/</a>.

Staff will further investigate nitrates and nitrogen trends, for example liaising with farmers about their changes. Noted that aquatic ecosystem health data could be from other influences affecting results – this matter will be checked.

In relation to swimming sites at Diamond Harbour, Tina advised she would check with Jarred whether the data was particularly affected by rainfall. A suggestion was made to support scientific investigation in the key catchments that have been worked on.

**Aurora Smith** – Talked about issues of interest from the recently held joint workshop of the Banks Peninsula, Christchurch West Melton, and Selwyn-Waihora Zone Committees, e.g. what the Zone Committee can do and targets to be achieved.

**Liz MacPherson** – Carrying out research on projects, e.g. ecosystem based management. Court decisions happening around Te Mana o te Wai, such as the Aratiatia Livestock decision from Southland.

#### 1. Purpose of Report / Te Pūtake Pūrongo

1.1 The purpose of this report is to provide the Banks Peninsula Water Management Zone Committee with information about the Christchurch City Council's Comprehensive Stormwater Network Discharge Consent (SNDC) and Banks Peninsula Stormwater Management Plan (SMP).

#### 3. Report / Te Pūrongo

- 3.1 At today's meeting, Clive Appleton, CCC Consent Implementation Lead, will brief the Committee on the SNDC. Clive will provide an overview of the SNDC in terms of how it will work on Banks Peninsula and what areas are covered by the SMP. He will cover what is involved in preparing the SMP and timeframes for public consultation.
- 3.2 Jenny Watters will attend to provide the Environment Canterbury perspective on this consent. Jenny was co-ordinating Environment Canterbury's processes for how it responds to and monitors CCC's compliance with this consent and has recently changed roles to Principal Implementation Advisor.
- 3.3 This is an opportunity for the Banks Peninsula Zone Committee to discuss with Clive how the Committee could be involved. Clive, Jenny and Shelley are able to provide some examples of how Christchurch West Melton Zone Committee is involved in the city. The Committee may wish to consider today (or at a later date) whether and how it would like to be involved, and determine if any specific action needs to be added to the Committee's action plan.

#### 1. Purpose of Report / Te Pūtake Pūrongo

1.1 The purpose of this report is to provide the Banks Peninsula Water Management Zone Committee with information about the Community Waterways Partnership and the opportunity for the Committee to discuss whether it would like to sign the Charter and how it would like to be involved.

#### 2. Officer Recommendations / Ngā Tūtohu

That the Banks Peninsula Water Management Zone Committee:

- 1. Receive the information in the Community Water Partnership report.
- 2. Agree to sign the Community Water Partnership Charter.

#### 3. Report / Te Pūrongo

At today's meeting, Sally Airey, Community Waterways Advisor at Christchurch City Council, will brief the Committee on the Community Waterways Partnership.

The Banks Peninsula Zone Committee was invited to the launch of the Community Water Partnership on 22 March 2021. At this launch, over forty community groups, schools, businesses, and organisations/agencies signed the Charter including the Christchurch West Melton Zone Committee, Christchurch City Council and Environment Canterbury. Since then, there has been further signatories.

Clive Appleton co-ordinated the development of the Charter and prepared the business case for the Christchurch City Council. Clive can also explain how the Partnership links with the Comprehensive Stormwater Network Discharge Consent. Sally Airey has been employed to co-ordinate the Community Waterways Partnership.

Christchurch City Council's priorities for the Zone Committee include:

• Advocacy of and support for the Community Water Partnership, including connections with members; community and professional networks.

#### They also include:

- Supporting implementation of Te Wai Ora o Tāne Integrated Water Strategy, in particular Objective 1 Awareness and Engagement, such as leading or sponsoring water forums and supporting City Council initiatives to give effect to Te Mana o Te Wai; and
- Supporting erosion and sediment control workshops for construction industry and developers.

For more information about Objective 1 in the Te Wai Ora o Tāne Integrated Water Strategy please see pages 30 and 31 of this Strategy.

Staff will also provide an overview of the Stormwater Superhero Mobile Resource which is a resource that community groups, schools and organisations/agencies will be able to utilise. This is an

example of the sort of resource that may be developed through the Community Water Partnership that: is based on agreed consistent material suitable for a variety of audiences; provides a network of trained people to deliver the key messages professionally and consistently; and in the case of this resource, provides stormwater educational resources.

The resource is intended to raise community awareness of the impacts of stormwater on the health of urban waterways, the estuarine and marine receiving environments, and associated ecosystems. It is pitched primarily at school-aged children, but is designed to also engage and reach adults and wider whānau through simple explanations of stormwater processes and systems. Through interactive displays and schematics, it highlights basic practical actions that people can undertake at home or in their neighbourhood to mitigate stormwater contamination and protect urban waterways. This information is delivered in the format of a custom-built trailer, equipped with various interactive displays including a touch screen and interactive game, mechanical models, and written material. It is also expected that use of the resource will be supervised by users that have been inducted/trained in its use.

## Community Waterways Partnership Charter

#### **Our Vision**

A collaborative partnership that supports the development of community-based initiatives to improve the ecological health, indigenous biodiversity and the amenity value of our urban waterways.

#### **Purpose of this Charter**

This charter is a shared statement of intent among community groups, researchers, businesses, and local, regional and central government. We seek to work in partnership under a Charter, to achieve outcomes that cannot be attained independently. We will do this by sharing expertise, networks and resources to promote and achieve solutions needed to improve the ecological health, indigenous biodiversity and amenity value of our urban waterways. We uphold Te Mana o Te Wai, to actively protect and enhance the mauri of Christchurch urban waterways.

This Charter is a statement of intent to work in partnership. It imposes no binding authority, decision or obligation on partners. Each signatory partner remains autonomous and none is bound by the Charter in undertaking everyday activities. The partnership is not a new formal structure or organisation.

Christchurch has many passionate community groups that are already working to further protect and improve their local waterways. Activities involving local communities and schools, with support through the partnership, will bring about behaviour changes, at individual, household and community level, to stop contaminants entering stormwater and waterways that degrade water quality.

The Canterbury Water Management Strategy (CWMS) was established in 2009 and sets a framework for a collaborative approach to managing freshwater in Canterbury. The Christchurch West Melton Zone Committee and Banks Peninsula Zone Committee were established to help implement the CWMS in the Christchurch area. The role of these committees is to work collaboratively with the community to make recommendations to Environment Canterbury and Christchurch City Council.

The Christchurch West Melton Zone Committee has identified stormwater as a priority issue. Untreated, contaminated urban stormwater is a major environmental problem for waterways. Routine water quality monitoring of Christchurch's urban waterways reveals regular exceedances for contaminants above guideline levels. Water quality varies considerably across and within catchments. Monitoring identifies areas that need to be improved and it will take time and everyone working together to make a positive difference.

Municipal stormwater treatment infrastructure alone will not address this water quality problem. It also needs communities to actively prevent pollution in the first place. To achieve community action requires communities to be aware of the issues and the actions that they can undertake. Given that in 2017, only 55% of Christchurch residents surveyed were aware that stormwater from roads and properties mostly leads to waterways, so there is a definite need for community awareness-raising and engagement initiatives.

#### **Benefits of a Community Waterways Partnership**

- · Reducing barriers to positive action;
- · Increasing coordination, sharing and communication;
- · Increasing ability to source funding and resources;
- · Increasing consistency of key messages to share with the wider community;
- · Having a collective voice to be more influential;
- · Having a coordinated response across catchments, sectors and stakeholders;
- Increasing support for community groups and organisations;
- · Increasing efficiencies by facilitating the sharing of resources;
- Providing potential for collective advocacy;
- Advocating as one voice for appropriate action from local, regional and central government and businesses;
- · Identifying gaps and initiating projects to address these;
- Increasing the ability to resource a behaviour change, education and awareness-raising programme;
- · Improving capacity and capability;
- · Sharing risk.



#### **Outcomes**

We will work together to:

- Establish a strong collaborative partnership between community groups, businesses, researchers, and local, regional and central government;
- Achieve consensus on messaging interwoven with appropriate cultural narrative, and market these with an innovative package of shared and consistent material suitable for a variety of audiences;
- Develop a network of trained people to deliver the key messages professionally and consistently;
- Design and implement stormwater, habitat and water conservation educational resources to supplement existing resources for use in schools and community events;
- 5. Advocate for incentives that enable community implementation of positive stormwater, habitat and water conservation actions and solutions.
- 6. Establish and facilitate a network of water care champions and kaitiaki;
- 7. Advocate for national legislative change to better address stormwater contaminants:
- Develop research to evaluate outcomes and improvements in our knowledge of best practice community interventions;
- 9. Establish, facilitate or support projects to deliver these outcomes;
- 10. Advocate for resources to sustain the partnership and deliver these outcomes.

#### We will employ the following to deliver the outcomes we seek:

- · An inclusive and collaborative working environment;
- · Time for listening but being willing to make the big decisions;
- To work with the process; but reaching beyond the ordinary with a culture of enablement;
- Clarity on scope and not trying to solve everything in one go;
- Clear communication to avoid surprises and ensure all voices are heard;
- Constructive, challenging and respectful debate;
- To be brave, ambitious and bold for our city's waterways;
- · To have fun and celebrate success.

#### We will achieve this with the following behaviours by:

- Being open to new ideas and ways of doing things;
- Being prepared to say when we are confused or unclear;
   Seeking to understand what others need to succeed;
- Leaving our badges at the door being the best for our urban waterways;
- Being accountable for our areas of responsibility and maintaining our integrity;
- · Respecting differences and embracing diversity.

#### 1. Purpose of Report / Te Pūtake Pūrongo

- 1.1 The purpose of this report is to provide the Banks Peninsula Water Management Zone Committee with information about the Christchurch City Council's Coastal Hazards Adaptation Planning programme (CHAP).
- 1.2 At today's meeting, Jane Morgan will brief the Committee on the CHAP. Jane is the lead for this programme at Christchurch City Council. This programme was mentioned as part of Emma Davis's presentation on the Council's Draft Climate Change Strategy in March and some Committee members and support staff attended the information session held in Allendale in November 2020.
- 1.3 It is also an opportunity for the Banks Peninsula Zone Committee to discuss with Jane how the Committee could be involved.

#### 2. Officer Recommendations / Ngā Tūtohu

That the Banks Peninsula Water Management Zone Committee:

1. Receive the information on the Christchurch City Council's Coastal Hazards Adaptation Planning programme.

#### 3. Report / Te Pūrongo

#### **CHAP Programme**

- 3.1 New Zealand is experiencing the first impacts of climate change, with sea levels projected to rise by around 370 mm within 30 years and just over a metre by 2100.1 Low lying coastal and inland communities in Christchurch will be impacted by more frequent flooding and ponding, rising groundwater, and increased coastal inundation and erosion.
- 3.2 The New Zealand Coastal Policy Statement requires local authorities to plan ahead for coastal hazards and consider a range of options in existing developed areas.
- 3.3 In response to these drivers, Christchurch City Council endorsed the establishment of the Coastal Hazards Adaptation Planning (CHAP) programme on 11 November 2020. The CHAP programme involves adaptation planning with low-lying coastal and inland communities to understand and develop responses to sea level rise and associated coastal hazards. The Council also agreed that the first tranche of communities to undertake adaptation planning will be those in Te Whakaraūpo / Lyttelton Harbour.
- 3.4 The Ministry for the Environment (MfE) has issued 'Coastal Hazards and Climate Change Guidance for Local Government' (2017) which sets out a ten-step process of structured engagement that builds increased awareness of the impacts of sea level rise and leads to the

- development of community-led adaptation plans that consider the social, cultural, natural and built environments.
- 3.5 Adaptation plans will identify community values and objectives and agree on a range of options and pathways that are adjusted over time to respond to the impacts of sea level rise, enabling communities and Council to prepare for the future in times of uncertainty without acting too pre-emptively or with undue delay.
- 3.6 Over time, the implementation of community-led adaptation plans will have significant implications for the city's infrastructure, District Plan, population movement and distribution, natural environment, and the ways that communities and Council manage the impacts of sea level rise.

#### 6. UPDATE ON MATTERS RAISED AT PREVIOUS MEETINGS

- 6.1 Since Ben Manson, Zone Committee member, and Harry Millar's, former Land Management Advisor at ECan, presentation about the Okuti River Project at the Committee's workshop on 20 April, Paula Smith has drafted a story, with input by Harry and Ben. ## The Government's Essential Freshwater package

#### Aims to:

- Stop further degradation of freshwater
- Improve water quality within five years
- Reverse past damage to ecosystems and waterways
- Includes fundamental concept of Te Mana o Te Wai which recognises the vital importance of water







#### The Package

- 1. National Policy Statement for Freshwater Management (2020)
- 2. National Environmental Standards for Freshwater (2020)
- 3. Stock Exclusion Regulations (2020)
- 4. Measuring and Reporting of Water Takes (2010)







#### The Package

#### **National Policy Statement for Freshwater Management**

- Sets national outcomes and policy direction for freshwater management
- Local authorities must notify new freshwater plans by the end of 2024 to give effect to new requirements

#### **National Environmental Standards for Freshwater**

- Contains rules / standards to regulate activities that affect freshwater
- Councils may have more stringent rules in their plans







#### The Package

#### **Stock Exclusion Regulations**

- Apply in addition to requirements in a resource consent
- A more stringent rule in a regional plan prevails over these regulations
- Within 3 metres of rivers and lakes and within natural wetlands
- Apply to cattle, deer and pigs, sheep not included

#### **Water Measuring and Reporting**

- Regulations relating to consented water takes
- Moving to real time measuring and reporting data on water use.







## Te Mana o te Wai Hierarchy of Obligations

Freshwater must be managed in a way that prioritises:

- 1. Health and wellbeing of water
- 2. Health needs of people (drinking water)
- 3. Ability of people and communities to provide for their social, economic and cultural wellbeing





  - 2022: establish policy approach / directions
  - 2023: limits & targets developed / plan drafted
  - 2024: formal consultation process

- ECan and community need to use our time / efforts wisely
