## 3. Wheels to Wings Major Cycleway Route - Hearings Panel Briefing

**Secretarial Note:** *This forum had no decision-making powers and was purely for the purpose of information sharing. The briefing was livestreamed for public access and links to each section of the presentation are available below.*

The purpose of the briefing was for the Hearings Panel to be informed and updated on the outcomes of the consultation, all design options considered, the preferred design including changes resulting from consultation feedback and next steps regarding the Wheels to Wings Cycleway.

Council Officers Lynette Ellis (Head of Transport), Kelly Griffiths (Project Manager) and Ann Thomlinson (Engagement Advisor), and externals Olly Brown and Ben Dodgshun of Peloton provided a PowerPoint presentation (**Attached**).

**Officer Actions**

The following action points were noted:

- The Hearings Panel requested for the current cycle counts along the route to be made available on the Wheels to Wings webpage.
- West end section – In relation to submissions received, were there were any submitters who indicated that they would begin to bike to Nunweek Park as a result of the new cycleway?
- West end section – Concerns were raised regarding the high parking demand at Nunweek Park particularly during sporting events. The Hearings Panel requested for Officers to investigate if any other dedicated parking in or around the park is viable.
- East end section – Concerns were raised regarding the potential conflict points between vehicles and cyclists at the Mitre10 entrance. The Hearings Panel requested for Officers to provide further information on the impacts of having a two way cycleway on the south side after Chapel Street as opposed to the preferred option.
