

### **Decisions Made Under Delegation**

- Requested staff to investigate the appropriate level and location base of representation on the Halswell Hurutini Drainage Rating District Committee.
- Requested more information regarding the stormwater affecting the property at 10 Pages Road, including legal advice, ownership, and cost options for improving drainage.
- Approved the HMNZS Steadfast Reserve Landscape Plan and Tracks Plan, and requested information relating to a Te Reo Māori name for the Park as well as the process for gazetting the land as a reserve.
- Approved the location and construction of a sealed car parking area and new lookout at the Sign of the Bellbird.

#### **Bridge Street Hub**





The Bridge Street Hub's logo is now up, the crowning jewel of the new community centre, bringing the completion ever closer. With just a few finishing touches to be done and a clean, the hub is set to open within the next couple of months.

For the mural inside, Kyla K of KAYLA K Design won the community vote held on 22 October 2021 and will be starting to paint her design on the internal north facing wall of community hub café shortly.





### **Ascot Community Centre – Upgrades**



The Ascot Hub managed by Eastern Community Sport had scheduled renewals and improvements to the patio area to improve flow and access to petanque and parking areas. This work commenced in December 2021. All the current user groups have been advised. In the New Year, the building will also have some internal improvements completed, including new furniture, heating, internal repaint of walls and doors, accessible toilets upgraded and wifi installed.

- Approved the dates for the 2022 Board meetings, which will continue to be held monthly until the end of the term




## Roto Kohatu Reserve Management Plan

It is understood that the Trusts current (undisclosed) high-level financial position is as follows:

Cheque Account: \$2,223.48 Investment Account: \$18,917.82 Liabilities (undefined): \$400

These figures are to be revisited with, and verified by, the Trust.

As noted in paragraph 5.59 of this report the balance of any Trust funds (net of any debts / liabilities) is to be held in Trust by Christchurch City Council "to be used to meet the Upper Riccarton War Memorial's Library's Inc objective of providing a form of memorial to the fallen of the area serving the country in military conflict"
