1. Purpose of the Report Te Pūtake Pūrongo

- 1.1 The purpose of this report is for the Reserves Act Hearings Panel to:
 - 1.1.1 Consider the submissions received through the public consultation process and all other relevant information presented for a new ground lease requested by the Canterbury Society of Model and Experimental Engineers Incorporated (CSMEE) over part of Halswell Domain (refer Attachment A); and
 - 1.1.2 Deliberate and make a recommendation to the Waipuna Halswell-Hornby-Riccarton Community Board, as the decision-maker, to determine whether a new lease for CSMEE existing and proposed rail track, buildings, other supporting infrastructure and structures, and pond area/jetty, should proceed or not.
- 1.2 This report has been written as a result of:
 - 1.2.1 The CSMEE submitting an application for a new lease; and
 - 1.2.2 A number of submitters on the proposed new lease indicating they wish to be heard by a Reserves Act Hearings Panel in support of their submission.
- 1.3 The decision in this report is of low significance in relation to the Christchurch City Council's Significance and Engagement Policy. The level of significance was determined by the low level of city wide interest and the likely impact on those people affected with regard to a long term existing occupation.

2. Proposed Officer Recommendations Ngā Tūtohu

- 2.1 That the Reserves Act Hearings Panel recommends that the Waipuna Halswell-Hornby-Riccarton Community Board:
 - 2.1.1 Receive and consider the information in the report, the submissions, and all other relevant information received on the proposed new ground lease to Canterbury Society of Model Experimental Engineering for an extension to the existing lease area.
 - 2.1.2 Subject to approval of the new lease, approve the surrender of the existing lease and licence plus variations for part of Halswell Domain (refer legal description below), Recreation Reserve under the Reserves Act 1977.
 - 2.1.3 Approve the granting of a ground lease pursuant to section 54 of the Reserves Act 1977 over approximately 8904m2, being part of Halswell Domain (RS40337, CB646/79, Sec 2 SO494103, RT740889, Lot 81774, CB47B/42, Recreation Reserve as shown in Attachment A), for a period of 33 years in 3 terms of 11 years, at an annual rental set in accordance with the Council's Sports Lease Charges Policy.



2.1.4 Authorise the Property Consultancy Manager to conclude and administer the terms of the new lease.

3. Background Te Horopaki

Halswell Domain

- 3.1 The legal description for Halswell Domain is RS40337, CB646/79, Sec 2 SO494103, RT740889, Lot 81774, CB47B/42. Halswell Domain is classified as Recreation Reserve pursuant to the Reserves Act 1977, and has a total area of 14.2875 ha.
- 3.2 The wider Halswell Domain area includes two playgrounds, a skatepark, playing fields, tennis and netball courts, bowling greens, several clubroom buildings, swimming pool, library and two public toilet buildings. Halswell Domain and its surrounds can be seen below in Figure 1.

CSMEE operation at Halswell Domain

3.3 CSMEE started operating at Halswell Domain in 2003. In addition to the model train operation, they also constructed an artificial pond with a jetty to use for model boats, while also allowing the public use of the pond. CSMEE has maintained the train operation and pond to a very high standard, continuously, since 2003.

- 3.4 CSMEE activities include operating a model railway, model boat testing and operations on the pond, and model and experimental engineering.
- 3.5 CSMEE utilise a large number of members to organise and operate public open days, as well as for maintenance of the area.
- 3.6 The trains typically operate for the public each Sunday afternoon 1-4pm. CSMEE pride themselves on providing low cost entertainment for family groups. The model railway operation is particularly popular, and is a City wide attraction.
- 3.7 CSMEE currently use the pond periodically, and do not oppose public access. The pond is utilised by smaller member groups, and for short periods of time (1-2 hours, several days a week).

CSMEE New Lease Proposal

- 3.8 Staff worked with CSMEE during 2021 to guide them with the preparation of a proposal for an additional track and formalising their existing use of the pond.
- 3.9 CSMEE have agreed this is the final proposed track extension and do not intend to apply for any further track extensions.
- 3.10 An overview of the CSMEE new lease area (highlighted in red) is provided in Figure 6 below.

Rail Track Extension

- 3.11 An additional 720m length of rail track will form a new 'loop' which will allow CSMEE to provide driver training and/or engine testing, while at the same time being able to provide rides for the public on a separate loop.
- 3.12 As seen in Figure 6, shown in red, the new loop goes around the pond, and in doing so, utilises a bridge to cross the low lying, often wet, area of the Domain. The bridge will provide for pedestrian crossing and access to the Domain (refer Figure 7 below).
- 3.13 The new rail track incorporates nine path crossings using concrete pads to allow easy public pedestrian access over the track. The access pads are the same design as used on the existing track (1.5 m wide x 1.9 m long).
- 3.14 A new set of stairs is proposed that will provide improved access for passengers to and from the train station, and approximately 25m² of extra lease area is required in the steaming bay area which will allow room for a locomotive turntable.
- 3.15 The new track will require the removal of approximately 15m² of existing vegetation. The 15m² of lost vegetation will be replaced with 35m² of new vegetation, immediately adjacent to the area. The new plants will be maintained by CSMEE and will enhance the landscape values in the area as well as forming a barrier between the new rail track and existing path.
- 3.16 Included in the 15m² of vegetation required to be removed, is one established tī kōuka (cabbage tree), near the toilet block. Arborist advice has been sought on the viability of shifting the tree, and this can be undertaken.

CSMEE Use of Pond Area

- 3.17 Small groups of CSMEE members currently use the pond and jetty at a variety of times each week to hold events and undertake boat testing.
- 3.18 CSMEE would like to formalise their existing use of the pond and jetty, while at the same time encourage public use of the pond at other times. This is to provide certainty for all, and to try and eliminate any conflict, or busy periods, between the public and CSMEE.
- 3.19 CSMEE would like to use the pond for regular member gatherings or events at the following times: Thursdays 10am 2pm, Saturdays 1pm 4pm and Sundays 12pm 4pm. The public will still be encouraged to use and enjoy the pond and jetty outside-these hours.
- 3.20 CSMEE will continue to take responsibility for jetty and pond maintenance (including aquatic weed control), including a one metre land buffer around the perimeter of the pond.

Proposed New Lease

- 3.21 Existing documentation includes a lease plus variation and a licence plus variation. Legal advice is to rationalise existing documentation and incorporate the proposed new area into one lease. This will involve surrendering existing lease and licences.
- 3.22 Key Lease Terms:
 - 33 year term
 - Rent set in accordance with policy for sports clubs and community groups
 - Exclusive use of areas A-D
 - Exclusive use of tracks and pond for CSMEE organised activities at specified hours and times
 - Maintenance of Pond by CSMEE

4. Community Views and Preferences Ngā mariu ā-Hāpori

Public Consultation Te Tukanga Korerorero

Process

- 4.1 Public consultation on the proposed new lease was open from 16 December 2021 to 14 February 2022 on the Council website and Have Your Say page.
- 4.2 Approximately 35 stakeholder organisations were emailed.
- 4.3 Approximately 30 letters including a copy of the plan were delivered to adjacent residents and sent to absentee landowners to introduce the proposal and invite questions or feedback.
- 4.4 In addition, a Newsline article and social media coverage supported the consultation process, and three corflute signs advertising the consultation were erected within Halswell Domain.
- 4.5 A public drop-in information session was held on 19 January 2022 between 4:00pm and 5:30pm.

Feedback received

4.6 The drop-in information session on site between 4.00pm and 5.30pm on 19 January was attended by the public, including several local residents, and the CSMEE project manager.



- One resident from William Brittan Avenue, opposite the proposed rail track, raised concerns about other issues in this area of the Domain, but all those attending were strongly supportive of the proposal and the work being done by the CSMEE.
- 4.7 Social media feedback on both the Council and Halswell Community Group Facebook pages during the consultation period was very positive. For Council it was the most popular post for December, reaching more than 80,000 people with 837 likes 140 comments and 52 shares with most comments in support.
- 4.8 Over December 2021 and January 2022 the Halswell Community Hub group received 71 Likes and 18 comments, all positive.
- 4.9 Te Rūnanga o Ngāi Tahu was approached early to discuss the proposal and seek feedback.

 A Ngāi Tahu representative advised they have no concerns to raise and did not wish to make a submission.
- 4.10 Of the 261 submissions received, 258 indicated support for the new lease proposal and three did not approve. 122 gave Halswell addresses, with the majority of the remainder from wider Christchurch suburbs. Two submitters living immediately across William Brittan Avenue from the miniature railway supported the proposal.
- 4.11 Two organisations provided feedback: The Halswell Residents' Association strongly supports the proposal noting that it was due to their efforts that the CSMEE originally established on the site. The Halswell Residents' Association requested more cycle parking. A submission from SPOKES highlighted the need for cycleway access and expansion.
- 4.12 Five submitters indicated they wish to speak to a hearings panel, three in full support, one in support with suggestion, and one in opposition.

Summary of supportive submissions

- 4.13 The overwhelmingly strong support for the proposal included 80 submitters who made no further comment. The remaining 179 in support expressed appreciation for the CSMEE's activities, self-resourcing and management of their space for use by the community.
- 4.14 More than a quarter commented on the value in extending the rail track, and there was specific support from 11 submitters for the proposal for a more structured use of the pond. The society members provide a positive atmosphere in a suitable environment to attract all ages, especially families and young children, as noted by half the submitters. This affordable activity complements other domain uses and does not restrict other activities. Feedback also noted family groups make use of the CSMEE operation, and surrounding area, for other family activities such as birthday parties.
- 4.15 More than a quarter of submitters noted the CSMEE operation as real asset to the Halswell community, and nearly as many commented that the miniature trains are also an attraction for wider Christchurch and beyond. There were also a number of comments praising the education and experiential value of this outdoor engineering activity, and two submitters commented specifically in appreciation of the CSMEE's value to the disabled.

Summary of opposing submissions, and project team responses

- 4.16 Suggestions and concerns raised by 16 submitters in support of the new lease including vegetation and planting ideas. There were requests to ensure the track extension has adequate resourcing and facilities including public walking and cycle access to the wider domain.
- 4.17 Two of the three submissions opposing the proposal came from local residents, one of whom lives next to Halswell Domain. Both are concerned that the changes that have happened over time affect their quality of life as residents. They both consider the CSMEE operation is



- intrusive and noisy (especially the tooting from the trains). These two residents are concerned about the new track's proximity to houses and the footpath. The adjacent resident is also concerned about the loss of amenity from the change in outlook from their property, and would like to see the track go deeper into the reserve instead of closer to William Brittan Drive.
- 4.18 The other resident indicating opposition to the proposal is from a nearby suburb. However, they stated in their submission that they support the lease if the proposal is amended to mitigate the impact on existing vegetation including mature trees, and plantings are only ecosourced natives.
- 4.19 See table below for details and project team response to suggestions and concerns raised

of grass will be removed when the track itself is

- 4.20 Following submitter feedback, there are two amendments to the proposal for consultation, resulting in the proposal for approval:
 - The mature tī kōuka cabbage tree will be relocated out of the path of the proposed rail track, and be re-planted close by.
 - Eco sourced native plantings will be used.
- 4.21 Submitters have been sent a summary of consultation and details of the hearing. Those requesting to be heard have been contacted separately.

5. Details

Decision Making Authority Te Mana Whakatau

- 5.1 The Delegations Register (3 June 2021) states the following powers:
 - 5.1.1 Part D Sub-Part 1 Community Boards Section s54 Reserves Act 1977 "To grant leases of recreation reserves in accordance with this section." "Excludes the hearing and determining of submissions/objections (refer Delegations Register Part D Sub-Part 4 Council Hearings Panels)"
- 5.2 Part D Sub-Part 4 Council Hearings Panels s54 Reserves Act 1977 "To hear and determine submissions and objections, and to make recommendations in relation to the granting of leases or licences of reserves."

Legal Implications Ngā Hīraunga ā-Ture

5.3 The existing lease/licence, together with the proposed new track and pond use, have no legal implications. The Society will be responsible for obtaining all necessary building and resource consents.

Risks Ngā Tūraru

- 5.4 There are minimal risks to Council, if any. The Society is long established on this site, has a strong membership, and a very good track record of managing and maintaining their operations and lease area.
- 5.5 The proposed lease is compliant with the Reserves Act 1977, and the consultation process has complied with the Reserves Act 1977 and the Local Government Act 2002.

Next Steps Ngā Mahinga ā-muri

- 5.6 The Reserves Act Hearings Panel will present its recommendations to the Waipuna Halswell-Hornby-Riccarton Community Board to determine if the lease should be approved.
- 5.7 If the Waipuna Halswell-Hornby-Riccarton Community Board approves the new lease, the Property Consultancy Manager will conclude the terms of the lease with CSMEE.
