4. Metropolitan DRF Staff Panel Recommendations

- 4.1 The total of the recommendations made in this report is: \$23,082 (all from the Discretionary Response Fund).
- 4.2 The Metropolitan DRF Staff Panel recommends that the Head of the Community Support and Partnerships Unit makes a grant of \$5,000 from the 2021/22 Metropolitan Discretionary Response Fund to the Epic Sports Project NZ Charitable Trust toward funding of Get Active Sports Christchurch Corrections.
- 4.3 The Metropolitan DRF Staff Panel recommends that the Head of the Community Support and Partnerships Unit makes a grant of \$557 from the 2021/22 Metropolitan Discretionary Response Fund to Deutsch in Christchurch Incorporated for transport costs of the stage to and from the venue.
- 4.4 The Metropolitan DRF Staff Panel recommends that the Head of the Community Support and Partnerships Unit makes a grant of \$8,000 from the 2021/22 Metropolitan Discretionary Response Fund to the New Zealand Choral Federation Canterbury West Coast Region towards venue hire and sound/staging.
- 4.5 The Metropolitan DRF Staff Panel recommends that the Head of the Community Support and Partnerships Unit makes a grant of \$6,000 from the 2021/22 Metropolitan Discretionary Response Fund to the Deacon Trust towards salary costs of their Course Manager for the Heart Space Mental Health Coach Training Programme.

Increase participation in physical activity and positively contribute toward wellbeing and quality

How Will Participants Be Better Off?

Physical activity is recognised as a key contributor to wellbeing and quality of life. Those who are more physically active tend to live longer, have healthier lives and increased functional and cognitive capacity. Physical activity reduces anxiety and depression, helps reduce obesity and developing chronic diseases.

Physical activity improves opportunities for social contact, social inclusion and cohesion. It allows youth to develop critical life skills such as communication, fair play, dedication, collaboration, leadership and courage.

Epic's coaches help youth develop a sense of value, belonging and self-worth, hope and determination for change. With hope and determination, Epic believes that youth will be less likely to participate in antisocial behaviour, drugs and gang involvement.

Staff Assessment

The Get Active Sports sessions is a weekly (during school term, Fridays 10.30am - 12) volunteer programme. The programme will provide up to 65 youth in the Christchurch Men's Corrections Facility Youth Unit access to experienced sports coaches to allow participation in recreation activities such as soccer, touch rugby, basketball, and more. The sessions will form part of the Youth Unit's weekly programme aligned with school terms, meaning there will be 41 sessions for the year.

The Epic Sports Project is the first, and currently the only, organisation to offer a sports initiative in the youth unit's correctional programme at Christchurch Men's Prison. Sport can play a role in the prison system by being a creative way to encourage and motivate behavioural change, being one tool that responds to the complex needs of youth in prison. Epic continues to work with correctional staff to improve their approach to engagement with youth.

As part of the Corrections Volunteer Programme, this Epic programme is not funded by Corrections.

The group are working in conjunction with the CCC Events Team to organise the Council's shipping container stage to be used for their performances. The Events Team are fully supportive of this group. They have also asked the Ministry of Ethnic Communities to reach out to other ethnic communities within Christchurch who may wish to share the stage and perform at this event also.

The group are asking for support for the transport costs of the stage to and from the event. The total cost for this is \$557.

The Big Sing is a national group-singing competition for secondary school students. Secondary Schools' Choral Festivals began in 1988 as a development of the vocal section of the Westpac Schools' Chamber Music Contest. Regional festivals take place over a period of 1-4 days in 11 centres during May/June. The choirs are required to present varied 10-minute programmes, including at least one New Zealand

Big Sing Regional Choral Festival will be held as a one day event in the Christchurch Town Hall. involving approximately 1000 young singers from 20-25 Canterbury and West Coast choirs. The Christchurch event will be managed by a group of volunteers led by Rosemary Fisher, the Regional Coordinator.

Top choirs from around the country will be put forward for selection to the Finale, to be held in Christchurch 26-28 August 2022, or to the Cadenza, to be held in Timaru 12-13 August.

After a return to the Town Hall in 2019 and 2021, NZCF are eagerly anticipating a 2022 event back in their traditional "home".

Outcomes that will be achieved through this project

100 people will attend mental health training courses and gain skills to assist mental health needs in our community.

These trained volunteers will work alongside community and church agencies to support access to other mental health services and professionals.

Deacon Trust will run community seminars on mental health topics.

How Will Participants Be Better Off?

Course attendees will be equipped to support community members, colleagues, and friends with mental health needs. They will also be better positioned to understand their own needs and those of their family.

This may be a catalyst for gaining further training in counselling or other health professions.

Staff Assessment

Founded 2018 with HeadSpace and HeartSpace courses starting in November 2019, this relatively new community trust provides mental health training to community and church groups. The focus is on creating a supportive, empathic and relational approach that takes the burden off mainstream services and encourages community resilience. As a relatively new trust, they have established their training programme, and conducted three and six month pilot courses with an initial group of 54 individuals, and are now looking to expand their services. The Chinese community in Christchurch has engaged particularly readily with this programme, as they look to address concerning suicide rates in their community.

Financially, the Deacon Trust expect to receive around \$10,000 in course participant fees over the next year, but this will only go a portion of the way to cover staffing costs. It is hoped that donations through church connections and community grant funding will help to make up that difference. They have \$30,000 cash in their accounts, which is a significant accumulation for a community trust of this age (particularly through covid), and speaks measures for their likely longevity. However, moving from one paid position in the last financial year to three (Course Manager, Clinical Director, Administration) is a growth that they may struggle to support without tapping significant external funding.

In the current climate, with anxiety and stress affecting ever-increasing number of people, this service is addressing a community need, and may help to relieve some pressure on the burdened health sector. At the completion of two three-month courses, it is hoped that individuals will have the pastoral skills to effectively support individuals until appropriate professional services are available, and to act as a navigator into appropriate support elsewhere.

The courses require participants to attend classes one night a week, complete readings, keep a journal of activity, undertake a field-work project, and complete a practical placement within the church or local NGO. While not for the purpose of religious ministry, it is clear that this course is designed to build capacity in individuals so that they are able to serve the local community or church. Design of the courses was completed with the support of Workplace Support, Mental Health Education & Resource Centre (MHERC), Laidlaw College, Stepping Stone Trust, and the Canterbury Men's Centre.

The rationale for recommending \$6,000 of funding towards this application is:

- . It would likely not receive funding from other sources as it is non-clinical mental health support.
- They are actively working in and establishing relationships with communities that traditionally are reluctant to access mental health services.

Staff Assessment

The Kennett Cup is the oldest cross country event in New Zealand, it was first held in 1930. As part of their club centennial year the Christchurch Avon Athletic Club (Inc) are excited about this event being an important part of their celebrations.

With the country in the Orange Covid setting there is now the opportunity to attract runners from around New Zealand to compete. The club will be focusing on increasing the marketing for this event to attract out of town participants.

While the site at QEII is ideal to host this event, without a changing facility yet on site there is a lack of amenities, therefore the funding the club is seeking is to hire port-a-loos.

Rationale for recommending \$525 is as follows:

- This event incorporates the South Island Cross Country Championships and is renowned for attracting out of town athletes.
- The event is being held in June therefore cannot be funded within the timeframes for Small Sports Events Fund where it is ideally suited.
- Once a changing facility with public toilets is available at QEII, the need to hire port-a-loos for events such as this will be reduced.

An aspect of the tournament which is very positive is the development of youth referees, all games are refed by youth and several of the younger teams are also coached by youth.

Rational for recommending \$3,000 towards the Christchurch International Cup Football tournament is as follows:

- This is a very popular community football event catering for tamariki and rangatahi.
- The event attracts teams from all around New Zealand and Australia (pre Covid). They are expecting 72 teams and are hoping for some from Australia.
- This event develops youth as referees and coaches.
- Local clubs are provided preferential entry before the registrations are opened up to other provinces.

How Will Participants Be Better Off?

Health and Safety. Specifically in the areas of staffing and food management. With the ever changing Covid-19 guidelines for business, the operations coordinator role has been pivotal to the safe and effective running of Kairos food rescue. Kairos has many volunteers and visitors to the warehouse and free store on a weekly basis, and with tons of food entering and leaving these premises its extremely important that operations are managed well and in a timely manner.

Staff Assessment

Staff have been liaising with Kairos Trust over the past few months, discussing at length, current operations and future plans.

Demand for the services that Kairos provides continues at pace, particularly with the ever changing Covid-19 situation. Their current space no longer serves their business. \$120,000 has been granted from the Ministry of Development. The grants purpose is to lease new premises. However, this is proving challenging, as landlords are reluctant to sign a one-year lease.

The role of Operations Coordinator (OC) plays a key role in ensuring all of Kairos' operations run smoothly, efficiently, and in a timely manner, in what is a fast-paced environment. In addition, the OC works to support and supply other foodbanks in Christchurch. Staff noted that pro-active collaboration included City Mission, local Marae, Satisfy, NZ Food Network, Delta Community Support Trust, Grace Vineyard and Wai-ora. An important part of this role is the responsibility for the well-being of staff, and volunteers. This includes keeping abreast of the Health and Safety at Work Act 2015.

The rationale for recommending \$11,232 to Kairos Trust is the invaluable work that is delivered at a local level. Staff will meet with the group and discuss funding options including the group applying to the Strengthening Communities Fund in the future.
