# 8. Hearings Panel Report - Halswell Domain Miniature Railway & Pond - New Lease

#### **Board Consideration**

The Chairperson of the Hearings Panel introduced the report.

The Senior Planner Open Space was in attendance and spoke to the report and answered questions. It was clarified that concern regarding possible excessive tooting of the horn on the model engine was raised during consultation and was a topic of discussion at the hearing. This feedback was taken into account and was addressed by a recommended condition that tooting of the horn on the model engine be used for safety reasons only as there are instances where the track crosses walkways.

Following a question from a member, staff noted a timeframe for the project could not be confirmed at this stage.

Members acknowledged the hearings panel and staff for their work on this project, particularly the consultation process which garnered a high level of feedback and noted that the activity is enjoyed by many people throughout the city.

It was noted the Canterbury Society of Model Experimental Engineering plans to replant the area and incorporate a cycle parking facility.

The Chairperson called for a mover and seconder. Debbie Mora moved the officer's recommendations. The motion was seconded by Andrei Moore.

Following invitation from the Chairperson there was no further debate on the item, and the motion was put to the vote and was declared carried.

- 6. Approves the new lease, subject to the understanding that "tooting" of the horn on the model engine will be for safety purposes only.
- 7. Requests the Council's Transport Unit to survey the demand for additional cycle parking in the Reserve as soon as possible.
- 8. Notes that the Canterbury Society of Model Experimental Engineering do not plan any more extensions to the lease area.

### 13. Elected Members' Information Exchange

#### Part B

Board members exchanged information on the following:

- The recent Greater Hornby Residents' Association meeting discussed the following topics:
  - Council staff are working to address concerns of the property owners adjacent to the Branston Street bund regarding containers that are to be moved and landscaping undertaken.
  - Concern regarding residential intensification proposals and how they affect Hornby.
  - Resource consent for the Hornby Menzshed on Wycola Park is still awaited.
  - Hornby Toy Library was vandalised ANZAC weekend.
  - Railway line/traffic island beautification in the vicinity of Carmen and Shands Roads, is being looked at.
  - Waterloo and Gilberthorpes Roads intersection report is still awaited.
  - Antisocial road use in Hornby is causing concern.
  - Staff advice on the location for the replacement of trees removed from Buchanans Road due to the construction of the South Express Cycleway is awaited.
  - Denton Park trees need trimming and pruning.
  - Trees on the Eastern and Western border of Branston Park are blocking sunlight and residents are seeking that the trees be trimmed.



- A Council arborist has visited Oakhampton Reserve and assisted with the removal of a fallen cabbage tree. It was noted that an assessment needs to be undertaken regarding the health and appropriateness of other cabbage trees at the reserve.
  - Residents have also made customer service requests regarding overgrown vegetation on the perimeter of Oakhampton Reserve.
- The recent Templeton Residents' Association meeting discussed the following topics
  - Templeton School Board is working with Council staff on safety planning, particularly regarding school pick up and drop off on Kirk Road.
  - There is interest in the location of any possible site for the Christchurch Organics Processing Plant, currently located in Bromley.
- Council is currently provided online information sessions on residential intensification proposals that are currently being consulted on.
- A Community Board Briefing is scheduled regarding investigations into community travel for Halswell School, and opportunities for accessibility and safety improvements.
- The piano in the Singlemen's Quarters, Halswell Quarry Park appears to be in need of replacement.
- Waka Kotahi New Zealand Transport Agency has been contacted regarding the possibility of a meeting about disputed directional signage on Halswell Junction Road.
- Community Board representatives will present at the Council Draft Annual Plan 2022-23 meeting on 4 May 2022 and a number of hearing meetings will be held until 14 May 2022.
- The opening of the Hornby Centre is delayed due to the inclusion of the hydrotherapy pool in the project and delays in the supply chain and it is now scheduled for completion September 2023.
- Halswell Junction Road extension proposals are being progressed but scheduled delivery in June 2023 could be delayed.
- Construction of the South Express Major Cycleway is progressing.
- Halswell Residents' Association meeting reported a survey of residents regarding intersections in Halswell has been undertaken with many responses received.
- A letter box drop is scheduled to notify residents of a community meeting regarding engagement related to Ngā Puna Wai and the new Netsal Facility.
- The benefits of livestreaming Board briefings was discussed. The Board agreed that it wishes to continue to hold Community Board briefings online.
- It was noted there is local concern regarding intensification proposals in the vicinity of local shopping areas on Riccarton Road, at Westfield Riccarton and Bush Inn Centre.
- There was discussion about the process for traffic safety improvements on Richmond Avenue.



• The Hornby, Riccarton, Halswell and Templeton ANZAC Services were attended by Board representatives and wreaths on behalf of the Board were laid. The services held were of a high quality. Noise from passing traffic was an issue at the Hornby ANZAC service.

#### 13.1 Templeton Pool

The Board noted local interest in the future use of the Templeton Pool following the opening of the Hornby Centre in 2023 and agreed to seek staff advice on any proposals for the future of the pool.

#### Part B

That the Waipuna Halswell-Hornby-Riccarton Community Board:

 Requests that staff provide advice on plans regarding the operation of the Templeton Pool after 2023 when the Hornby Centre and attached hydrotherapy pool is scheduled to open.

#### 13.2 Waka Kotahi New Zealand Transport Agency Meeting

The Board noted local interest in Halswell regarding Halswell Road improvements. The Board agreed it would be advantageous to meet with Waka Kotahi New Zealand Transport Agency representatives to discuss Halswell Road, the proposed upgrade and plans for a footpath, the intersection with Aidanfield Drive and any proposals for the entrance to the current supermarket and plans regarding construction of the proposed supermarket. The Board would also like to discuss intersections of Halswell Junction Road with Sparks, School and Glovers Roads.

The Board agreed to ask staff to arrange a meeting with Waka Kotahi New Zealand Transport Agency to discuss these issues.

#### Part B

- 1. Requests staff seek an opportunity for the Board to meet with Waka Kotahi New Zealand Transport Agency representatives to discuss traffic issues in Halswell including:

  - d. Proposals regarding the entrances to the current supermarket and the supermarket proposed to be constructed
  - e. Intersections of Halswell Junction Road with Sparks, School and Glovers Roads.

#### 13.3 Cashmere Road - Pedestrian and Cyclist safety

The Board discussed concern regarding pedestrian and cyclist safety on Cashmere Road, particularly the area near Halswell Quarry Park.



New development in the area has seen an increase in cyclists and pedestrians using the road however there is no footpath or other adequate provision for safety of pedestrians and cyclists.

The Board agreed to request staff investigate pedestrian and cyclist safety on Cashmere Road, particularly the area near Halswell Quarry Park and provide advice on measures that can be implemented to improve safety.



# 3.3.1 Report back on other Activities contributing to Community Board Plan [for items not included in the above table but are included in Community Board Plan]

#### ANZAC Mural

The ANZAC Mural located on the Hornby Primary School building that faces the Hornby War Memorial is complete. The school worked in partnership with residents and the Hornby ANZAC group to facilitate this project. The mural was completed prior to ANZAC day so was able to be enjoyed by the community who attended the ANZAC day service at the memorial.





#### Hornby Covid Support - Need a Buddy?

This initiative which supports community members who are isolating at home, involving local organisations Hornby Community Care Centre, Te Whare Awhero, 126 on the Corner, Citizens Advice Bureau, and the Greater Hornby Residents' Association, has been well received.

From the launch of the 0800 HORNBY number until 1 May 2022 there have been 53 Calls/Messages received.

Prior to RAT tests becoming widely available initial calls were how the community could access them.



Support given to community members by the Need a Buddy initiative includes deliveries of food parcels, RAT tests, children activity packs and wellbeing packs. Those who identified that they were new to Hornby also received welcome packs (created by Te Whare Awhero).

Key trends identified include:

- Those who are needing support often don't have friends/family close by to offer support.
- Some people couldn't afford the petrol to pick up RAT tests (when queues were an issue).
- People were unable to order groceries online as they didn't have a credit/debit
- Low-income families that are in isolation are struggling with food necessities as it is not usual for the whole family to be home during the day EG: Many rely on food in schools to help with support for their children's breakfast.

In addition to specific Covid support this initiative has allowed community members to connect with key organisations within their community. Need a Buddy organisations will continue to stay in touch with community members and support them to become more involved in the community once they are out of isolation.

#### • Songpa-gu Korean Garden Project

At the Board's 12 April 2022 Meeting, Simon Oe spoke, on behalf of the Christchurch Songpa-gu Sister City Committee, regarding the landscaping proposal to install a traditional Korean pavilion and update the garden at the Songpa-gu Korean Garden, Halswell Quarry Park.

The project acknowledges Korean War Veterans and recognises the sixtieth anniversary of diplomatic relations between New Zealand and the Republic of Korea. A report seeking approval from the Community Board for this work was presented at the Board's 3 May 2022 meeting.

The Committee plans to unveil the pavilion and gardens on Saturday 4 June 2022 and an invitation has been extended to Board Members to attend.



#### • Harvard Lounge Maintenance

The Harvard lounge is currently closed to have scheduled maintenance work completed. This work is due to be completed by 6 May.

#### Christchurch City Council's Draft Annual Plan 2022-23 Community Board Submission

The Christchurch City Council's Draft Annual Plan 2022-23 was open for feedback from 11 March 2022 to 18 April 2022. Pursuant to the decision of the Board's Submissions Committee on 5 April 2022, the attached submission was lodged on behalf of the Board (**Attachment B**).

#### Draft Plan Changes

The Housing and Business Choice Plan Change, Draft Coastal Hazards Plan Change, Draft Heritage Plan Change, Draft Radio Communications Pathway Plan Change were open for feedback from 11 April 2022 to 13 May 2022.

A Waipuna Halswell-Hornby-Riccarton Community Board Submissions Committee meeting was held on 4 May 2022 to consider the preparation of Board Feedback to the Council on the Draft Plan Changes.

#### 3.4 Governance Advice

3.4.1 Following New Zealand moving to the orange traffic light setting (Covid-19 Protection Framework) all Council and Committee meetings, briefings, hearings and working groups resumed in person from Tuesday 26 April 2022. Community Board meetings will resume in person from Tuesday 31 May 2022.

Where a meeting is open to the public, members of the community may also attend in person, request attendance via audio/visual link or watch the live stream where this is available.

Community Board meetings will continue to be livestreamed after 31 May 2022.

### 4. Advice Provided to the Community Board

#### 4.1 Traffic concerns Blankney Street

At its meeting on 2nd November 2021 Mr. Don Pilgrim, resident of Hornby, addressed the Board regarding traffic concerns about excessive driving speed around the right angled corner in the vicinity of 50-44 Blankney Street, Hornby.

The Board agreed to request that staff investigate the issue of excessive speed on Blankney Street and advise possible traffic calming measures. Staff have now provided the attached memorandum in response (**Attachment C**).



Staff advise that the section of Blankney Street between Witham Street and Boston Avenue is a local road that has a Collective Risk (also described as crash density) rating of "Low Medium". A speed survey was undertaken in October 2020 on Blankney Street between the Oriana Crescent and Dunstan Crescent intersections that indicated that the average speed (both directions) was 41.5 kilometres per hour and the 85<sup>th</sup> percentile speed (both directions) was 50.4 kilometres per hour. This shows that a majority of the vehicles passing through this section of Blankney Street were travelling within the posted speed limit.

Due to residents' concern about the vehicle speeds along the curve which runs adjacent to no.s 44 – 50 Blankney Street (approximately 480 meters away from the last speed survey location), a new speed survey was undertaken near the curve between 9th February 2022 and 15th February 2022 to understand the vehicle speeds at this specific location.

The daily average traffic volumes over the 7-day period was 415 vehicles per day (450 per day over five working days). This relatively low traffic volumes are consistent with many similar local roads in the city.

Information regarding the average speeds and 85<sup>th</sup> percentile speeds (over seven days) can be seen below:

The survey results show that vehicles are predominantly travelling at safe speeds along the curve. Only three vehicles travelled over the posted speed limit of 50 kilometres per hour over the entire 7-day period.

Staff consider that it is likely that the existing road geometry and environment encourages lower speeds through the curve and that physical traffic calming measures such as speed humps or road narrowing along this section of Blankney Street are a high cost solution to a relatively low priority site in terms of the need for safety improvements and would not be justifiable from existing road safety budgets. Funding for such work would need to be allocated through the Long Term Plan either as a specific project or for a citywide traffic calming program. If funding was allocated for a citywide traffic calming program, this area is unlikely to rank as a high priority compared to other locations around the city based on recorded speeds, risk rating and crash history.

#### 4.2 Urban Growth Issues: Trees, Footpaths, Kerb and Channel

At its meeting on 14 September 2021 the Board discussed a public forum presentation to the Board at an earlier meeting voicing concern about the removal of trees often as part of new developments and the negative effect this has on the environment and noted the importance of trees in the community to provide a range of environmental, cultural and social community benefits. The Board agreed to request staff to arrange a joint briefing for the Waipuna Halswell-Hornby-Riccarton and Waihoro Spreydon-Cashmere Community Boards on tree removal as part of new residential/commercial developments.



As the Waihoro Spreydon-Cashmere Community Board has previously had a briefing on Tree removal and replacement as part of new developments staff have provided the attached memorandum to address issues of tree removal, footpaths, kerb and channel.

Staff advise (**refer Attachment D**) that it is a challenge to retain rural trees when land is redeveloped for urban development purposes as rural trees can be very large and specifically planted for rural not urban purposes. For example rural shelter belts can grow very large and it may not be safe or amenable to retain them in an urban subdivision (due to limb failure or overshadowing). Individual trees are not generally protected by the District Plan in new growth areas.

In addition the District Plan sets out that land must be developed at a minimum density of 15 dwellings per hectare excluding waterway and stormwater areas. At this density it is difficult to retain rural trees when the land needs to be shaped and sometimes compacted (for drainage and geotechnical reasons), roads and footpaths constructed and services installed.

While subdivision consents make provision for suitable urban tree species to be planted in streets and other public spaces and there is often planting on residential lots it takes time for trees to mature.

Waterway and stormwater areas generally incorporate a reasonable amount of tree planting but this may not be immediately obvious as the trees take time to establish and mature. Sometimes there may be reasons for not having trees in the wetland reserves. In terms of some examples staff advise that:

- At Greens stormwater basin (Kennedys Bush Road/Glovers Road), the draft landscape plan has nearly 1400 specimen trees.
- 750m Snellings Drain enhancement at Prestons has over 200 large tree specimen.
- Sparks Road wetland does not have a lot of trees as it is intended to reflect the historic swamp theme of the surrounding area.

Staff further advise that large areas of land are being taken for public open space in subdivisions (i.e. for example North Halswell will probably have at least 12%) and through time there may be more opportunities for planting on these areas outside of subdivision processes.

Staff identify that it is common for people to question why footpaths and kerb and channel stop along an existing road in an urban growth area. The timing of any length of footpath and kerb and channel is dependent on when each subdivision site is developed. Under conditions of subdivision consent each subdivision is responsible for providing kerb and channel and footpaths along its frontage of an existing road (with some exceptions) but conditions cannot be lawfully imposed on subdivision consents to force a developer to upgrade an existing road beyond their frontage. Typically the footpath and kerb and channel will be extended/completed incrementally as other developments occur.

The Council does not typically fund footpaths on new urban roads (with some exceptions) as it is considered that the cost should fall on developers, not ratepayers.

#### 4.3 New Hornby Centre

Staff have provided an update regarding the construction of the Hornby Centre which will comprise of customer services facilities, a library and swimming pools (**refer Attachment E**). The pools will include a lap pool, a hydrotherapy pool, a learn to swim pool, a family spa and a toddler's pool. In addition to the usual collections spaces, the library will include a creative activities space.

#### Waipuna/Halswell Hornby Riccarton Community Board

Submission to the Christchurch City Council Draft Annual Plan 2022-23

#### 1. Introduction

- 1.1. The Waipuna Halswell Hornby Riccarton Community Board ("the Board") appreciates the opportunity to submit on the Draft Annual Plan 2022-23 ("the Plan").
- 1.2. The Board would like to speak to its submission.
- 1.3. The Board acknowledges that a number of its submissions on the Draft Long Term Plan 2021-31 were accepted, in particular Riccarton's two bus lounges are to stay open, plans to decommission Wharenui Pool are on hold, in recognition of the heritage values of Yaldhurst Memorial Hall Expressions of Interest have been called for Community Use, Hasketts Road properties sale is to be subject to conditions, Wycola Skate Park renewal has been brought forward and subsequently the installation of a hydrotherapy pool has been included in the Hornby Centre project. The Board is grateful for the changes made to address its concerns and accommodate its priorities.

#### 2. General Comments

#### 2.1. Rates

- 2.1.1. The Board notes the new general rate differential proposed for vacant central city land and accepts that this could encourage owners to develop vacant areas as well as help to offset the increase of residential rates.
- 2.1.2. The Board acknowledges the difficult task the Council has to balance the costs of maintenance and development of the city, particularly in these difficult and uncertain times including current rising construction costs while keeping rates at a level that is affordable to residents. It urges the Council to recognise, however, that many residents are currently suffering significant financial hardship and to provide support where possible for those struggling to pay increased rates. In addition to the rates remission policy consideration could be given to payment schemes, deferral etc. with residents made aware that staff are available to discuss and support access to the options for payment of rates.
- 2.1.3. The Board supports the proposed change to the Revenue and Financing Policy to enable the Council to require financial contributions from developers to fund related Council works, if it chooses to do so in future after appropriate consultation. The Board recommends that development contributions be spent in growth areas where they are most needed and emphasises the importance of contributions being used as soon as new developments go in to ensure that the necessary supporting infrastructure is provided and provision is made for ongoing maintenance. considers that the intersection improvements at Milns/Sutherlands/Sparks Road referred to at 2.3.1 is an example of necessary roading changes lagging behind development.

#### 2.2. Proposed changes to revenue, spending and borrowing:

- 2.2.1. There Board supports inclusion of 1.8 million dollars in the Plan for implementation of the Government's Resource Management (Enabling Housing Supply and Other Matters) Amendment Bill. The Board understands that this is a significant piece of legislation and it is important that meaningful consultation be undertaken on it.
- 2.2.2. The Board notes that the Plan includes additional revenue of 1.9 million dollars from surplus property to be disposed of. The Board reiterates its submission on the Long Term Plan supporting in principle the disposal of properties that are surplus to the Council's requirements but cautioning against disposal of property for which there is or could be a current or future community use. 151-3 Gilberthorpes Road is included in the list of properties for disposal but the Board has become aware that there are now a number of potential community uses being put forward for these premises and it therefore asks that the disposal of this property be revisited.

#### 2.3. Capital Programme

- 2.3.1. It is of CRITICAL CONCERN to the Board that the Plan does not provide for advancement road improvements to the intersection of Milns/Sutherlands/Sparks Road (Project 1344) that are currently programmed for beyond 2025. The Board considers that this work needs to be completed sooner than currently programmed and seeks to have the included in the Plan for completion in the 2022-23 financial year. The Board is conscious that a retirement village is currently being constructed in close proximity to the intersection and considers that intersection improvements are CRITICAL for the safety of all pedestrians, cyclists, and vehicles using the intersection. In addition the Board is aware that Sparks Road improvements will go ahead this year and it considers that continuity requires that the intersection improvements be completed at the same time.
- 2.3.2. It was noted that at 3.3.2. of the Board's Long Term Plan submission the Board drew attention to the longstanding flooding issues in Goulding Avenue, Hornby and asked that provision be made to address this problem without delay. Despite assurance that the work would be done under the 21-22 budget the Board is disappointed that no work has yet been undertaken and seeks provision in the Plan for this work to be undertaken in the 2022-23 financial year.
- 2.3.3. As part of its Long Term Annual Plan submission the Board sought provision for a park and ride facility in the south west. The staff response to the submission pointed out that a business case supporting investment in Public Transport endorsed by the Council in December 2020 did not identify Park and Ride facilities as a cost effective measure to improve bus patronage across greater Christchurch as a whole, compared with other alternatives, such as increasing bus frequency, improvements to bus

priority and improvements to bus stop infrastructure and noted that Park and ride facilities were recommended in the Selwyn District and Waimakariri District Long Term Plans. The Board considers, however, that the distance many residents need to travel to access reliable passenger transport services is a hindrance to them changing from private motor vehicle use to buses and suggests that provision of park and ride facilities in association with passenger transport improvements that are being made is important to maximise use of passenger transport services and notes many people currently utilise parking on streets for this purpose. Mindful that the cost of any land purchase to provide for a facility is may be more expensive in the future the Board seeks the provision be made in the plan for a park and ride facility in the south west.

- 2.3.4. The Board notes that the construction of the South Express Major Cycleway through Hei Hei is to be brought forward. The Board maintains that this should not be done in advance of necessary work to improve the safety of the Waterloo/Gilberthorpes Roads intersection. The work need to be done at the same time.
- 2.3.5 In its Community Board Plan the Board undertakes to advocate for the creation of a fenced dog park in the Halswell area as a Board priority. There is \$30,000 in the Long Term Plan at Financial Year 2031 for investigation of a site and \$200,000 in Financial Year 2032 for the project. The Board seeks to have this project that has been requested by many community members advanced, noting that it was previously proposed for the 2025 Financial Year.
- 2.3.5. The Board at the request of the Upper Riccarton War Memorial Library Trust recently recommended that the Council accept a surrender of the lease and demolish the damaged buildings. The Board acknowledges that the Council accepted the recommendation but that following a presentation from Historic Places Canterbury agreed to put a hold on the demolition of the Upper Riccarton War Memorial Library building. As part of its recommendation the Board sought retention of the Library site as an ongoing war memorial and it reiterates that request here.
- 2.3.6. The Board is aware that local residents are seeking renewal of the deteriorated Templeton Domain playground earlier than programmed in the 2026/27 financial year and it supports the advancement of this project to the 2022-23 financial year.
- 2.3.7. The Community Board Plan identifies revitalisation of Sockburn assets as a Board priority. The demolition of the former Sockburn Service Centre and outbuildings has now been completed but the rehabilitation of Sockburn Park and its restoration for use by the local community still needs to be completed. The Board is concerned that more than fifteen years after the swimming pools were decommissioned, the removal of damaged pools from Sockburn Park and rehabilitation of the area has not yet taken place. This work is important for the residents of Sockburn to move forward and the Board therefore seeks provision in the Plan for it to be completed.
- 2.3.8. The Board notes that Amyes Road / Springs Road has been identified as a medium high-risk intersection in Christchurch. Its upgrade is included in the Long term Plan project 60099 that aims to improve safety and reduce death and serious injury crashes at this intersection and also Awatea Road / Springs Road intersection and includes a signalisation of both intersections as a staggered T-intersection.



Although this upgrade was originally proposed prior to the earthquakes work is not now programmed to start until 2025. The Board considers that this work needs to done earlier than currently scheduled as the intersection is in a fast growing area both in terms of development and intensification.

The Board recognises that the funding is significant and its advancement will likely require deferment of another project but points out that this is important safety work while other projects scheduled to commence sooner, for example Project 18371 Gloucester Street (Manchester to Colombo) improvement, could be seen as being in the category of "nice to have". The Board considers that residents, safety needs to be prioritised over enhancement work and urges the Council to consider advancement of Amyes Road / Springs Road upgrade in this light.

#### 2.4. Projects For consideration In Future Years

2.4.1. Kyle Street, Riccarton is a short street in need of a renewal. The National Institute of Water and Atmospheric Research (Niwa) office is located on this Street. A similar street Seton is likely to be renewed as part of the Christchurch Regeneration Acceleration Facility (CRAF) programme. The Board would like to see renewal of Kyle at the same time but if this cannot be done the Board "flags" that it is likely to seek that the renewal of Kyle Street be included in the 2023-24 Annual Plan.

#### 3. Conclusion

3.1. The Board requests that the council considers the matters set out above in relation to the Draft Annual Plan 2022-23.

### **Blankney Street**

#### 1. Purpose of this Memo

1.1 The purpose of this memo is to reply to the Board's request on 2<sup>nd</sup> November 2021:

Mr. Don Pilgrim, resident of Hornby, addressed the Board regarding traffic concerns about excessive driving speed around the right angled corner in the vicinity of 50-44 Blankney Street, Hornby.

The Board agreed to request that staff investigate the issue of excessive speed on Blankney Street and advise on possible traffic calming measures.

#### 2. Update

- 2.1 The section of Blankney Street between Witham Street and Boston Avenue is a local road approximately 550 metres in length, with an approximate average width of 9 metres. This section has a Collective Risk (also described as crash density) rating of "Low Medium".
- 2.2 A speed survey was done in October 2020 on Blankney Street between the Oriana Crescent and Dunstan Crescent intersections. According to the results, the average speed (both directions) was 41.5km/hr and the 85<sup>th</sup> percentile speed (both directions) was 50.4 km/hr. This shows that a majority of the vehicles passing through this section of Blankney Street were travelling within the posted speed limit.
- 2.3 But, as the residents were concerned about the vehicle speeds along the curve which runs adjacent to no.s 44 50 Blankney Street (approximately 480 meters away from the last speed survey location), a new speed survey was organised near the curve to understand the vehicle speeds at this specific location.
- 2.4 A speed survey was done near this curve between 9<sup>th</sup> February 2022 and 15<sup>th</sup> February 2022. The daily average traffic volumes over the 7-day period was 415 vehicles per day (450 per day over five working days). This relatively low traffic volumes are consistent with many similar local roads in the city.
- 2.5 Information regarding the average speeds and 85<sup>th</sup> percentile speeds (over seven days) can be seen below:

- 2.6 From the survey results, it is evident that vehicles are predominantly travelling at safe speeds along the curve. Also, upon analysing the results further, it was found that only three vehicles travelled over the posted speed limit of 50km/hr over the entire 7-day period (three vehicles were recorded in the 50km/hr interval. There were no vehicles recorded travelling over 60km/hr).
- 2.7 It is likely that the existing road geometry and environment encourages lower speeds through the curve.
- 2.8 Physical traffic calming measures (like speed humps) along this section of Blankney Street is a low priority/high cost project for safety improvements from existing safety budgets in the Long Term Plan. For a traffic calming program to be an option for this section of Blankney Street, specific funding would need to be allocated through the Long Term Plan, either as a specific project or for a citywide traffic calming program. If funding were allocated for a citywide traffic calming program, this is also unlikely to rank as a high priority compared to other locations around the city based on recorded speeds, risk rating and crash history.
- 2.9 Council is currently developing a prioritisation tool and a programme for implementation of slow neighbourhood areas over the coming years. This area is one amongst many potential candidates for a speed limit change. However, the approved budget for this activity is relatively modest and is unlikely to be sufficient to deliver complimentary engineering measures (such as traffic calming). As this is still under development and may be subject to changes, it is not possible to say how high a priority this area currently is, however based on the existing safety scenario it is unlikely to be an immediate priority for delivery in this financial year.

#### 3. Conclusion

- Physical measures such as speed humps or road narrowing's are a high cost solution to a relatively low priority site for the need of safety improvements and would not be justifiable from existing road safety budgets.
- 3.2 Council is currently in the process of developing a prioritisation tool and programme for delivery of slow speed neighbourhoods through speed limit changes. This area is one of many around the city where speed limits may be reviewed and changed through this programme.

# Subject: Urban Growth Issues: Trees, Footpaths, Kerb and Channel Introduction

This memorandum responds to the deputation on 4 May 2021 to the Community Board.

The presentation appears to focus on two key issues:

- 1. The removal of established trees to facilitate urban development.
- 2. The timing of infrastructure in new neighbourhood areas including footpaths.

#### **Trees**

Unfortunately it is a challenge to retain rural trees when land is redeveloped for urban development purposes. Individual trees are not generally protected by the District Plan in new growth areas.

In my experience it is often difficult to retain rural trees because they can be very large and specifically planted for rural not urban purposes. For example rural shelter belts can grow very large and it may not be safe or amenable to retain them in an urban subdivision (due to limb failure or overshadowing).

The District Plan also sets out that land must be developed at a <u>minimum</u> density of 15 dwellings per hectare excluding waterway and stormwater areas. At this density it is difficult to retain rural trees as the land needs to be shaped and sometimes compacted (for drainage and geotechnical reasons), roads and footpaths constructed and services installed.

Subdivision consents do make provision for suitable urban tree species in streets and other public spaces. Planting can also be expected on residential lots. It takes some time for trees to mature.

In respect to some of the waterway and stormwater areas generally there is a reasonable amount of tree planting although it may not yet be obvious as the trees are no yet mature. Sometimes there may be reasons for not having trees in the wetland reserves. In terms of some examples:

- At Greens stormwater basin (Kennedys Bush Road/Glovers Road), the draft landscape plan has nearly 1400 specimen trees.
- 750m Snellings Drain enhancement at Prestons has over 200 large tree specimen.
- Sparks Road wetland does not have a lot of trees as they were trying to reflect the historic swamp theme

Large areas of land are being taken for public open space in subdivisions (i.e. for example North Halswell will probably have at least 12%) and through time there may be more opportunities for planting outside of subdivision processes.

#### Infrastructure

It is common for people to question why footpaths and kerb and channel stop along an existing road in an urban growth area.

The timing of any length of footpath and kerb and channel is depend and on when each subdivision site is developed. Under conditions of subdivision consent each subdivision is responsible for providing kerb and channel and footpaths along their frontage of an existing road (with some exceptions).

Council Officers cannot lawfully impose conditions on subdivision consents to force a developer to upgrade the rest of an existing road beyond their frontage. Typically the footpath and kerb and channel will be extended/completed incrementally as other developments occur.

The Council do not typically fund footpaths on new urban roads (some exceptions) as it is considered that the cost should fall on the developer, not the ratepayer.

#### SCOP

Hornby Centre will comprise of customer services facilities, a library and swimming pools. The pools will include a lap pool, a hydrotherapy pool, a learn to swim pool, a family spa and a toddler's pool. In addition to the usual collections spaces, the library will include a creative activities space.

#### **UPDATE**

The piling began slowly as we have undertaken modifications to improve the pile capacities at a shallower depth. This is causing a delay, although the piling rate has increased as piling progresses.

The design team are well underway with the design amendment to add the hydrotherapy pool. The fabrication of this and shipping from overseas will dictate the overall construction programme and, ultimately, the opening date.

We currently anticipate the Hornby Centre will open in Q3 2023. However, the current unpredictability of the piling, hydrotherapy pool sourcing, and global shipping issues will be challenging.

The Hornby High School has expressed interest in having students involved in the construction somehow. We will explore opportunities with them and hold site visits at an appropriate time.




