Organisation Description/Objectives:

The Arts Centre Te Matatiki Toi Ora is a unique historical site, a full square city block of 23 heritage buildings in the Neo Gothic style, once the University of Canterbury and now an Arts Centre, and a major attraction for domestic and international tourists alike. It is run by an independent not-for-profit trust on behalf of the people of Christchurch and houses art, culture, creativity, the creative industries, and education as per the Arts Centre of Christchurch Trust Act 2015.

How Will Participants Be Better Off?

This project is a way to encourage that healthy conversation of mental health and finding hope through those times.

There is then a whole 5 days of hands-on learning about art, tools and techniques of street art. At the start of the painting week, the concept for the piece of art is presented to the rangatahi

Staff Assessment

The Arts Centre of Christchurch Trust Board would like to commission a Tumanako project for Mr G. to run a free wananga for 50 rangatahi over 7 days, resulting in a large community mural at The Arts Centre. The 7 days will include programming around: depression and hope, hands-on art lessons (art, tools and techniques of street art), and mana whenua history of the CBD (based on the Arts Centre's cultural narrative developed by Puamiria Parata-Goodall) that will inspire the artwork concept Mr G will prepare and present to the rangatahi. The students will help paint the mural, 10 students per day over 5 days.

The rangitahi will be referred by social workers, kura and Te Puni Kokiri. The rangitahi families, teachers, social workers, neighbours are invited to be part of the wananga, and to watch the art being created over the 5 day period.

This will take place in early 2023 (TBC). All funding needs to be confirmed ahead of setting a date. Te Puni Kokiri gave verbal commitment if Rata and CCC funding secured. The Arts Centre is contributing to the project through project coordination, marketing, kai, shelter, hosting the 2-day training in the Arts Centre, and building a moveable wall for the mural.

The Tumanako project has been run in Westport December 2021 as part of flood recovery activities <https://westportfloodrecovery.org.nz/tumanako-project-mr-g-rangatahi-mural>

The Arts team is supportive of funding this proposal.

How Will Participants Be Better Off?

The Board and management of Te Pūtahi will have a clear and well expressed strategic vision and direction for the organisation and a plan to realise it. They will be better equipped, motivated and able to realise their organisational purpose. Their partners will feel more engaged and involved in informing their work, and better understand how, when and why they work together. Their funders and other stakeholders will have a better understanding of their organisational direction and development and better able to support them to achieve their purpose.

Staff Assessment

Te Putahi will undertake a collaborative strategic planning process to develop an organisational Strategic Plan and Action Plan. Te Putahi's mahi is to create meaningful ways for the public and visitors to deepen their engagement with the city's built environment, the making of the city and a greater sense of belonging through a diverse and inclusive programme of engagement, urban festivals (FESTA), speaker events (Christchurch Conversations), neighbourhood walks and other programmes.

Te Putahi's funding model is such that it receives funding on a project-by-project basis, they have no core funding, an unsustainable model. This does not allow for time to reflect, review and develop new plans and explore new opportunities, evolve and grow to ensure organisational longevity. Funding to develop a Strategic Plan and action plan will enable the organisation to become a stronger, more sustainable local city making organisation that is focused on strengthening the connections between people and place that opens people's eyes, minds and hearts to the city and its role in their lives and wellbeing.

Te Putahi will engage LEAD Centre for Non Profit Leadership and Governance to develop and run three strategic planning sessions. Director, Jessica Halliday, will manage the project, including consulting with past and existing partners. The plan will be professionally designed and disseminated to stakeholders, partners, and funders.

Te Putahi's organisational mahi and programmes align with the Place Partnership Fund purpose.

Organisation Description/Objectives:

Te Putahi are an independent non-profit that catalyses greater involvement in city making through a diverse and inclusive programme of engagement, i.e. large urban festivals, speaker events, neighbourhood walks and other programmes.

Te Putahi aims to make it easy, desirable and fun for everybody to participate in the shaping and enjoyment of Otautahi Christchurch. Their vision is to see people and the city thrive together. Because they believe that great cities are places where everyone can participate and all life can flourish.

Organisation Description/Objectives:

Bush Farm is a nature-based educational organisation that grew out of the need to bring deep nature connection to the bush, farm, and sea to Children in Canterbury.

Bush Farm has been in operation since January 2018. However it changed legal structure to a charitable trust in January 2021 in order to be able to achieve a more sustainable service to the community.

How Will Participants Be Better Off?

Improved mental and physical health. When individuals connect to nature and can integrate this with skills and knowledge, learners can have a sense of belonging, self-agency and well-being.

-When learners are on the farm and forming connections with the animals, it develops empathy. Research stipulates that early years in the natural outdoors leads to strong environmental values later in life, as well as ability to form healthy relationships.

- When learners are in real-world situations in the bush, sea and farm, it decreases the growing gap between those who 'are of the land' and urban city dwellers.

- Providing access to resources (books, learning materials) for all learners will enhance their experience and learning success

- Health, safety and wellbeing is incorporated into the daily programme, children will learn knowledge and skills of healthy risk, increasing their capabilities.

Staff Assessment

Bush Farm was established as an Educational Trust in January 2021 with the aim to provide authentic, real-world experiences that create new learning pathways about nature and sustainability for children. Bush Farm operates on working farms, in the bush and on the beach, year-round in all weathers for all ages of children.

Whilst parents of the children attending pay fees which cover the costs of the teachers, there are a number of other costs associated with running such a programme which are not covered by these fees. Therefore, the Trust are seeking funding for key materials (taraulins, rope, first aid kits, string, guidebooks) and te ao Maori resources which will help the project provide richer experiences to a wider range of learners.

The materials and resources funding is requested for will be used by approximately 84 students enrolled during term time and in school holiday programmes. Students will be taught how to use all of the materials so they can be empowered with skills and knowledge.

A traditional approach (school) doesn't always meet the needs of many children and offers limited opportunities for connecting children with the outdoors. Bush Farm Trust provides children with opportunities to explore and learn about nature and how to assess and manage risk and understand safety when in nature. This element of the programme aims to provide children with the skills needed to grow into competent decision-makers with appropriate risk assessment skills.

There are 5 contractors that deliver the programmes to children who are all specialists in their field, two of which are trained teachers. There is also one paid member of staff who oversees the work of Bush Farm Trust.

Bush Farm Trust embraces the principles of Tangata whenuatanga - acknowledging and linking our history to the land to create an authentic, real-world context for understanding ourselves and our community. Students have the opportunity to connect to places and spaces in their community and safely explore new concepts or engage in problem-solving.

There are two other similar projects in the wider Christchurch area. However, both of these are businesses and out of the financial reach of many families.

Bush Farm Trust received a Council grant from the Sustainability Fund in FY20/21 for \$10,000 to hire staff and develop a Health and Safety Plan. They have also applied to this year's Strengthening Communities Fund for funding for additional teacher time to increase the scope of the Trust's activities as well as to subsidise places for some children from low-income families to attend and benefit from Bush Farm's programmes without charging fees.

The rationale for the staff recommendation of \$2,000 to Bush Farm Trust is this project aligns closely with the Strengthening Communities Together Strategy and the Climate Resilience Strategy by providing connections to, increasing understanding of and nurturing guardians of the natural environment. Provision of these resources and materials will enrich the learning opportunities of students undertaking this programme. Bush Farm Trust will be provided with a free laptop as part of the CCC Computers for Communities Scheme so funding towards this item is not required.

Staff Assessment

Once again the Multicultural Festival - Celebration of Cultures (MFCC) is planned to be held at La Vida Centre in July, organised by IndianNZ Association of Christchurch Inc. (IAC). The organisers are seeking to build on the success of 2021 which saw 24 different cultural performances from the Indian community as well as other multicultural communities. The event came about in the wake of in the wake of one of their Lohri Mela events. Post event discussions among fellow cultural groups established that it would be good to have a festival where different multicultural groups could perform and share their various cultures.

IAC hope to facilitate cultural celebration with the wider community while supporting the various groups to stay socially connected by meeting each other, improving community resilience and support their COVID-19 recovery.

There are two main events in Christchurch which enables the sharing of different cultures and participation from various multicultural organisations; Culture Galore and the Inner-City East Multicultural Festival. One of the main points of difference for this event will be the fact that it is held indoors. While held nearby to where Culture Galore takes place, this event is also different in the fact that it is organised by the community for the community.

The rationale for recommending \$2,000 in funding to IndianNZ Association of Christchurch Inc is that:

- The event aligns strongly with the Multicultural Strategy and the Strengthening Communities Strategy
- The event has come about due to a perceived community need, identified by the community.
- It has points of difference to Culture Galore in that it is held indoors and it organised by part of the multicultural community for the community.

How Will Participants Be Better Off?

Learning circus arts greatly benefits members' health, both mental and physical. Through a term-based structure members are able to progress through circus skills with the same groups of people, building relationships and a strong community within our organisation.

We provide the opportunity for people of all backgrounds to explore the aspects of play involved in performing arts in a relaxed and supportive environment.

In addition to confidence, mental health, and social benefits, members grow in physical fitness and ability. Our range of classes involve building coordination, balance, stamina, strength, flexibility, and dexterity.

We run performances and events, where students can try out performing. This can lead to students becoming instructors or paid entertainers/circus artists, which further builds the circus community benefitting future students.

Staff Assessment

Circotica provides a high level of circus-based performing arts education to the people of Christchurch and has been financially sustainable since their incorporation in 2018. However, following the implementation of COVID precautions and vaccine requirements across the country, a trustee who did not wish to comply with the requirements for operating decided to leave the board taking their personal equipment which was being used by the school, as well as ceasing to be the personal guarantor on the organisation's lease. This has led to unexpected costs and disruption to their provision of services.

Circotica are seeking to address the issue of personal equipment being used by the organisation with a staggered programme of replacing equipment, but there is an urgent need to replace core equipment used for a number of classes including those with a youth-focus.

The rationale for recommending \$14,641 is based on the following:

- The equipment is a one-off cost that will allow the school to become self-sustaining again.
- Circotica's focus is on accessibility and removing barriers to participation in circus activities so maintains a low fee structure in both its adult and youth / child classes.
- The operation of Circotica contributes to a healthy performing arts ecology in Christchurch, where there is no longer a tertiary provider for circus education.
- Circotica's activities strongly support Toi Otago's Pou Arahi; Hauora Wellbeing through the delivery of professionally facilitated classes that have proven physical and mental health benefits.

In addition the development of the new target scoring system will enhance their ability to attract new and younger members.

Staff Assessment

Recent changes to the ISSF (International Sport Shooting Federation) regulations require shooting clubs to change from their old target systems to a new electronic target system. With the recently upgraded range facilities and the new electronic air pistol targets, the Christchurch Pistol Clubs range will be brought up to world class standard.

Benefits of the new electronic target system include shooters being able to train with the same system used at competition level, greater accessibility for disabled athletes and a more interactive system to attract younger members to the club.

Rationale for recommending \$5,145 of funding to Christchurch Pistol Club for a new electronic target and scoring system is that:

- The new system is a requirement of International Sport Shooting Federation.
- The new system will benefit competitive shooters, disabled athletes and younger club members.
- The club has raised a significant amount of money towards the new system themselves, only requesting 9% of the project cost from Council.

Staff Assessment

Matariki ki te Pātaka celebrations is a collaborative series of wananga hosted by three of the Rūnanga of Te Pātaka o Rākahautū (Wairewa, Ōnuku and Koukourārata). The point of difference with other Matariki event taking place across Ōtautahi is that these wānanga also focus on raising awareness for Puanga. Focusing on the local histories of stargazing specific to Te Pātaka o Rākahautū.

The collective has contributed to the cost of holding the first three wananga but had expected to receive funding from Te Arawhiti's Matariki Ahunga Nui funding to cover the cost of the main hui over the Matariki long weekend. Unfortunately, their funding application was unsuccessful which has put the fourth wananga in question. They are now seeking funds to ensure the fourth wananga can go ahead.

The Papatipu Runanga have very limited experience with Council funding as they normally only approach funders with a specific kaupapa Maori funding pool. They were only made aware they would be able to access funding through Council after their other funding application fell through.

The rationale for recommending a grant of \$10,000:

- Aligns with the purpose of the DRF due to the unforeseen nature of the application.
- The kaupapa has a strong alignment with the Strengthening Communities Together Strategy (People and Place).
- This application is an opportunity to build stronger relationships with the Papatipu Runanga and provide them with more information about Council funding.
