2. Officer Recommendations Ngā Tūtohu

It is recommended that the Head of the Community Support and Partnerships Unit on behalf of the Council:

- 1. Makes a grant of \$14,999 from the 2022/23 Metropolitan Discretionary Response Fund to Te Rūnanga o Koukourarata towards event running costs.
- 2. Makes a grant of \$9,000 from the 2022-23 Metropolitan Discretionary Response Fund to Te Toka Tū o Waitaha Māori Rugby League Manatōpū Incorporated towards tournament costs.
- 3. Recommends Council declines to make a grant from the 2022-23 Metropolitan Discretionary Response Fund to Eduk8 Canterbury towards The Right Track Te Ara Tutuki Pai.
- 4. Makes a grant of \$3,051 from the 2022-23 Metropolitan Discretionary Response Fund to Christchurch Transitional Architecture Trust towards wages.
- 5. Declines to make a grant from the 2022-23 Metropolitan Discretionary Response Fund to Tribute to New Zealand Heroes Association towards Snooker Tournament.
- 6. Makes a grant of \$10,000 from the 2022- 23 Place Partnership Fund to Kahukura Rongoa Maori Trust towards volunteer work and planting.

3. Key Points Ngā Take Matua

Strategic Alignment Te Rautaki Tīaroaro

3.1 The recommendations are aligned to the Strategic Framework and in particular the strategic priority of enabling active and connected communities to own their future. It will contribute to three community outcomes, resilient communities, liveable city and healthy environment. The recommendations are consistent with the Strengthening Communities Together Strategy.

 - Projects or initiatives that change the scope of a Council project or that will lead to ongoing operational costs to the Council (though Community Boards can recommend to the Council that it consider a grant for this purpose).

Assessment of Significance and Engagement Te Aromatawai Whakahirahira

- 3.5 The decisions in this report are of low significance in relation to the Christchurch City Council's Significance and Engagement Policy.
- 3.6 The level of significance was determined by the number of people affected and/or with an interest. It is also due to the decision required being the allocation of an existing funs using approved criteria.



3.7 Due to the assessment of low significance the applications have been discussed with the applicants and other stakeholders in the course of providing an assessment, no further community engagement and consultation is required.

How Will Participants Be Better Off?

Participants will learn about local whakapapa and purakau associated with Ngai Tahu purakau and Mahinga Kai practices, and will learn about medicinal properties of plants, i.e. the tapu and mauri of Te Taiao. The tikanga for entering the natural world, planting, gathering plants or kai starts with karakia acknowledging maramataka, the stars.

Learning about the natural world helps grow values of kaitiakitanga and whanaungatanga; connecting the culture and identity of people with whenua, wai and ngahere.

Staff Assessment

Eight years of volunteer effort have created habitat restoration where bush now thrives. Project Whakapai at the Kāpūtahi Confluence Conservation Park aims to:

Project aims:

- Restore and enhance indigenous biodiversity values by descendants of Ngati Urihia and local communities of the Puharakekenui awa (Styx River) catchment
- · Create a place for Mahinga Kai, Rongoā Mãori, carving and weaving as a collective of Tohunga
- Provide a place for intergenerational and local traditional knowledge for Mahinga Rongoā Māori, Toi Mãori and Mara Kai

Project outcomes:

- Volunteers take an active role in a meaningful project with measurable environmental outcomes.
- Volunteers learn and demonstrate a deeper level of understanding about local traditional values -and practices of native habitat restoration and Rongoā Māori
- Whanau of volunteers feel welcome and able to participate in community events and activities at the reserve
- Participants benefit in terms of te taha hinengaro and taha wairua. Their wellbeing is lifted.

The site/ Kahukura Rongoā Mãori Trust currently hosts:

- Schools, community groups, environmental organisations who help with planting, and are offered a basic introduction to Rongoā Māori
- Annual Matariki celebrations since 2014 with support from the Council
- Whanau visit through local health and social services, which connect on Māori practices of Rongoā, weaving, toi Māori and mahinga kai
- Whanau traumatised by family harm visit and help on the site

Key stakeholders associated with ecological restoration include Council Parks and Reserves, Styx River Restoration Project, Mahaanui Kura Taiao and ECan.

Staff Assessment

This request is recommended as a Priority One due to its strong alignments with Council strategies, the number of people it will reach, and the broad range of outcomes it will achieve.

Te Rūnanga o Koukourarata is working towards enhancing the spiritual, cultural, educational, moral, social and economic wellbeing of the members of the Rūnanga and future generations. At the time of the Port Levy Deed negotiations in 1848, Pukenui was the chief of Koukourarata. After asserting the boundaries of the land, Pukenui and others demanded that Mantell provide 1000 pounds and three reserves. These demands were refused, and instead the hapū received 300 pounds and, despite promises that reserves would be 'large and many', only one reserve at Koukourarata was given. This meant that the whānau and hapū living throughout the tribal lands in the various bays and harbours had to leave their traditional homes and settle in Koukourarata. For 104 000 acres, Ngāi Tuhaitara/Ngāi Huikai received 1361 acres.

Today, many members of the Rūnanga live outside the takiwā. There are a number of issues around infrastructure (drinking water, wastewater, communications, health, roading, electricity) and climate change (risks of fire, floods, and drought) that makes it difficult for the members who want to return to do so. The Centenary will be an opportunity for whānau to (re)connect with the whenua, and for the community to learn about Koukourarata's stories. The preparation for the Centenary has required a high degree of coordination, communication and connecting in order to get it to the stage it is at present. It has shown a desire from whānau and community to be a part of the event, whether that be as a kaimahi or visitor.

Rationale for staff recommendation:

- As a result of colonization, Mātauranga Māori was denigrated. Enhancing a sense of pride of colonized cultures is necessary to build strong and resilient communities. Thanks to the Centenary, the sense of belonging will be enhanced and long-term effects can be expected with members being more engaged with the Rūnanga.
- Koukourarata whānau and community will be able to reengage with the place and enhance whanaungatanga.
- According to the local government act, Council has a responsibility to maintain and improve opportunities for Māori to contribute to local government decision-making processes. Supporting the Centenary is a good way to build trust and connections with the Rūnanga, and eventually, improve their members' participation in the Council's decision-making processes.

Te Toka Tū o Waitaha was established last year after being endorsed by Ngāi Tuahuririr and had a successful inaugural Pacific Series campaign entering 17 teams. Whānau and rangatahi expressed the desire to attend a national event to represent Te Waipounamu at the Aotearoa National Māori Rugby League Tournament. Members of the teams come from various clubs creating a new hapori/ Whānau within the league hapori. The tournament is 14th to 17th April.

This tournament is an opportunity for the boys to develop their rugby league skills while connecting through whānaungatanga.

The boys will be immersed in the values that relate to the tikanga and kawa of their kaupapa both at training and throughout the tournament.

Te Toka Tū o Waitaha enables Māori players to represent their culture as well as their province in rugby league.

How Will Participants Be Better Off?

This event is pivotal for Te Toka Tu o Waitaha as they will be giving the boys their first ever opportunity to not only travel but represent their Māori culture from Waitaha and the wider Te Waipounamu rohe. The boys will be immersed in their culture as well as develop their rugby league skills.

Staff Assessmer

This application is recommended as a Priority 1 as it aligns to Council's partnership with Iwi through Te Tiriti o Waitangi as well as alignment with other key Council Strategies and Strategic Framework.

Te Toka Tū o Waitaha Māori Rugby League Manatōpū Incorporated was established in 2022 to promote, foster and develop Māori Rugby League within the Waitaha region. They surpassed their primary target of entering 10 teams into the Pacific Series rugby league tournament in 2022 and were able to field 17 teams. They now want to take 40 players to the Aotearoa National Māori Rugby League Tournament in Rotorua at Easter weekend 2023. This application is to support the costs associated with attending this tournament, including flights, registration, gear and van hire. They plan to travel from Christchurch to Rotorua to participate in the Aotearoa New Zealand Māori Ruby League Teina Tournament. They will be taking a team of 40 boys to play in the under 13 and under 14 grades. This event is pivotal for Te Toka Tū o Waitaha as they will be giving the boys their first ever opportunity to not only travel but represent their Māori culture from Waitaha and the wider Te Waipounamu rohe.

They commenced planning for this in late December/early January focusing not just on rugby league skills but also the values that relate to the tikanga and kawa of their kaupapa. This aspect of their preparation is very important and for many of the boys and their Whānau this is their first experience of cultural connection.

As an organisation that has been endorsed by Ngāi Tuahuriri, Te Toka Tū o Waitaha not only promote the positive benefits of participating in rugby league but also the values that relate to the tikanga and kawa of their kaupapa. The values around whakapapa, taonga, kaitiakitanga and manaakitanga are at the forefront of how they are approaching and journeying towards this tournament which will provide positive outcomes for their players, coaches, managers and support people.

Letters from the Under 13 players highlight the importance of representing their culture, performing their haka and being immersed in Whānaungatanga with their teammates. Several have never travelled to the North Island before and are really looking forward to this opportunity and experience.

Rationale for recommending \$7,000.00 of funding to Te Toka Tū o Waitaha Māori Rugby League Manatōpū Incorporated to attend the Aotearoa National Māori Rugby Laegue tournament is that:

- Te Toka Tū o Waitaha Māori Rugby League has been endorsed by Ngāi Tuahuriri, mana whenua of Waitaha.
- Te Toka Tū o Waitaha Māori Rugby League enables Māori players to represent their culture as well as their province and this is the first time that teams from Waitaha will be attending the tournament.
- This national tournament is the pinnacle event for Māori Rugby League in Aotearoa and many players pathway to success in the sport began through attending this event.
- In addition to increasing their rugby league skills, participants will be immersed in Te Ao Māori throughout the event to enhance their rangatiratanga.

Staff Assessment

This application is recommended as a Priority Two because of the opportunity it gives for the Christchurch community to be informed and engaged in a positive way about topics which can sometimes be difficult for people to navigate and understand.

Our accessibility and diversity programme is a new initiative for Open Christchurch. It involves a series of events and other programming that will both make the festival more accessible and inclusive - through the development of talks, tours and exhibitions that better reflect the diversity of the people and places of Otautahi - and will also centre the lived experience of diverse people. This year we are focusing on making the programme more accessible to people with disabilities, for instance an accessible tour designed with and for people with disabilities of 3 New Brighton buildings, 2 audio described tours of 2 buildings, an exhibition by a disabled artist, and an accessibility tour of the Christchurch Town Hall designed with members of the Disability Advisory Group. We have also sought to make our open building programme & walks more diverse by opening buildings designed for kaupapa Māori, Tongan and Chinese communities, as well as offering guided walks led by youth and mana whenua. We are also improving our communications & promotion channels to better meet the needs of people with disabilities.

The Trust, operating as Te Pūtahi Centre for Architecture and City Making (Te Pūtahi) has a vision to see people and the city thrive together because they believe great cities are places where everyone can participate and all life can flourish.

They have a reputation for delivering successful events like this for the past two years (as well as Open Christchurch, neighborhood walks and previous FESTA celebration of ourban creativity and regeneration).

This application supports the delivery series of events and other programming that will both make the festival more accessible and inclusive, through the development of talks, tours and exhibitions that better reflect the diversity of the people and places of Otautahi - and will also centre the lived experience of diverse people.

How Will Participants Be Better Off?

Many learners experience success in education for the first time through this program. Often it is the first certificate they've received or course they've passed. This sets them on a long-term path of growth and development.

Staff Assessment

Founded in 2021, Eduk8 Canterbury is a subsidiary of the wider Eduk8 organisation, which has its headquarters in Auckland, but also operates in Otago, Southland, and the Waikato. Financially, the wider Eduk8 group has done very well, generating \$153,000 in surplus over the last financial year. This come primarily through revenue from the provision of services. Furthermore they currently hold \$411,000 is cash reserves.

The Right Track programme is an effective body of work created by the national EDUK8 Charitable Trust as a proactive approach to driver offender rehabilitation. The programme is designed to educate, motivate, challenge and inspire participants to help them make better decisions and choices for the future. The Programme is run as 9 sessions, which is held over the course of 6 to 8 weeks. 30 participants take part at any one time, meaning that the application is for support of a total of 60 individuals. The first programme applied for is from March 8 to April 19. The second is from May 29 to June 28.

The Right Track programme also has good evidence for its success. Despite working with a very high-risk group of the community (some individuals with 20+ Driving-related offences), 79% of course participants commit no more driving offences after completing the course, and a further 12% have committed only one offence. While this reduction in driver offence statistics is at the very heart of the charity, Eduk8 is also very aware of the potential of this programme to have a positive influence on some highly challenged individuals, and work with partner organisations to tie participants into appropriate services as/when required.

The rationale for recommending a decline to Eduk8 is:

- The first of these two programmes (March-April) would be considered retrospective funding,
- While certainly important and aligned to the nationally-led 'Road to Zero' action plan, this programme only has weak ties to Council's current strategic priorities.
- Council's transport team already supports a vehicle rehabilitation programme through a different provider, so this would be duplication.
