#### 4.1 Halswell Community Project Inc Youth Project Report

Kate Cleverly, Senior Project Manager, spoke on behalf of Halswell Community Project Inc regarding its Youth Project Report.

Ms Cleverly advised that the group had identified a gap in the services available to young people in the Halswell area, specifically those intermediate school aged and above. She outlined the work undertaken by Halswell Community Project Inc to identify the needs of local young people and to address these.

**4.3 Proposed rates increase and Intensification Proposal**

Garth Wilson, Central Riccarton Residents' Association Secretary, spoke regarding the proposed level rates increase in the Council's Draft Long Term Plan 2024-34.

Mr Wilson considers the level of increase to be unaffordable for many and proposed that any rates increase should have been capped at no more than five percent.

Mr Wilson also spoke about residents' ongoing concern regarding District Plan proposals to provide for increased building heights of between six and ten storeys in the Riccarton and Hornby areas.

Dear Community Board,

I am writing to you in regard to a new development that is currently under construction on Ayr St (5-9 Ayr St) in Riccarton and my concerns regarding the impacts to the existing neighbours.

The new development is going in behind my house on Riccarton Rd (1-6 Riccarton Rd). Intensification is all ok and my house is in a large development too but when looking at the plans I noticed that the new development is putting a communal bin area bordering my tiny garden (pics below for reference) and looking at the resource consent (RC) there is no gap between my boundary fence and the communal bin area.

Having communal bins in my development too, I am unfortunately well aware of the odour and vermin issues it continuously causes.

The Ayr St bin area is conveniently located away from that developments occupants but completely bordering my tiny garden. This is usable living space with the clothesline mounted to that bordering fence, and an established veggie patch and on top of that it is less than 4m of space to the house with big sliding doors to the outdoor area.

As I see this as a recipe for disaster, I reached out to the council and subsequently to the developer Mike Greers to proactively find a solution that would be suitable for all parties. However both, the council and Mike Greers said they cannot do anything because the resource consent was granted. This seems absolutely crazy to me as this will be an issue going forward and I would have expected the council being on top of this and proactively managing issues.

The only mention in the RC about the bin area is that there is probably more volume of rubbish created than what the bins can handle and it may have to be emptied more than once a week by a private company, if that happens. I have requested the monitoring plan, but I have not received anything yet. However, it just shows me that it is to be expected that there will be a lot of rubbish and this is causing me great concerns as you may be able to imagine. This also means that there will be big rubbish trucks to empty large 660l bins several times a week, which may also be a noise nuisance (depending of the time of the day they choose to empty the bins). I am aware that noise is well explained in the district plan, so hopefully this won't be an issue at all.

I am absolutely shocked and disappointed that the location of the communal bin area was not appropriately considered in the RC application process. I received the RC and it is very telling that the word "odour" is not mentioned in it once. So I cannot see how the council appropriately assessed the effects on the existing neighbours to decide that it was OK to have it non-notified. I am so very much disappointed in the council as I feel completely let down by the process and council's assessment.

This will now lead me to logging odour and vermin complaints when the development is finished and the first whiff of the odour is experienced. Given my experience with my own developments communal bin area, odour and vermin nuisance will unfortunately be inevitable. This is causing me a lot of stress and is definitely not good for my general wellbeing as I feel completely disregarded with my concerns. Knowing this nuisance is on its way and I cannot do anything about it is very frustrating and makes me feel helpless.

I am urging you for future developments to ascertain that council are assessing the location of the bins as what has happened at this development is just not acceptable. A developments communal bin area should not be put into the neighbours backyard and be close to their house and usable garden space. Smells should be internalised within the site which causes it and not be a problem for the neighbouring development(s).

Secondly, I would like to have the councils guidelines in regard to what they are checking regarding the bin locations. I have not been able to find anything online. I have reached out to CCC as well as Environment Canterbury but none have provided me with any actual guidelines. ECAN referred me pack to CCC and CCC planners did not send me anything when I asked about it.

I hope this information can be passed on to all community board members of the Waipuna Halswell-Hornby-Riccarton ward and the community board has some powers to prevent this issue for this and other developments and advocate for better guidelines and assessments.

I am more than happy to talk to someone from the community board either in person or on the phone (mobile 021 214 9424) to explain the issues in more detail if required and I hope you can help mediate regarding this issue. If not, there will be issues down the track with seems a waste of CCC resources.

Looking forward hearing from one of you and sorry for the lengthy email but I tried to explain my concerns and what I have already tried to prevent this future predicament,



Good evening

I am a resident of Westlake, this is a lovely area and I and the other residents in this community have been enjoying living here. This area was subdivided in the 80's to early 2000's where there are large open intersections and roads. Halswell has grown substantially over the years, as such the routes through Westlake are carrying more traffic and catering to increased pedestrian movements. This means that the roading systems through westlake are experiencing major issues relating to speed, lack of street/public area lighting, safe crossing points for pedestrians or CPTD measurements/infrastructure designed to mitigate illegal motoring behaviours such as sustained loss of traction and speeding.

I am writing to our community board and local council representative so these issues can be discussed, then solutions and intersection upgrades, traffic calming measures can start.

The intersection we are desperately needing change for is the Patterson Tce and Rempstone Drive intersection. I highlight this intersection as a first priority as this is classified as a collector route under the District Plan, which carries a high amount of road users. This route is local spine road connecting to arterial routes. At the moment along Patterson Tce there are no traffic calming measures or road markings. Patterson Tce has two different bus routes that travel along this road, this is also a main route for cyclists to commute Dubars Road and then to the CDB. This is also the route pedestrians use to get to Westlake or to get to Oakland Primary school which we are all zoned for. The motorcycle learner test also uses Patterson Tce as one of its testing routes. All these activities happen along Patterson Tce which speaks to its busy nature.

The issues with this intersection (Patterson tce and Rempstone Drive) is that;

1. It is so wide and carries a high amount of traffic (as explained above)
2. The road lighting is sparse
3. Both these streets leading to this intersection are wide, creating a large open intersection
4. There are no traffic calming measures or painted middle lines down either road which facilitate vehicles to drive at excessive speeds.
5. The wide intersection and dim lighting encourages illegal activity such as sustained loss of traction and dangerous behaviours. Attached are photos of the sustained loss of traction at this intersection. This causes unnecessary wear on the road which should be a concern for everyone, as unnecessary surface costs can be prevented with proper intersection design.
6. Crossing this intersection is dangerous as it is wide and vehicles are travelling fast and often you cannot cross without encountering a vehicle that has to stop hastily not to hit pedestrians. The footpath does not dip and allow prams, those with mobility issues to cross at the most logical point, rather they must use peoples vehicle crossings. Attached are photos of the footpath curb which does not facilitate a crossing point.
7. The dim lighting at dusk and dawn is dangerous as vehicles cannot see pedestrians, cyclists ect and vice versa.

I and other residents of Westlake need this intersection to be upgraded, as a collector road in the District Plan this route requires traffic calming measures and pedestrian safety upgrades, this also has the high probability of stopping sustained loss of traction being undertaken at this intersection which will be a major relief for the community of Westlake. We request a built up pedestrian island that is angled so pedestrians, wheelchairs, mobility scooters and prams can fit safely without overhanging into the traffic lanes while crossing the street. An idea of what we envisioned this looking like is attached, changes to the intersection are circled in red. In terms of traffic calming to slow vehicles, speed bumps or raised intersections is what we were thinking. We are aware of the costs for upgrades like this therefore painted lines such as what is attached (circled in purple) is a cost effective option. Ideally, this would be replicated down Patterson tce to help with vehicle speeds.

If getting a raised pedestrian island here will be a long process, please could fixed/bolted in road cones be added as a temporary pedestrian crossing or similar. The plastic road curb ramps will also need to be added for accessibility given there is no crossing point currently. This will also help with the sustained loss of traction and anti-social driving issues as the intersection area accessible for vehicles will be narrowed.

Please can you respond to our request and let us know options of how to get this intersection upgrade facilitated, either by getting this small intersection upgrade in the long term plan with a fast track project time frame (we have been feeling unsafe and not supported in our community for long enough), if you could also suggest other options such as community grants or fast track intersection safety upgrades that could be done with CCC roading team, or perhaps there is community projects funding that could be used, or other suggestions to get this small but major project for our Westlake community underway, that would be appreciated.

Hello Hornby was a wonderful opportunity for the community to come together, celebrate, and enjoy everything that makes Hornby special.

The Hello Hornby - Our Community Party in the Park Committee sent a thank you letter to its supporters expressing their gratitude and appreciation of the immense support that contributed to the event along with a collage of photos (refer Attachment A).



- **Launch of Hornby Community Patrol Car**

The Hornby Community Patrol launched their brand new patrol car amongst their large team of volunteers and sponsors at the Hornby Bowls Club Rooms on Sunday 10th March. Hornby Community Patrol Patron Hillary Muir cut the ribbon and revealed the new car and its signage.

The new car is an incredible asset to the Hornby Community Patrol who contribute significantly to the Hornby community through their patrols, and their ongoing support of other Hornby organisations and events.

In November 2024 the Waipuna Halswell-Hornby-Riccarton Community Board approved a grant of \$22,500 from its Better Off Fund to the Hornby Community Patrol for a contribution towards the car.

### 3.3 Participation in and Contribution to Decision Making

#### 3.3.1 Council Engagement and Consultation.

- **Draft Long Term Plan 2024-2034**

The Draft Long Term Plan 2024-2034 is currently out for consultation. Consultation opened on 18 March and closes on 21 April 2024.

- **Tree Planting Plans**

The Council is seeking feedback on 11 new plans for tree planting in reserves and parks across the city, including Scott Park in Halswell and Jones Reserve in Templeton.

Consultation was open for feedback between 12 March to 9 April 2024.

- **Arthur Street Parking Changes**

To meet increased parking demand, the Council are planning on removing the existing timed parking restriction signage, extending the yellow no-stopping lines outside Middleton Grange School and at the Hansons Lane and Middleton Road intersections and introducing two 60-minute timed car parks on the southwest side of Arthur Street.

Consultation was open for feedback from 25 March until 7 April 2024.

### 3.4 Governance Advice

#### 3.4.1 Summer with your neighbours

At its meeting on 14 September 2023 as part of its consideration of Summer with your Neighbours 2023-24 the Board discussed the programme noting that the application

period closes in August which may be some time before summer events are held and requested that staff assess the feasibility of extending the application period for ‘Summer with your neighbours’ 2024/25 funding through to mid-December and provide advice on possible Board delegation of decision making on grants under this fund to staff.

The August application closing date has previously been uniformly applied across the city. This timeframe allows for all applications to be received, assessed against fund criteria, reported to the Board, decided and the outcome advised to applicants ahead of the start of summer. It is acknowledged that requiring applications in July/August necessitates potential applicants to consider their summer plans and submit applications during winter. To address this the Board has in the past provided for Summer with your Neighbours 2023-24 late applications to be made to allow for the remaining unallocated funding and any unspent funding by funding recipients, to be applied towards events that meet the Summer with your Neighbours criteria and delegated authority to the Manager Community Governance to consider and make decisions on these late applications and to approve grants up to a maximum of \$200 per application. All decisions on late applications to be reported to the Board.

An extension of the application period until mid-December would put Waipuna Halswell Hornby Riccarton “out of step” with other community boards but is likely to offer flexibility to applicants to apply closer to the time of a planned event when they may be better placed to estimate the number of participants, likely costs etc. Delegation to decide applications to staff would enable applications to be processed as they arrive so that approvals could be conveyed to applicants earlier, although this approach would mean that the total cost of applications would not be known in advance of decisions so that recourse to the Board seeking “top up” of the fund may be required to fund later applications. All decisions on applications made under delegated authority should be reported to the Board regularly together with advice on the amount remaining.



## 4. Advice Provided to the Community Board Ngā Kupu Tohutohu ka hoatu ki te Poari Hapori

### 4.1 Matatiki Hornby Centre

The Board and local community are looking forward to the official opening of the Matatiki Hornby Centre on Friday 19 April 2024, with the Board attending a blessing on Tuesday 2 April.


Matatiki offers the Hornby community refreshing pools, learn to swim classes, aqua group fitness classes, library, service centre and more. The Matatiki Hornby Centre pool complex also includes a lane pool, learn-to-swim pool, family spa pool, and toddlers’ wet play area.

Hornby Rotary and the Greater Hornby Residents’ Association have been working alongside the Council to fundraise \$1.4 million for a hydrotherapy pool at the facility. The groups have raised over \$1.1 million to date.

The Goulding Avenue library closed on Thursday 28 March for the shift to Matatiki Hornby Centre with the Customer Services Hub to remain open until 5pm Friday 19 April, before also

shifting across to Matatiki. Following the closure of Hornby Library on 28 March and before the opening of Matatiki Hornby Centre, four Mobile Library van visits were scheduled for the Goulding Avenue site.

#### 4.2 Riccarton Upgrades

A long-awaited facelift is coming for a street in Riccarton as part of a wider package of upgrade work throughout the area.

The Bradshaw Terrace renewal is underway with construction running through until late May. Upgrades will include a full street renewal, including a safer turnaround area at the end of the cul-de-sac, kerb and channel, new street trees, and a new garden bed.

The work is part of the Council’s Christchurch Regeneration Acceleration Facility package throughout residential Riccarton.

Other projects will include a full street renewal of the southern end of Brockworth Place and various traffic calming projects and pedestrian safety upgrades throughout a number of residential streets.

Tactile pavers have also recently been installed at all Riccarton Road intersections between Matipo and Balgay Streets and several other sites in high pedestrian areas. The pavers improve accessibility for people with low vision and provide an anti-slip surface.



#### 4.3 Cashmere Road - Pedestrian and Cyclist safety

At its meeting on 3 May 2022 the Board discussed concern regarding pedestrian and cyclist safety on Cashmere Road, particularly the area near Halswell Quarry Park and requested staff

investigate pedestrian and cyclist safety on Cashmere Road in the vicinity of Halswell Quarry Park and provide advice on measures that can be implemented to improve safety.

At its meeting on 13 July 2023 the Board noted that there is no footpath on Cashmere Road between Halswell Quarry Park and Sutherlands Road and requested that staff investigate and provide advice on the provision of a footpath in that area.

Staff have provided the attached memorandum (see Attachment C) in response to these two requests. Staff advise that this section of Cashmere Road remains 'rural' while other surrounding roads have developed to a suburban standard. The proximity to the Halswell Quarry makes this a popular recreational destination, however the absence of schools / workplaces in the vicinity means that this is unlikely to be a significant route in future for commuting or school related travel. There has been a review of signage along the route including 'Pedestrian' and 'Cyclist' permanent warning signs and there is an upcoming reduction of the speed limit to 40 kilometres per hour that will improve safety for all users.

If a footpath connection is to be delivered, this will need to be provided for as a line item or programme budgeted for in the 2024-34 Long Term Plan with a project budget of one million dollars.

#### 4.4 **Milns Road/Sparks Road/Sutherlands Road Minor Safety Improvements**

An update for the Board on interim modifications to the intersections of Sparks Road/Milns Road and Sparks Road/Sutherlands Road is attached (see Attachment D) which is in response to community and staff concerns about vehicle operating speeds, turning movements and cycle safety at this intersection.

The changes primarily consist of the following changes to road markings:

- Additional markings to highlight the existing cycle lanes through the intersection.
- Removal of the "flush island" markings which separate left turns into Sutherlands Road and Milns Road. These have the potential to convey ambiguity as to which vehicle has right of way.
- Shoulder markings and delineation devices (flexible posts) to tighten the left turn movements from Sparks Road to better manage speed.
- Adjustments to the position of right turn bays to position right turners further forward to improve visibility.

These improvements are an interim measure pending the wider upgrade of Sparks Road to the west of Sutherlands Road. This upgrade is associated with subdivision development in the surrounding area and is likely to get underway next year. Some of the interim improvements will be incorporated within the permanent works.

#### 4.5 **Graffiti Snapshot**

For the Board's information, attached is a Graffiti Snapshot, an update on graffiti as of February 2024 (refer **Attachment E**).

#### 4.6 **Hornby Community Patrol**

Hornby Community Patrol is a volunteer organisation operating as the "Eyes and Ears" of the community for the Police and citizens. The organisation patrols the areas of Sockburn, Templeton, Prebbleton, Halswell, Broomfield, Hei Hei, Islington, Wigram, Park House and Hornby.



## Cashmere Road - Sutherlands Road to Kennedys Bush Road (Halswell Quarry)

### 1. Purpose of this Memo Te take o tēnei Pānui

- 1.1 The purpose of this memo is to fulfil requests for information from the Community Board
  - 1.1.1 **18.6** *Cashmere Road, Halswell – Footpath* from the 13<sup>th</sup> July 2023 meeting
  - 1.1.2 **13.3** *Cashmere Road – Pedestrian and Cyclist Safety* from the 3<sup>rd</sup> May 2022 meeting
- 1.2 The above actions both contain reference to photos in the meeting minutes of the section of Cashmere Road between Spalling Road and Corgwyn Avenue.
- 1.3 The information in this memo is not confidential and can be made public.

### 2. Update Te take o tēnei Pānui

- 2.1 This part of Cashmere Road is defined as a Local Road in the One Network Framework classification. The District Plan defines this as a Collector Road.
- 2.2 Traffic volumes on this section (from a count in 2021) are 1206 (weekday) and 1304 (weekend), with an average speed of 50km/h. The posted speed limit is currently 60km/h, changed from 70km/h in December 2019. An earlier (2018) count records volumes of 1525 (weekday), 1,087 (weekend) and speeds of 59.3km/h. In 2018, the speed limit was 70km/h. On 5 July 2023, Council approved a plan which includes reducing the speed limit on this road to 40km/h (“Safe Speed Neighbourhoods”).
- 2.3 Data on pedestrian and cyclist volumes is not available. However, a customer service request from 2016 from a resident of the area references “*high use of this narrow section of road by pedestrians and cyclists*”. It can be assumed that there has been at least moderate pedestrian and cyclist usage of the road for some time, most of which is assumed to be recreational in nature.
- 2.4 The surrounding area is predominantly residential, and this is anticipated to continue in the future. As such there is little expectation of other land use types (such as schools or commercial) that would in themselves generate high travel demands. It is assumed that any commuting pedestrians or cyclists are originating from the immediately surrounding residential properties rather than further afield and are lower in number than the recreational users.
- 2.5 **Crash record**

- 2.6 In the past 10 years, two crashes were recorded on this section of road.
- 2.6.1 One minor injury crash in 2019, which involved a vehicle turning right into the path of an oncoming cyclist. It is possible that environmental conditions (strong sun/shadow) played a part in this crash, which is not easily mitigated by infrastructure. Collision speeds were low, which is likely a contributor to the crash only resulting in minor injury.
- 2.6.2 The second crash was a non-injury crash in 2014, which involved a vehicle exiting a driveway and a motorcycle on Cashmere Road. Details on this crash are minimal.
- 2.7 The crash record does not indicate a strong trend of crashes involving pedestrians or cyclists. However, it is acknowledged that there is little space available on the road, with pedestrians walking on or close to the live lane, and this represents a poor pedestrian experience.
- 2.8 In the block of Cashmere Road between Kennedys Bush Road and Sutherlands Road , there are three distinct sections, with different features and infrastructure. These are shown on pages 1-3 of **Attachment A**.
- 2.8.1 Section 1: Kennedys Bush Road to 900 Cashmere Road. (page 1 **Attachment A**)
- This section includes
    - 1.5 metre cycle lanes on both sides,
    - 3.5 metre traffic lanes, and
    - a 2.2 metre flush median,
    - Three pedestrian refuge islands, two at the intersections and one at the entrance to Halswell Quarry off Cashmere Road.
- 2.8.2 Section 2: 900 Cashmere Road to Quarry Paddocks (page 2 **Attachment A**)
- East of the Halswell Quarry entrance, Cashmere Road narrows to a sealed width of 5-6 metres (varying), and climbs the hill (around 11 metres vertical over 140 metres horizontal).
  - This section is marked with ‘No overtaking’ lines. It should be noted that this prohibits a motor vehicle overtaking another motor vehicle – it does not prohibit crossing the line to overtake a pedestrian or cyclist, provided that it is safe to do so (which is a judgement call that the motorist must make).
  - Site constraints are greatest on this section, with a narrow carriageway, the embankment on the south side, and minimal flat land on the northern side. The land slopes steeply down in places and there may be potential design & construction costs associated with the need for a retaining wall structure.
  - This section is also adjacent to 876 Cashmere Road, which is zoned RNN (Residential New Neighbourhood). When this develops, it will include a safe pedestrian connection between Spalling Road in the west and the continuation of Spalling Road in the Quarry Paddocks subdivision in the east. Council has not, to date, had any indication that this property is ready to develop.
- 2.8.3 Section 3: Quarry Paddocks to Sutherlands Road. (page 3 **Attachment A**)
- Along this section, Council has acquired some additional land during the subdivision of Quarry Paddocks in order to enable a future footpath. However, design and construction requires a line item in the Long Term Plan for this to be delivered.
- 2.9 **Work done so far**
- 2.10 Traffic Operations staff have recently undertaken an extensive review and renewal of signage along the route, including ‘Pedestrian’ and ‘Cyclist’ permanent warning signs.

- 2.11 A speed limit reduction to 40km/h has also been approved through the Safe Speed Neighbourhoods plan. This is intended to be implemented before the end of the 2023/24 financial year. This will contribute towards improved safety for all road users, including pedestrians and cyclists.
- 2.12 **Future work**
- 2.13 A footpath connection between Sutherlands Road and Halswell Quarry has a rough order cost of approximately \$1M. This will need to incorporate design for stormwater coming off the new path and would be located along the northern side of the road to connect the existing footpaths to make a continuous network. This will include both the section 3 adjacent to Quarry paddocks and the steeper section 2 adjacent to 876 Cashmere Road.

### 3. Conclusion Whakakapinga

- 3.1 This section of Cashmere Road remains 'rural' while other surrounding roads have developed to a suburban standard. The proximity to the Halswell Quarry makes this a popular recreational destination, however the absence of schools / workplaces in the vicinity means that this is unlikely to be a significant route in future for commuting or school related travel.
- 3.2 A review of signage along the route, and an upcoming reduction of the speed limit to 40km/h will improve safety for all users.
- 3.3 If a footpath connection is to be delivered as requested by members of the community, this will need to be a line item or programme budgeted for in the 2024-34 Long Term Plan with a project budget of \$1M.



## Milns Road/Sparks Road/Sutherlands Road Minor Safety Improvements

### 1. Purpose of this Memo Te take o tēnei Pānui

- 1.1 To provide an update to the Board on interim modifications to the intersections of Sparks Road/Milns Road and Sparks Road/Sutherlands Road.
- 1.2 This is in response to community and staff concerns about vehicle operating speeds, turning movements and cycle safety at this intersection.

### 2. Update Te take o tēnei Pānui

- 2.1 The Board was briefed on the proposed changes last year. There is funding available to implement the proposal on-street and a contractor has been engaged to undertake the work through the Minor Safety Intervention programme.
- 2.2 The changes are relatively minor in nature and primarily consist of changes to road markings. As shown in the attached plan, included in the works to be undertaken are:
  - Additional markings to highlight the existing cycle lanes through the intersection.
  - Removal of the “flush island” markings which separate left turns into Sutherlands Road and Milns Road. These have the potential to convey ambiguity as to which vehicle has right of way.
  - Shoulder markings and delineation devices (flexible posts) to tighten the left turn movements from Sparks Road to better manage speed.
  - Adjustments to the position of right turn bays to position right turners further forward to improve visibility.
- 2.3 The improvements are an interim measure before the wider upgrade of Sparks Road to the west of Sutherlands Road. This upgrade is associated with subdivision development in the surrounding area and is likely to get underway next year. Some of the interim improvements will be incorporated within the permanent works.
- 2.4 Works are scheduled to be undertaken in the week beginning 10 March 2024 and will take three to four days to complete (weather dependent).
- 2.5 The information in this memo is not confidential and can be made public.
