



# **Decisions Made Under Delegation**

- We listened to 12 Deputations and unanimously supported the sale of Council land at 27 Hunters Road and 43 Whero Avenue, Diamond Harbour to FENZ for a Fire Station and Te Pā o Rākaihautū for a character school. This report will go to the Council's 5<sup>th</sup> June meeting for a decison.







### **IHP minute**


"We remain concerned that whilst the separation of the decision timeframes may be of assistance to the Council when making its decisions, the split dates for final decision by Council is of no assistance to the IHP. That is because it is **artificial and too difficult at this late stage for us to unpick all of those aspects of the evidence and submissions, and associated provisions that are not subject to Policy 3 and Policy 4 of the NPS-UD** from those associated with the MDRS. To that end while we see some merit in the Council offering its suggested colour coding of provisions as a means of identifying what the Council officers consider to be solely Policy 3 and 4, and solely MDRS, or both, we wish to make it clear, that it will be a matter for the IHP to determine, where the line falls based on all of the evidence and submissions before us."

### Context

- Different types of overflows:
  - Dry weather overflows occur as a result of O&M issue such as a pipe blockage
  - Wet weather overflows occurs when capacity is exceeded
- Wet weather overflows can occur at:
  - Manholes → when there is insufficient capacity downstream, wastewater can surcharge to such an extent that it spills from manhole lids – there are about 29,000 manholes in the city (model predicts that 168 MH's may overflow in a storm event)
  - Constructed sewer overflows (CSO's) → located at low points in the wastewater network (usually at pump station locations) and overflows into the environment (waterways) – there are 135 CSO's (model predicts that overflows can occur at 36)
- Environment Canterbury focus is on overflow events that impact waterways – Consent CRC224552: To discharge water and contaminants to water at 53 constructed sewer overflow locations





# **Consent Conditions**

- The discharge consent (CRC224552) <u>demands a continuous improvement</u> in wet weather overflow frequency and volume
  - catchment specific targets for Avon River, Heathcote River and Avon-Heathcote Estuary for 2015, 2020 and 2025
  - individual targets for each consented CSO < two events per year by dates agreed OR by date of Action Plan (as aligned to committed projects)
- Compliance in terms of overflow frequency and volume is measured by the overflow events and volumes predicted every three years in terms of the field-calibrated WW network model when modelling the last 15 years of actual rainfall including a comparison of predicted events and actual frequencies and volumes in the previous reporting period.






Rainfall 📕 # Overflow incidents — -# Events with Overflows — 3 per. Mov. Avg. (# Overflow incidents)
