To provide a planning framework for the land that Council has traditionally provided to regional sports organisations to allocate to sports played on natural turf and to consider the future needs of primary codes supported through this approach.

Goals


- Goal 1: Participate where you live citizens can participate in sport where they live
 - primary focus is training for 6-12 year olds
- Goal 2: Play for life sports field infrastructure supports full and flexible participation
 - focus on changing demands
- Goal 3: Succeed sports field quality enables high level community sport
 - equitable access to appropriate facilities for community sport

<u>Provision and development of the sports field network must balance other recreational needs of the community and competing and increasing demands for use of open space</u>





Spatial analysis methodology is driving the planning framework





Integration with other plans



Sports fields network plan needs to align and integrate with other council plans



Significant issue to consider - increased pressure on existing land

- Housing intensification
- Changes to urban form
- Increasing demand for park use
- Changing sports field use
- Climate resilience- Council's key strategic objective
- Demand for all-weather training and play





Goal 1: participate where you live

- Minimise negative impacts associated with unnecessary travel
- Provides opportunity to contribute carbon neutral goals in a meaningful way
- Targeted at short term training sessions for juniors 6-12 years old
- Relieves pressure on parents minimising barriers to participation





Goal 2: play for life

- City wide network of facilities that promotes participation
- Aligned to mass rapid transport system
- Artificial turf/ training / out of season use for all
- Reduce barriers to participation






Goal 3: succeed

- Design and implement a method for regular and consistent objective feedback on the performance of our sports fields
- Monitor and adjust the maintenance and capital investment plans based on feedback and performance of our sports fields
- Implement new and emerging hybrid turf and irrigation technology for maximising the use, resilience and longevity of new and existing natural turf sports fields
- Work with the RSOs to determine and prioritise capital investment programmes

Multi sport zones



- Provision of flexible training and casual use spaces
- Opportunity to install outside of 'normal' sports park areas





Hybrid turf technology - Ferrymead Park trial



- No consent required
- Can be implemented progressively
- Provides stable surface even when natural grass worn away

- No above-ground sprinklers
- Operates invisibly
- No surface evaporation wastage

CCC 2024-34 Long Term Plan

- Parks Unit bidding for additional \$50M over 10 years to support
- Goal 1 Ground improvements and multi-sport zones
- Goal 2 Up to six artificial hubs (2 x fields per hub)
- Goal 3 Up to 20 hybrids for # 1 club fields
