### Submission to Council on 18th August 2019 followed by the Abley Report in November 2019 which had similar recommendations;

- 1. Safety at the Westminster and Cranford Street intersection due to potential congestion increase from the Northern Corridor project. A need for a dedicated pedestrian traffic light phase and removal of the red left turn arrow to improve traffic flow.
- 2. Lack of clarity on proposed traffic calming measures around the school's entrances on Courtenay St and Westminster St.
- 3. Unclear visibility for road traffic to see pedestrians in the landscaping proposals for Dee Street and Malvern Street.

  Suggestion to plant low-level landscaping for better sight lines.
- 4. Advocacy for a safe crossing point directly outside the school's Westminster Street entrance, as the existing pedestrian refuge on Westminster Street is rarely used due to safety risks.
- 5. Request for an additional entrance to the English Park carpark to enhance safe drop-off practices and reduce risks to students.
- 6. Adherence to Christchurch City Council Cycle Design Guidelines, suggesting separated cycle routes or shared paths on key access routes for students, such as Westminster Street and Berwick Street.



### **Changes to TRAFFIC Flow**



### **Northern Arterial**

- The Northern Arterial opened in 2020 with the outcome of increasd traffic, prompting the DEMP.
- Data collection then included; travel surveys, pedestrian/vehicle counts, and observations.
- Concerns included; uncontrolled crossings, speed of traffic, and safety at intersections.

### **Proposed Historical Changes: Council**

- The addition of the pedestrian crossing point on Cranford Street outside ASB Football Park along with further pedestrian crossings on Sherborne Street.
- Ongoing safety audits throughout the design phase that will be performed by suitably qualified transportation professionals
- Traffic monitoring for a minimum of ten years post completion of the works.
- Consideration of improving active transport in the area.

### Findings in 2019;

- As many students use Westminster gate entry as Trafalger Street
- A crossing was put in at Trafalger but NOT Westminster
- Springfield Road has NO crossing at all yet our children need to cross this road
- If we want less traffic from our school community and active transport then the roads have to be safe

What steps should the Council take to enhance road safety in St Albans?



### **Near Misses and Observations**

### What we are seeing and hearing

### **Cranford Crossing at English Park**

- 1. Multiple logged near misses related to traffic not seeing the lights at all
- 2. Parents and caregivers reporting that they teach their children NOT to cross when the 'green man' begins as cars run through this crossing
- 3. The staff member on this patrol has observed drivers missing this light altogether when children have been crossing
- 4. There is a high volume of traffic using Cranford Street and in particular at times when children are going to and from school

### **Springfield Road**

Submissions from our community regarding NO places to cross safely from West to East in the morning and back again in the afternoon with high volumes of traffic driving at speed.

### **Cranford Intersection with Westminster**

Multiple logged near misses related to;


- 1. Drivers running orange and red lights heading south down Cranford Street (at speed)
- 2. Drivers NOT seeing the red arrow turning East from Westminster into Cranford Street while a 'green man' signal is going (principal and cyclist two of the victims in one morning)
- 3. Crash near misses with blocked intersections

### **Westminster Gate Entrance**

Multiple logged near misses related to;

- 1. Rat runners cutting through Westminster Street, Courtenay Street and Roosevelt Street to avoid Cranford with no places for children to cross
- 2. Child hit off their bike with cars rolling through the intersection at Westminster





### **SAFETY AUDITING**

Before we explore innovative solutions to improve road safety and enhance the well-being of our community we need an URGENT safe systems audit regarding; the impact of the changes, the volume of traffic and the behaviour of our motorists.



### Roads affecting our tamariki;

- Cranford Street (including crossing by English Park and the intersection at Westminster Street)
- Westminster Street
- Courtenay Street
- Springfield Road



### **EXPERT Involvement**

The DEMP Improvements were designed to deter or make the shortcuts through Westminster Street and Courtenay Street more difficult for rat runner drivers (not residents).


We request that experts in traffic engineering, safety and transport planning are involved in providing solutions to address the following issues;

- Cars are running the red light at the English Park pedestrian crossing, (presumably because they are confused from the other traffic lights at the Berwick / Cranford intersection)
- Issues with traffic flow and cycle safety in Courtenay Street
- The entire intersection at Cranford Street and Westminster Street to be audited and made safer for all road users
- A crossing (type to be designed) at the Westminster gate entry (the same number of children who use Trafalgar which has a specific supervised crossing)

### **Collaborate with St Albans School**

The Council has access the expertise that can come up with innovative solutions however collaborating with us before introducing new measures to enhance road safety would be beneficial as we have knowledge of the current issues and an obligation to ensure oour children and community are safe on the roads.



#### Alcohol ban Edgeware Village

On behalf of the local businesses in Edgeware Village, I would like to request that the Christchurch City Council establish an alcohol ban in Edgeware Village.

There has been a significant increase in people loitering and begging in the village recently. Some of these people have also been seen drinking in public and have been aggressive and violent when asked to stop. Others have refused to stop, and attempts to move them on have been thwarted as they know there is no alcohol ban here. There have been many instances of loitering, alcohol consumption and public urination outside business premises. In addition, there have been several incidents of violence against business owners and staff and the police have been called many times.

Members of the public feel increasingly concerned about the presence of people loitering in the area and begging, and many customers say they prefer to avoid the area because of it.

We would find it a lot easier to move people on, or ask the police to attend, if there was such a ban in the area. While local alcohol retailers can and have been refusing service to known offenders, it is more difficult when they have purchased their alcohol elsewhere.

The local businesses are all reporting incidents with people loitering, begging, drinking on the street during the day. I would like to share some of the feedback I have received:

- They actually sit right where my admin team sit on the other side of the glass, so
  its really distressing. Not to mention the constant urination is revolting,
  unsanitary, marking the footpaths too and our people just don't want to visit our
  office
- Vomit and urine all over the footpath again on Monday morning this week.
- We constantly call the police and advise our building manager around the loitering, urinating, and alcohol consuming right outside our office.
- I have been getting feedback from customers that they would rather shop elsewhere now as Edgeware is becoming dangerous and unsafe.
- Edgeware is lovely village experience not a slum
- We support a liquor ban in the Edgeware Village. There have been too many cases of louts drinking in the area and abusing our customers.



- One of them attacked me last month after trying to steal alcohol and when I had asked that they stop drinking on our premises. Given that we only have an "off licence" this behaviour cannot be tolerated and the police need support to remove these types of people from the area.
- I've had a full argument with the Police about their lack of Community Policing and that they are reactive in matters like this. Its only when someone is hurt that they would get involved. I've visited the Papanui police station and also called the 105 number twice, hanging up on them the second time
- I have had to deal with these people every day. They steal our supplies in the
  morning before anyone is on site, they abuse the general public etc. I have had to
  get physical with a group of them as they thought they could enter the pub and
  grab all the left over smokes.
- I have had to intervene in the carpark several times when customers pull up and someone stands right next to their car door asking for money
- Edgeware has become a tolerant area for many of these people which is destroying ambience of the area.
- 1am Tuesday morning quite a lot of activity, people sleeping rough and wandering around, threatening security of businesses as well.

We also need increased police patrols in the area and would request that the Community Board help to request that from the Community Policing Team. An alcohol ban in Edgeware Village would help business move people on who are drinking and give the police the tools to act as well.


