


Our online petition results as of 11:30am 12 June 2024: 162 responses support the alcohol ban


The specific border will be determined at a later date, but will include Stanmore Road and Richmond Village Green. The maps below are indicative only:










Photos from Sideline Sports Bar. James Muir said a man came in clearly intoxicated or under the influence of drugs. He was escorted out.







Prior to the earthquakes, the building was 'active' with day/night time activities/events & used by local community groups. Currently 10 Shirley Road/Shirley Community Reserve is used mostly by the parents/children of the Shirley Primary School, during drop off/pick up times. The majority of the time, this site is left 'vacant' & not 'activated' by local residents.

'Pop up' activities to 'activate' the site have had little success. Events like 'Skip Day' & the 'Car Boot Sale' organised by the 'Shirley Road Central' residents group, required many people to be involved in the planning & running of these events. More hours were invested in planning/meetings, than the actual duration of the event. Events had to be postponed or cancelled due to the weather.

Option 2. A recreation space with a full basketball court, renewed playground, planting, a picnic and BBQ area, a community garden and a walkway. No. Why?

Most of these suggested 'additions'/activities already exist at the Shirley Community Reserve, or in nearby suburbs.

Deprivation by Area Units (6 and above): Here we see Richmond South, Edgeware and Shirley have higher levels of deprivation (6 and above) as a percentage of total population, much higher than the Christchurch Average. - Location of Provision: There is no direct provision of Council facilities within the defined facility catchment area (Shirley, Richmond, Edgeware and Mairehau) and much of what is provided is Church based, with the area being home to a number of strong Church based Trusts.

- There does appear to be a gap in the area identified on the boundary of Shirley and Richmond.

- 6.4.1 Asset data Across Council Owned Community Facilities: This suggests current provision is lower than the city-wide average in terms of community facilities.

The current Shirley Library is located in the carpark of The Palms (Burwood Ward). There are currently no local 'suburban' sized Christchurch City Libraries in the Innes Ward. Shirley Library is considered a 'suburban' library, but there is a limited book selection, no board room, meeting rooms or learning centre (flexible spaces). - 'Suburban' library: Catchment ranges from 1.5km to 3km radius; services population range from 15,000 – 40,000

Services could include a variety of activities and flexible spaces. UDS – Greater Christchurch Urban Development Strategy and Action Plan 2007. - 'Neighbourhood' library: Catchment ranges from 1km to 1.5km radius; serves population from 10,000 to 12,000 people.

Services could include small, broad-spanning collections and a range of activities. "...(2015) Council/ECan planning with mall owners in Shirley, with a view to possible relocation and upgrade of this library as a 'suburban' library." This implies that the current Shirley Library is actually a 'neighbourhood' library?

### Good Morning

Ahead of the decision you are making today regarding the Shirley Community Centre, We would like to reiterate to the board The St Albans Residents Association (SARA) fully supports the rebuild of the facility that was lost to the Canterbury Earthquakes. SARA has always supported investment in community facilities throughout Christchurch in an equitable fashion. We would like to see the decade long indecisive process regarding 10 Shirley Rd end, and some certainty given to the community that a facility will be rebuilt and community groups can again form, and have a space to socialise and carry out their interests, hobbies, and passions as well as have a place to meet, celebrate, commemorate, discuss. This facility should be owned by the people, and managed by the community.

The St Albans Community Centre, Kohinga is now a fully booked facility most days of the week, with other community spaces nearby, such as the very large Scottish Society hall, basically next door. Kohinga has not detracted from the use of the surrounding facilities, more so the center has encouraged the surrounding community to become more social, at a place that is focused on community engagement and providing a space for all to enable this. SARA envisions and hopes for the same to occur with the Shirley Community Centre.

Please be assured that The St Albans Residents Association will lend it's support to the community group entrusted with the running of a rebuilt Shirley community centre at 10 Shirley Rd. The experience and systems developed in the management of Kohinga St Albans Community Centre can be shared and oversight given in getting a management structure in place.

### Most recent SARA CCC-LTP submission

We submit the funding for the Shirley Community Centre be brought forward in the LTP. As is seen in the success of other community centre's in Christchurch lacking this focal point of the Shirley Community is a disadvantage to the local residents. The St Albans Community Centre which we collaborate with the council to manage provides over 400 hrs per month of community activities for the local residents. Shirley residents need this too. ### Briefing note on issues in Edgeware Village

### Summary

- 1. Initial information suggests the issues in Edgeware are related to a small number of people engaging in persistent and sometimes aggressive or intimidating begging, with alcohol consumption sometimes being a factor.
- The Council has a bylaw that specifies public places where alcohol cannot be possessed or consumed (alcohol ban areas). The bylaw is made under the Local Government Act 2002 (LGA) and gives the Police the power to infringe, search for and seize alcohol, and arrest.
- 3. Adding an alcohol ban area is an amendment to the bylaw, which must comply with LGA requirements.
- 4. Staff are of the view that an alcohol ban may not be the appropriate approach to the issues in Edgeware an alternative approach is working across Council, with the Police, Government agencies, and social service providers to address the problems.

### Alcohol Bans

### When we use alcohol ban areas

- 5. Most alcohol ban areas relate to spillover nightlife-related issues around clusters of licensed premises (i.e. Merivale, Northlands, the Central City). Alcohol ban areas being used as a tool to deal with daytime drinking (associated with begging or loitering) is a recent development.
- 6. Legislation provides councils with the power to regulate public places for alcohol control purposes, but places limitations on how that power can be used.
- 7. People begging or persistently occupying public spaces can lead to a sense of community stress and intimidation and has a negative impact on businesses. However, in order to put an alcohol ban in place, alcohol must be shown to be a significant issue.

### What does the LGA require for an alcohol ban bylaw?

- 8. Section 147A of the LGA requires that:
  - there is a "high level of crime or disorder that can be shown to have been caused or made worse by alcohol consumption in the area";
  - that the use of the bylaw must be "appropriate and proportionate" this can be hard to argue if a small number of people are causing the problems; and
  - the restrictions in the bylaw "can be justified as a reasonable limitation on people's rights and freedoms" (this links with the New Zealand Bill of Rights Act).
- 9. Section 155 of the LGA also requires an assessment of whether a bylaw is "the most appropriate way of addressing the identified problem". This requires analysis of what the problem is and whether regulation is appropriate or not.

### Do alcohol ban bylaws work?

10. They provide a tool the Police would not otherwise have, to address alcohol possession and consumption in specified public places.



11. An alcohol ban bylaw does not:

- stop people from being intoxicated it is only able to deal with possession and consumption of alcohol in public places; or
- stop people from loitering or begging in public places.
- 12. Even if an alcohol ban is in place, it may not achieve what the community might hope (i.e. the Police may not have the resources to attend the area and enforce the ban, loitering and begging may persist, alcohol may be consumed nearby but continue to impact on activities in the public area).
- 13. Staff are aware of similar requests for alcohol bans related to begging for other areas. It is important these are analysed individually, based on the evidence available. In some cases, a bylaw may be appropriate.

### Conclusions

- 14. Some of the behaviour being reported may already constitute an offence under the Summary Offences Act (e.g. offensive behaviour or language (s.4), disorderly assembly (s.5A), intimidation (s.21) and obstructing a public way (s.22). These are a matter for the Police.
- 15. The Edgeware community should be encouraged to report any incidents or concerns to the Police as they occur. This will do two things:
  - alert the police to issues that require their attendance or response (eg anything violent, intimidating or threatening); and
  - create evidence / data indicating the types of incidents, frequency, etc.
- 16. An alternative to a bylaw is taking a non-regulatory approach, working with the Edgeware community, the Police, Government agencies like Ministry of Social Development (emergency housing), social service providers e.g. City Mission.
