| Purpose and<br>Origin      | <ul> <li>The Finance and Performance Committee noted during the meeting of 28 February 2024 that 'Staff promised to come back with more information on the OARC Stopbanks, in particular some illustration of what they will look like'.</li> <li>The Finance and Performance Committee meeting of 17 April 2024 noted 'staff to provide information on the stormwater OARC programme of work'. This was actioned via email, in which it was noted that a briefing would also be held.</li> <li>There is an ELT action from the 25 January 2024 meeting to 'engage with Council and the OARC co-governance on the proposed [stopbank] strategy via briefings and memos'.</li> </ul> |

| ELT<br>Consideration       | Continue to progress the design, consenting and construction of interim, short-term stopbanks within the Ōtākaro Avon River Corridor, where practicable set back from the river.  |
|                            | Leave room for long-term stopbanks within the Ōtākaro Avon River Corridor and coordinate design with other Council activities within the corridor (i.e. Parks and Transport).   |
| Next Steps                 | Staff will continue to deliver the OARC Three Waters programme.   |
| Key points /<br>Background | <ul> <li>The temporary stopbanks are coming to the end of their asset life. The <u>Ōtākaro Avon River Corridor (OARC)</u> Regeneration Plan shows new stopbanks and Council has begun construction, starting at Waitaki Street and Avon Park.</li> <li>These new stopbanks will protect over 1,800 homes in large, present day storm events. This is the same level as protection as the temporary stopbanks currently provide and are designed to provide this level of protection for the next 30 years, after which they would require raising/modification. This is because over the next 30 years sea levels will rise as the land continues to sink.</li> </ul>               |

|              | The stormwater and floodplain management infrastructure in the corridor is currently estimated at \$700-800 million, which includes the new stopbanks, stormwater treatment basins, flood pumpstations and raising/modification of the stopbanks. There is \$141M assigned in the 10-year plan.   |

|              | <ul> <li>The CHAP programme will establish the most appropriate long-term strategy for<br/>land use in the catchment, which may or may not require flood defences.</li> <li>Construction of the stopbanks will allow time for the long-term Coastal Hazard<br/>Adaptation Planning (CHAP) process to be applied within the catchment.</li> </ul>  |
|              | Constructing the stopbanks first will mean that stormwater treatment projects will be delayed until later in the programme.   |
|              | There are residual risks in this approach, which will be discussed in the briefing.   |

|                       | The purpose of this information session is to provide Councillors with an overview of the Council's approach to growth-related planning and investment – including growth modelling, strategic planning, asset planning, and development contributions.  |  |

| Purpose and<br>Origin | During co-development briefings for the Long Term Plan 2024-34, Councillors requested an information session on how the Council plans for and delivers infrastructure to service growth development.   |  |
|                       | This session outlines in particular the Ōtautahi Christchurch Planning Programme (ŌCPP), Parks Network Planning, and the fundamentals of development contributions.  |  |
| Timing                | This information session is expected to last for 60 minutes.   |  |
| Confidentiality       | The session, and any shared information, is not confidential.  |  |
| Outcome<br>Sought     | Following this session, Councillors will have a clearer understanding of the interrelationship between the council's growth model, strategic planning programmes, asset planning and investment, and development contributions. These interlinked processes require clear oversight and an integrated approach to ensure Council delivers on its Strategic Priorities, and growth-related plans and strategies.  Staff will provide practical examples of how infrastructure required to support growth is identified and funded, including the requirements and limitations of development contributions. Staff will focus on Local Area Planning, including the GCP Priority Development Areas and Eastern Regeneration Area, being a key component of the |  |
|                       | Ōtautahi Christchurch Planning Programme (noting the council has been previously briefed on the ŌCPP). It is the intention of staff to seek endorsement for the ŌCPP (documentation) after the Council's decision on PC14 in September 2024, given the implications on the urban form within the PDA's.  |  |
| ELT<br>Consideration  | ELT's final feedback and general endorsement of the Ōtautahi Christchurch Planning Programme (ŌCPP) was sought at an ELT meeting on 8 July 2024. ELT generally endorsed the programme, but some feedback was received requesting some changes and provision of more detail in the A3 documentation and presentation material for Councillors. Staff are continuing to make changes to the ŌCPP documentation in response to ELT feedback, but also taking account of pending decisions on PC14 and this Councillor information session.  |  |

| Next Steps                 | Staff will finalise the ŌCPP A3 document and bring a report to a Council meeting in early October seeking endorsement of the ŌCPP.  The Council's Development Contributions Policy is being reviewed in 2024 in accordance with the Local Government Act 2002, which requires all local authorities to have a policy on development contributions and to review that policy at least every three years. There will be a further information session on proposed catchments and development contributions charges in early October 2024.  |

| Key points /<br>Background | <ul> <li>The draft ÖCPP and underlying work was used to inform the development of the Greater Christchurch Spatial Plan and Councillors were briefed on this work in 2022 and 2023, with a high-level focus on ŌCPP alignment with sub-regional documents. The ŌCPP provides an overview of the Council's activities at a network level, a greater level of detail on key actions and a staged local area planning programme.</li> <li>The ŌCPP is intended to guide Council's land use planning and associated work programmes and implementation, bringing together planning for transport, urban forest, biodiversity, stormwater, open space, community facilities, heritage, and identity. The ŌCPP is aligned with the objectives, outcomes and actions of other Council plans and strategies, and the Greater Christchurch Spatial Plan (GCSP), providing a pathway for its implementation.</li> <li>The ŌCPP includes integrated city-wide network and local area actions, including prioritisation of locations for further planning, potential investment and other initiatives that will bring about regenerative outcomes in a staged and targeted manner.</li> <li>The ŌCPP promotes "an integrated and regenerative approach" to development and renewal. Whilst local area planning will need to occur across the city over time, it is prioritised in certain locations based on need and demand. The programme will take many years, noting no specific timeframe is set out. Local area plans will be tailored depending on the issues and opportunities relevant to a specific location and area, including levels of mana whenua and community involvement, and partnership approaches and commitments.</li> </ul> |
|                            | <ul> <li>New Parks are planned and developed to meet the Council's Levels of Service. Council has funded acquisition programmes for both neighbourhood parks and regional parks and charges Development Contributions to fund the growth component of these programmes.</li> </ul>   |
