#### Recent Highlights:

- Closer working relationship with all outreach services operating in the city, allowing joint approaches to difficult issues
- Department of Corrections ongoing support. This includes developing a
  Probation Officer who will deal with community sentences where
  people are NFA, with a focus on those who are living on the street.
- The ability to respond to street issues quickly and effectively (e.g. aggressive beggars or other anti-social/criminal behaviour)
- Establishing good report with those on the street so that solutions can be found with them to deal with matters.
  - Consistent messaging to street community is delivered by all outreach services.
- Inclusion of City Council Libraries Social Inclusion Advisor



#### Growing street trends:

- People living in vehicles,
- Gaps in wider outreach services, e.g. MH and addiction services,
- Prison releases NFA who will be living on the street with no other options available,
- Impact of govt withdrawing from emergency housing and development of KO properties,
- Work that Outreach/Police/Security services do in CBD, is pushing problems out into suburban areas,
- Need to quantify our homeless population.



### Introduction

- Jarrod True on behalf of the Gaming Machine Association of New Zealand and Pub Charity.
- The Gaming Machine Association of New Zealand represents the vast majority of New Zealand's gaming societies.
- Pub Charity is the largest class 4 gambling operator in New Zealand and the largest operator within Christchurch City.



### Introduction

- We ask Council to:
  - · Put the policy out for public consultation.
  - Include in the consultation the option of adopting a relocation provision that enables venues to relocate out of high deprivation areas, out of residential areas, and away from sensitive sites.



- The current policy has been in force since 2004.
- If the policy is rolled over again, without the normal public consultation process, this would be the 6<sup>th</sup> consecutive time this has occurred.
- I am not aware of any other Council that has continuously rolled over its policy without undertaking the standard public consultation process.



- Undertaking public consultation would be consistent with Council's Significance and Engagement Policy. The policy provides:
- The Council seeks meaningful exchange with the community through engagement on local decision making. Genuine engagement will be encouraged in a manner that is consistent with the significance of the issue...



- Policy principle: Decision-makers are well informed, aware of and take into account the community's views.
- A full public consultation will enable decision makers to be better informed. Additional context can be provided.
- For example, the Council report states that class 4 expenditure
  has been relatively steady. In fact, since 2004, per capita spend
  in inflation-adjusted terms has fallen by 50%.



- The Council report suggests there is a link between machine numbers and problem gambling rates.
- However, despite a 44% reduction in class 4 gaming machines and venues across New Zealand, and a 50% reduction in per capita spend, problem gambling prevalence has remained unchanged.



- Being well informed includes considering the migration of the class 4 spend to the local commercial casino and the commercial online gambling providers.
- Only around 2% of casino profits are returned in community grants.
- No community grants are made from offshore-based online gambling providers, and no requirement to make grants is proposed as part of the plan to issue licences to online providers in 2026.



- Taking into account the community's views includes hearing from <u>all</u> parties, including:
  - Players.
  - Gaming venue business owners.
  - Staff at the gaming venues.
  - Community groups and their members who receive funding.



- Policy principle: The level of engagement will be tailored to the level of significance for each issue, proposal or decision.
- The gambling venue policy is a very significant policy.
- The gambling venue policy has implications beyond public health. It impacts entertainment, community funding, employment, and business viability.



- Player entertainment (69.3% of adult New Zealanders gamble at least once a year).
- 2023: \$29,182,388.00 in local grants.
- Between November 2020 and July 2024, Pub Charity distributed \$17.4m, in 1,625 grants that benefited Christchurch City.
- Public interest, and public participation, at gambling venue policy hearings is always very high.



#### **Relocation is a Harm Minimisation Tool**

- There are benefits in consulting. This would enable a relocation provision to be included as a new harm minimisation tool.
- The ability to relocate was introduced by the Māori Party as part of the Gambling Harm Reduction Amendment Bill.
- The aim was to enable venues to move away from undesirable areas to more suitable sites.

#### **Relocation Benefits**

- Venues should be free to move out of high deprivation areas.
- Venues should be able to move out of residential areas or areas that are close to sensitive sites.
- There is no good policy reason for preventing this.
- 44% of the venues are currently located in very high or medium high deprivation areas.



#### **Relocation Benefits**

- Venues should be free to relocate out of earthquake-prone buildings. This is a health and safety issue.
- Venues should be free to move to new, modern, smaller premises. This results in more vibrant central business districts.
- Prohibiting relocation does not lead to fewer machines, it simply entrenches venues in unsuitable locations and unsafe premises.



## **No Urgency or Confidentiality**

 There is no urgency or confidentiality that would make engaging with the standard consultation process inappropriate.

- Sinking lid policy is an effective way to reduce gambling harm
- Over half of councils have a sinking lid policy in Aotearoa New Zealand





- Most harmful form of gambling in Aotearoa New Zealand
- Profits from pokies over \$93 million in Christchurch in 2023
- Design features keep people playing






- Range of impacts on physical and mental health
- Impacts on individuals, whānau, workplaces and communities





- Māori, Pacific peoples, Asian peoples and young people are more likely to experience gambling harm
- Pokies are often located in areas of socioeconomic deprivation







# MENZSHED HORNBY



Site originally brought (under Public Works Act) for community purposes



Community needs have not gone away:

Community is bigger and growing, especially with housing intensification

Community still has high level of social deprivation



LTP scheduled site for disposal – based on assumption that there was no community need

This assumption was wrong — as shown by the groups working to retain the site



# Discounted Cash Flow

Option 2 (our proposal) shows NPV of -\$478 000



Only specific costs given were \$110 000 for subdivision, demolition fencing etc.

Income would be \$200 000 - \$300 000 from sale of no 153 Gilberthorpes Rd.

Only way to get a negative NPV would be to count the forgone sale value of 151 Gilberthorpes Rd

## **Highlights from the Board Area**

New tables and shade sails for New Brighton beachside playground
