  - a. Avonside Drive between Kerrs Road and Wainoni Road, and

- 3.2.2 The Fund does not cover:
  - Legal challenges or Environment Court challenges against the Council, Council Controlled organisations or Community Board decisions.
  - Projects or initiatives that change the scope of a Council project or that will lead to ongoing operational costs to the Council (though Community Boards can recommend to the Council that it consider a grant for this purpose).

#### Assessment of Significance and Engagement Te Aromatawai Whakahirahira

- 3.3 The decisions in this report are of low significance in relation to the Christchurch City Council's Significance and Engagement Policy.
- 3.4 The level of significance was determined by the number of people affected and/or with an interest.
- 3.5 Due to the assessment of low significance, no further community engagement and consultation is required.

#### Staff Assessment

PIPS (Pregnancy Infancy Parenting Support) provides free, non-judgmental practical and emotional support during pregnancy and early parenting. They are unique in Canterbury due to accessibility of services that do not require appointments, not church or government affiliated, and available to all caregivers. PIPS distribute free maternity and baby clothes, nursery equipment and goods to help reduce the stress of poverty for mothers and whānau in the first 1,000 days of a baby's life.

As a non-church or government based organisation, PIPS have trained staff and volunteers available to assist people with their individual needs. Clients engage with the service for a variety of reasons, needing baby items, needing friends or connections postpartum, for information and more. Each contact is an opportunity to check how things are going at home, identify any challenges they may be facing and find out which groups they are engaged with and where support may be needed.

The majority of PIPS clients are from east Christchurch and the focus is on connecting them to locally based services and activities. PIPS provide assistance with practical items and an opportunity to inform, encourage, and support each person to grow the skills and connections needed to thrive during pregnancy and early parenting.

PIPS is experiencing an enormous amount of extra mahi, because of the current economic pressures on whanau (increasing food, petrol, and housing costs). PIPS is becoming more widely known in the community, and as a result people are donating a large amount of items mostly clothes and useful items donated to be redistributed to whanau in need. PIPS distribute these goods out to the community as quickly as possible- due to a great need for clean and safe items at no cost. The circularity of these items decreases consumption and helps ease the financial pressures on the

Since 2020, PIPS have redistributed over 100,000 maternity and baby items to families Support) SCF CB in need. 123 families attended their groups and courses, 650 families supported, and they have had 2,590 client contacts. The PIPS volunteers are under pressure to manage the large volume of donated items in their current resource room set up. Upgrading this space to ensure that it is a suitable workspace to clean, fold and store the items on storage shelving/containers. To ensure that the space can be used efficiently and that items are kept clean and easily found to be redistributed. PIPS have reached out to their local Menz Shed to ask for assistance in assembling the shelving units. The rationale for recommendation of \$3,890 to PIPS is: - The project aligns very strongly with the Strengthening Communities Strategy, Children's Policy and the Community Board Plan. - They offer a valuable and well utilised service to the community, especially encouraging positive parenting and wellbeing. - Recycling of clothing and other items to support local families and avoids items going to landfill.

We will be providing the new youth girls grades with playing uniforms with a jersey presentation so they feel connected and part of our club.

We will be increasing opportunity for active recreation for youth girls in our club in an environment where players feel connected as a team and as a club, as well as local community pride in being a part of Linwood.

Our participants, coaches and management staff will be well equipped to deal with any health and safety issues with having first aid kits available to use.

#### Staff Assessment

Linwood Rugby League Football Club Inc provides children, youth and adults with the opportunity to train, play, coach, administer, and support rugby league in greater Linwood. It has been operating for over 107 years and has a proud history. The season runs from April to September with teams training twice a week and games on Saturday.

The Club is the largest sports club in the area and the largest league club in Canterbury. It provides a positive influence within the low income suburbs of greater Linwood and is a significant and very successful community sport provider that also encourages positive use of Linwood Park for all ages/grades, supporters and the public.

The club is governed by the Board of Directors consisting of seven members, as well as Junior and Senior Football Committees and a dedicated team of coaching staff made up of senior players and parent/caregivers. They operate their provision based on five core values - brotherhood/sisterhood, integrity, passion, pride and family.

Linwood Kea's membership ranges from between 250 to 350 playing members, with up to 200 of those being junior players. They are striving to maintain and grow this player membership post COVID-19 and cost of living challenges currently facing their community. With a high emphasis on whanau well-being and hauora, the Club helps to bring the community together, builds a strong sense of belonging, develops skills, keeps people active, gives people opportunities to volunteer, and meets expressed interests and needs within a low income community with a large proportion of Maori and Pacifica.

They are the only rugby league club in the Linwood area and the largest rugby league club in Canterbury with 16 junior teams and 5 senior teams.

This project is about providing opportunities for youth girls aged from 13-17yrs to participate in active recreation through rugby league. The cost of uniforms is a barrier for many families on top of Club registrations and boots.

We are providing opportunities for active recreation for 3 youth girls' teams in a supportive club environment. Playing in a team will encourage friendships and connection through active recreation. Wearing the jersey of Linwood Keas Club will give a sense of belonging not only to the team, but to the Linwood Community. Playing in a team environment will encourage learning of life skills for collaboration, communication, team work.

Providing first aid kits for all of the teams and educating volunteers on basic first aid will ensure players are safe on the field and well looked after by coaching and management staff in a health and safety space.

The inclusion of the youth girls grades was announced recently by CRL. The Club were unsure what the uptake from within the community would be. The response has been extremely positive and they have been able to fill all 3 grades with youth girls. This has meant that the existing stock of uniforms is not sufficient to meet the needs of the new teams and new uniforms are required. Given the season starts in April the Club have not had sufficient time to seek funding from any other sources.

The rationale for recommending \$6,674 to the Linwood Rugby League Football Club Inc is that:

- The project aligns strongly with the Strengthening Communities Together and Physical Recreation and Sport Strategy.

- It also aligns with Sport NZ messaging to provide more opportunities to engage and retain female youth in sport and physical recreation





#### About local boards and our plans

Community boards were created by the local government reforms in 1989.

Approximately 110 community boards now operate in both urban and rural areas within local authorities throughout New Zealand. They carry out functions and exercise powers delegated to them by their councils.

Local body elections for community board members and councillors are held every three years.

#### The community board's main role is to:

- Communicate with community organisations and special interest groups within the community.





# **Our priorities**

Earthquake Legacy and Transport Projects: Southshore Estuary Edge, QEII Masterplan, Christchurch Regeneration Acceleration Facility and Pages Road Bridge

#### Why this matters:

The community board have received strong feedback from the community that they feel disenfranchised and left behind following the earthquakes. The top priority projects include Pages Road Bridge, Southshore Estuary Edge and the QEII Masterplan.

We have also heard that the community feel vulnerable and at risk in a disaster and that the current roading infrastructure will not provide a safe evacuation route. Both New Brighton Road and Pages Road Bridge provide important routes for the community in both and emergency as well as for day-to-day access and both need to be repaired.

In conjunction with this, the Christchurch Regeneration Acceleration Facility (CRAF) funding provided funds for projects that increase safety and the board would like to see these projects completed in a timely manner.

#### What the board will do:

- Advocate for funding to remain in the Long Term Plan to see the Southshore Estuary Edge project completed and for the preservation and enhancement of the Ihutai (Estuary) as an environmental taonga.
- Collaborate with staff, the community and mana whenua on progressing the Southshore Estuary Edge project through the resource consent process and in the ongoing preservation and enhancement of the Ihutai.
- Advocate for progress on the QEII Masterplan including bringing forward funding where possible to see some projects completed in the next financial year.
- Advocate for the Pages Road Bridge project to be completed as soon as possible and that funding remain in the Long Term Plan to achieve this.
- Advocate for the best solution for the future of New Brighton Road.



- Advocate for planning for Natural Hazards, climate change adaptation and Tsunami Evacuation with prioritisation of delivery of key infrastructure.
- Advocate for progress on the CRAF funded projects in the board area, e.g. Linwood, Woolston, Bromley, and New Brighton.
- Advocate for delivery of Ōtākaro Avon Major Cycleway Route as a key priority and with no delays.

#### We will measure our success by:

- Ensure that the matter is included in community board submissions to appropriate consultations.
- Receive regular briefings and updates on progress of these key projects.
- Ensuring \$100k for planning of Ōtākaro Avon Cycleway is back on the Council budget.
- · See works begin on the ground.

#### **Improve Access to Community Facilities**

#### Why this matters:

The wider community has identified a need for new community-led facilities in the Burwood Ward and expressed this view strongly to the previous community board. Many people who were red-zoned have moved into new developments and the community board agrees there is a gap in the area for the community to be able to access facilities to come together and connect after losing access to facilities following the earthquakes.

#### What the board will do:

There are two opportunities to improve access to community-led facilities in the Burwood Ward:

- The community board will support All Saints in progressing their community facility to completion as this project is in an advanced state.
- The community board will support Marshlands Hall Trust in progressing their community facility in the Prestons area.

#### We will measure our success by:

- · Seeing the All Saints Community Facility completed.
- Support the Marshlands Hall Trust to progress towards commencing a community facility in the Prestons area.

#### Support the Bromley Traffic Project

#### Why this matters:

The community have strongly advocated to the community board that they do not feel safe on the roads in the Bromley area and that they have tragically experienced loss of life, making this a significant priority.

Light industry has increased in the Bromley area, leading to an increase in heavy transport and buses using the residential streets as through ways; further impacting on the amenity of the area and wellbeing of local residents.

Traffic speed creates irritation and hazards for local residents. Bromley was badly affected by the earthquakes, the land is fragile, which creates greater impacts from heavy and speeding traffic on surrounding residences.

Parks and roads maintenance levels of service were lowered during the recovery phase and this has exacerbated the impact of damage in Bromley.

#### What the board will do:

- Continue to advocate for improvements in the Bromley area, including speed reduction, enhanced monitoring and quality control, street planting and visual appeal.
- Advocate for an increase in maintenance to pre-quake levels.
- Encourage citizen participation in decision making and practical projects.
- Advocate for improved public transport service in Bromley.
- In preparation for the LTP, seek to learn lessons from Bromley to apply to other areas (e.g. North Linwood).
- Advocate for and support measures to reduce heavy vehicle traffic on residential streets.

#### We will measure our success by:

- The Local Area Traffic Management Plan is reviewed and outstanding items incorporated into an implementation plan that deals with current issues.
- · Traffic speed in Bromley reduced.
- Resident surveys indicate that local wellbeing and happiness have improved.
- Increased collaboration with Waka Kotahi/NZTA, ECan and other agencies.

#### **New Brighton Mall**

#### Why this matters:

The board has received feedback from the community that the mall has been left in state of decline for many decades and especially since earthquakes. The community provided feedback they'd like to see completion of the Master Plan, by re-establishing New Brighton mall as the centre of the community and an activity centre for the eastern suburbs. A revitalised, vibrant centre will attract people to 'live, work and play' in New Brighton.

#### What the board will do:

- · Support completion of the New Brighton Master Plan
- Support funding to be brought forward from the LTP to make improvements to the New Brighton Public Realm to align with other planned works in 2023 and beyond.
- Support the progression of the Oram Avenue extension, including investigation of all options.
- Advocate for incentives for landowners to care for their derelict premises and sites, and find solutions to get them repaired and leased; support extension of the City Vacant Differential rate to the New Brighton mall by July 2024, or earlier if possible.
- Support delivery of Canterbury Earthquake Appeal Trust (CEAT) project and activation of the Mall through funding for local events.

- Advocate for improved amenities to improve safety, accessibility and public perception of the mall.
- Collaborate with the community, in the development and implementation of a localised Food Resilience Action Plan.

#### We will measure our success by:

- Ensure that these matters are included in community board submissions to appropriate consultations.
- Receive regular briefings and updates on progress of these key projects with clear timelines and deliverables.
- Collaborate with key stakeholders, local businesses, community, CEAT Community Leadership Group, and council to deliver upgrade of the mall as one project.
- Ensuring funding is on budget in the LTP to prioritise delivery of all stages of New Brighton Master Plan.
- · See works begin on the ground.

# Infrastructure / Roading Levels of Service Improved to see issues with roads, footpaths, stormwater and flooding addressed in the board area

The board regularly receives feedback from the community that the quality of the basic infrastructure in the board area appears significantly worse than other areas of the city. Recent events have also highlighted the urgent need for communities to prepare for, and respond to, natural hazard and climate change-driven events, incidences and severity of which forecast to increase. We also know that climate change is not only an environmental issue, it is a social issue because some communities may have less capacity to prepare for, respond to, and recover from climate-related hazards and effects.

#### What the board will do:


- Advocate during the Long Term Plan process for improvements to the levels of service in the board area.
- Prioritise repairs to key infrastructure, wastewater and stormwater systems and drainage, flood mitigation works, pump stations and stormwater pipes to improve resilience.
- Encourage community submissions to the Long Term Plan and Annual Plan processes.
- Encourage and educate the community on the use of the Snap, Send, Solve app for repairs and maintenance.
- Support better strategic planning coordination of work programmes across transport, three waters and parks to ensure efficient delivery and to minimise disruption to community.
- Advocate for an equity lens to ensure adequate funding to build resilience within all of our communities.
- Advocate for Council funding and subsidies for green infrastructure including permeable pavements, rain gardens, gray water reuse, rainwater capture, etc. to help mitigate impacts on households and whānau.
- Advocate for acceleration and timely completion of CRAF and CERF projects.
- Advocate for the resolution and relief of flooding issues in areas where there are particular challenges, e.g. Avondale, New Brighton, and Woolston.

### We will measure our success by:

- Ensure that the matter is included in community board submissions to appropriate consultations.
- Monitor regular Hybris reporting in the monthly Community Board Area Report.
- Increased number of tickets generated and issues resolved through use of the app.
- Improved resident's satisfaction through the annual survey within the board area.

## **Enhancing Environmental Wellbeing**

#### Why this matters:

For people to be healthy, our environment must be healthy. This requires a Ki uta ki tai (from the mountains to the sea) an integrated approach to guardianship and understanding of the inter-connectedness of our natural environment. The community have long suffered from poor air quality in the East of the city, dating back over a century. With the stench from the recently damaged Waste Water Treatment Plant impacting on lives of many people coupled with the longstanding odours emanating from the Organics Processing Plant, the community board have heard strong views from communities on these issues. More recently issues have arisen on the industrialresidential fringe in Woolston with noise, vibrations and impacts to the community's visual amenity, affecting the day to day lives of people. The combined community board covers some of the most ecologically significant habitats and environments, including the Avon-Heathcote estuary which has received international recognition for its importance as a safe haven for scores of migratory bird. The Heathcote Ōpāwaho River has been designated a site of ecological significance. The Ōtākaro Avon River and Ihutai Avon Heathcote Estuary are of vital importance to mana whenua, and regeneration provides a once-in-alifetime opportunity to create a legacy that benefits future generations and mitigate the impacts of climate change.

#### What the board will do:

- The board will strongly advocate for the Organics Processing Plant to be relocated as per the decision made in principle by the Council.
- The board will continue to advocate for the repairs to the Waste Water Treatment Plant to ensure the plant is resilient and does not continue to produce odours that impact on the community.
- The board will continue to work with ECan to improve monitoring of odours, noise, air and water quality in the East.
- The board will continue to advocate for a timely resolution to the issues impacting the community from the industrial-residential fringe and for any needed planning changes needed to land use rules.
- Improving health of our waterways, is a top priority focused on restoration and improving habitats for indigenous plants, animals and mahinga kai/mahika kai.Support protection of the Avon-Heathcote Estuary Ihutai Estuary as a top priority.
- Supporting the Opawaho/Heathcote River by advocating for the implementation of the Lower Heathcote Öpäwaho River Guidance Plan.
- Raising awareness and supporting enhancement of the Püharakekenui (Styx) River catchment and its environs including its ecology, drainage, landscape, culture, heritage and recreation values.
- Support delivery of the Ōtākaro Avon River Corridor Regeneration Plan acknowledging the significant opportunity it plays by enhancing positive community wellbeing, building connection and improving resilience.

#### We will measure our success by:

- Funds being retained on budget for the Organics Processing Plant to be relocated.
- Receiving regular updates and information on the progress being made at the Waste Water Treatment Plant.
- Funds being allocated specifically towards projects detailed in the Lower Heathcote Ōpāwaho River Guidance Plan, including through an Activity Management Plan within the LTP.
- A plan change approved by Council to better regulate/ control industrial activities in close proximity to residential areas.
- Receiving regular monitoring updates from ECan on reported odours etc. in the East.
- See a decrease in complaints from residents about odour and midge activity.
- Support funding for a dedicated Estuary/wetland Ranger in recognition of the special ecological values of these areas.
- Support funding for initiatives to improve health of waterways and biodiversity by reducing contaminants and pollution and reducing sediment in river/ wetland environments; increasing riparian planting; prioritisation of delivery of stormwater and flood management basins.
- Work with community to identify and develop positive social and recreational spaces for the community across the board area.
- The Estuary is better protected from disturbance from dogs, with better signage and compliance with bylaws.

### **New Brighton Safety Initiatives**

#### Why this matters:

Coastal Brighton is seeing an increase in homeless, vulnerable and at-risk tangata within those communities. Businesses have expressed concerns for their safety when opening and closing, and there have been incidents of verbal and physical assaults. People are increasingly concerned for the safety of their whānau and are reporting more break-ins, thefts and anti-social behaviour.

#### What the board will do:

- Advocate for incentives for landowners to care for their derelict premises and find solutions to get them repaired and leased.
- Support local events aimed at bringing the community together through funding streams.
- Build relationships with other Government agencies who can offer support services for at-risk tangata in emergency and alternative housing.
- Support engagement with youth sector in the development of activities and recreational spaces for our tamariki in the mall, and key activity areas across the ward including Parklands.
- Meet regularly with key agencies to discuss appropriate and timely response to safety issues.
- Support the re-establishment of the communityled group which supports regeneration of the mall, builds social capital and advocates for businesses and residents in the Greater New Brighton area.
- Investigate and fund safety initiatives in the New Brighton CBD through environmental design; investigate funding for security patrols; urban design initiatives; provide information, resources and support to local businesses and residents to improve safety.

#### We will measure our success by:

- A community-led group advocating for the mall, such as a Business, or joint Business and Resident's Association is established and meeting regularly.
- Wrap-around social services are provided for emergency and alternative housing in the area.
- Decrease in the amount of derelict buildings in commercial centres of Brighton suburbs.
- New ideas for local events and activations are funded.

### Aranui / Wainoni Safety Initiatives

Activating key community assets which have been underutilised for years with diverse activities catering for a wide range of community will see improved wellbeing and a great sense of community.

#### What the board will do:

- Support the activation and community management of the Aranui-Wainoni Community Centre.
- Explore and investigate opportunities for wider use and activation of Wainoni Park by local community organisations and groups.
- Support the Streets for People project in Aranui.
- Partner with key local organisations who work with tamariki and rangatahi to provide opportunities for pro-social activities and events.
- Promote and encourage greater use of the Snap, Send, Solve app.

## We will measure our success by:

- Increased hours of usage at the Aranui-Wainoni Community Centre with a more diverse range of users booking the facility.
- Directly sponsor and support collaborative projects that aim to activate and increase usage of Wainoni Park.
- Increased number of tickets generated and issues resolved through use of the app.

# **Woolston Village Safety Initiatives**

#### Why this matters:

Post-earthquakes, Woolston Village has seen investment and revitalisation but recently there has been a spike in anti-social behaviour, alcohol and drug-related incidents, and a decline in a sense of safety among business-owners and their customers due to loitering, intimidation, and harassment.

#### What the board will do:

- Support initiatives to activate public spaces with a view to discouraging the anti-social behaviour and street begging.
- Build relationships with other Government agencies who can offer support services for at-risk tangata in emergency and social housing.
- Meet regularly with key agencies to discuss appropriate and timely response to safety issues.
- Build relationships with local residents and business.
- Support local residents and businesses to collaborate for the common good of Woolston Village and the wider suburb.

#### We will measure our success by:

- Regular collaboration meetings of community and businesses are established with support from the board.
- Community board have granted funding towards activation projects for the Woolston Village shops and Library.
- New ideas for local events and activations are funded.
- The temporary alcohol ban is evaluated and altered accordingly.
- There is an improvement is the perception of safety within Woolston Village.

# **Community board funding**

In Christchurch, community board funding is allocated to each board based on population and equity. The NZ Deprivation Index is the tool used to measure the equity portion of the allocation. The Council uses the formula of 60% population and 40% equity when determining the allocations to each board.

The community board has four funding schemes available for allocation each year:

#### **Strengthening Communities Fund**

An annual contestable funding round – opens in March/April each year. Provides funding for the period of 1 September to 30 August each year.

The purpose of this fund is to support communityfocused organisations whose projects contribute to the strengthening of community wellbeing in the Christchurch city area.

Successful organisations will be those which demonstrate they are sustainable, strategic, community-focused groups which have a significant presence within their community of benefit. Successful projects will also clearly demonstrate their contribution to the council's funding outcomes and priorities. Organisations must be able to demonstrate their ability to contribute towards their project(s) and not rely on council funding as their sole source of funding.

# **Discretionary Response Fund**

Open for applications all year - 1 July to 30 June.

The purpose of this fund is to assist community groups where the project and funding request falls outside other council funding criteria and/or closing dates. This fund is also for emergency funding for unforeseen situations.

Community board projects (events and awards) are also funded from this fund.

### Youth Development Fund

The purpose of the Youth Development Fund is to celebrate and support young people living in the Waimāero Fendalton-Waimairi-Harewood Community board area by providing financial assistance for their development. The community board also seeks to acknowledge young people's effort, achievement and potential excellence in the community.

The community board will consider applications for the following activities:

- Personal Development and Growth For example leadership training, career development, Outward Bound, Spirit of Adventure, extra-curricular educational opportunities.
- Representation at Events Applicants can apply for assistance if you have been selected to represent your school, team or community at a local, national or international event or competition. This includes sporting, cultural and community events.

### **Koru Fund**

The Koru Fund would is a funding avenue from which community can access up to \$500 to help fund a project or initiative, removing the barrier of a more official and lengthy application process. The process involves a simple one page application form which included a few details on what the idea was about. This then gets processed and e-mailed to two selected members of the community board for approval. A two day turn-around from submitting the application to getting approval would enable community to get started straight away on making their idea happen and allows Council staff to be more flexible and responsive to issues that arise in the ward area.

# Glossary of terms used

### Avon Otakaro River Corridor Regeneration Plan

Regenerating the 602-hectare Ōtākaro Avon River Corridor is a one-in-a-lifetime opportunity to create a legacy that benefits future generations. Stretching from the city to the sea, the 11km regeneration area contains streets, lawns and gardens that used to make up people's properties.

#### Christchurch Earthquake Appeal Trust (CEAT)

The Christchurch Earthquake Appeal Trust (the Trust) is responsible for the allocation of the money raised by the Christchurch Earthquake Appeal to support earthquake recovery initiatives.

# Christchurch Regeneration Acceleration Facility (CRAF)

The Christchurch Regeneration Acceleration Facility (CRAF) investment in roading and transport improvements will act as a catalyst towards the development of a high-quality, safe and reliable transport network that will improve connectivity and the customer experience across Christchurch City. It will improve safety outcomes and encourage more people to walk, bike or catch public transport.

# Climate Emergency Response Fund (CERF)

In 2021, the Government announced the establishment of a new 'Climate Emergency Response Fund' (CERF). The fund was set up with an initial \$4.5 billion 'down payment' for Aotearoa New Zealand's climate spending, proportional to the proceeds of the Emissions Trading Scheme

#### Ihutai

The Avon Heathcote Estuary/Ihutai is a large shallow estuary located on the eastern fringes of Christchurch City. It is separated from the Pacific Ocean by a 4.5 long sand spit that forms the triangular shape of the estuary. The estuary contains fresh water from both the Avon River/Ōtakaro and Heathcote River/Ōpāwaho, and salt water from the ocean.

### Lower Heathcote Ōpāwaho River Guidance Plan

This guidance plan is the result of extensive collaborative partnership and consultation between the Linwood Central Heathcote Community Board, Christchurch City Council staff, the community and organisations with an interest in the lower Ōpāwaho Heathcote River. The plan is a living and enduring framework to support and enhance the long-term sustainability of ecology and biodiversity in the area, reversing the damage or restoring the ecosystem after decades of degradation from a wide range of sources.

# 1. Purpose of Report Te Pūtake Pūrongo

1.1 The purpose of this report is to present the Community Service and Youth Service Award 2023 nominations to the Waitai Coastal-Burwood-Linwood Community Board for consideration.

# 3. Context/Background Te Horopaki

# Issue or Opportunity / Ngā take, Ngā Whaihua rānei

- 3.1 The Christchurch City Council created Community Service and Youth Service Awards as a way to thank and honour those who, by their demonstrated commitment and example, inspire others to engage in volunteer service. Recognising and honouring community-focused initiatives sets a standard for service, encourages a sustained commitment to civic participation, and inspires others to make service a central part of their lives.
- 3.2 There has been promotion of the awards scheme through Council media releases, local newspaper advertisement and the Council's social media networking avenues. In addition local community groups, including residents' associations, have been sent information seeking nominations for Community Service and Youth Awards for 2023.
- 3.3 The service undertaken should be of a voluntary nature. A paid employee may be eligible where the work undertaken is beyond the scope of that person's normal job description and the nominee has spent some of their own non-work time in the project. In this circumstance either one of the nominators should be an employer who states that the work is outside of normal work or a supporting letter supplied from an employer stating the same. Please find the Guidelines information attached (refer **Attachment A**).
- 3.4 People will be eligible for Community Service Awards in the area that they do the work in, however, if the work is for a metropolitan organisation that covers more than two Board areas then the nomination shall be considered in the community board area that the nominee does the majority of their voluntary work.

- 3.5 Service recognised may include work in the following areas: youth, older persons, education, cultural, church, recreation, sport and community service sectors.
- 3.6 Individuals shall be eligible to receive only one Community Service Award for the same voluntary work.

Details of such nominations may be received as late applications for consideration. Bearing this in mind the Board may wish to put in place measures to meet this contingency. # Community Service Awards 2023

# Nomination guidelines

# Community Service Awards are awarded to individuals and groups in recognition of significant voluntary service.

#### PLEASE NOTE

Participating Community Boards this year are Waihoro Spreydon-Cashmere-Heathcote, Waipuna Halswell-Hornby-Riccarton, and Waitai Coastal-Burwood-Linwood

Community Boards *not* participating this year are Te Pātaka o Rākaihautū Banks Peninsula, Waimāero Fendalton-Waimairi-Harewood, and Waipapa Papanui-Innes.

Youth Service Awards\*: Community Boards participating this year are Waihoro Spreydon-Cashmere-Heathcote, Waitai Coastal-Burwood-Linwood and Waipuna Halswell-Hornby-Riccarton

- The service undertaken should be of a voluntary nature.
   A paid employee may be eligible where the work undertaken is beyond the scope of that person's normal job description and the nominee has spent some of their own non-work time in the activity. In such a case, one of the nominators should be an employer of the nominee, who states that the nominee's work/activity went beyond the requirements of routine work by providing a supporting letter to that effect.
- The Community Service Awards recognise voluntary efforts in the following areas: youth, older adults, education, culture, church, recreation, sport, community service fields.
- People will be eligible for Community Service Awards in the area/suburb that they do the work in. If the work is for an organisation that covers more than two board areas, then the nomination shall be considered in the board area that the nominee does the majority of their voluntary work.
- Nominations must be submitted on the official nomination form that is available at ccc.govt.nz/csa
- The nomination form must be signed by two nominators and both nominators should be aware of the details of the nomination.

- Any community organisation, club or society may make a nomination. Two executive officers of the organisation should sign the nomination and record their title of office.
- Letters of support or evidence supporting the work can also be submitted with the nomination. It is highly recommended to supply as much detail as possible to support the nominations. Length and type of service is particularly helpful.
- The more information you are able to supply in support of the nomination, the greater the assistance for the community boards in assessing the nominations.
- The length of voluntary work shall be considered alongside the nature of the work undertaken.
- Community Service Award nominations are considered and decided by community boards.
- Individuals shall be eligible to receive only one Community Service Award for the same voluntary work. This does not apply if a recipient has received a Youth Service Award.
- Community Service Awards are presented to recipients at functions hosted by the local community boards.

\*Youth Service Awards are presented by the Waihoro Spreydon-Cashmere-Heathcote,
Waitai Coastal-Burwood-Linwood and Waipuna Halswell-Hornby-Riccarton Community Boards
only, in recognition of significant voluntary service carried out by residents aged 25 years or under.
These awards are to recognise individual effort rather than that of a whole group or organisation.



# 3.1 **Community Funding Summary**

3.1.1 For the Board's information, a summary is provided (refer **Attachment A**) on the status of the Board's 2022-23 funding as at April 2023.

# 3.1.2 Koru Fund

Board members with the delegation for the Waitai Coastal-Burwood-Linwood Community Board Koru Fund (Alex Hewison, Tim Baker and Jackie Simons) made two decisions under delegation:

- A grant of \$500 from the 2022-23 Waitai Coastal-Burwood- Linwood Koru Fund to Christchurch Methodist Central Mission towards the costs of delivering the Upcycling and clothing swap event they are running as part of Youth Week 2023.
- A grant of \$500 from the 2022-23 Waitai Coastal-Burwood- Linwood Koru Fund to the Bridge South Brighton Trust towards the costs of delivering the Create a Space event they are running as part of Youth Week 2023.



3.1.3 La Vida Youth Trust received \$5,000 from the Waitai Coastal-Burwood Community Board's Discretionary Response Fund in June 2022 to launch their new youth drop-in space. Conveniently just down the road at the Avonhead Girls and Shirley Boys High School QEII Campus on Atlas Street, over the last school term they've had a regular core of around 30 rangatahi attending each week on Friday afternoons. After taking a break over the school holidays the drop-in centre will be open again for Term 2.









3.1.4 **Kainga Residents Association** held their Community Day on 26 March at Kainga Park. The event was organised for the residents of Kainga, Stewarts Gully and Riverlea. Featuring a sausage sizzle, lawn games, a candy floss machine and bouncy castle around 50 people went down to the park to enjoy the festivities. A few of the residents also brought surplus produce from their gardens, instigating and kai swap and share. The group received \$500 from Waitai Coastal-Burwood-Linwood Community Board's Koru fund towards delivering this inarguable event. The organising group have received lots of positive feedback about the day with residents asking to make it an annual event.









## 3.1.5 Easter Whānau Fun Day

He Waka Tapu received \$500 of funding from the Waitai Coastal-Burwood-Linwood Community Board's Koru Fund for this event held on Saturday 1 April at He Waka Tapu – an Easter theme Whānau Fun Day.



The following report was received:

Our first Saturday, Whānau "Easter" themed Fun Day event for 2023 was a huge success with an overwhelming attendance of over 250 people from the Eastside community. Given the weather was a disappointment it did not stop whānau from attending.

The event started at 9am running through to 2pm, providing the community with free stations of; sausage sizzles, water, colouring in, harakeke, bouncy castle, table tennis, Face painting, a Challenge Stall for community to win either a shirt, book or an Easter Egg and of course The Mobile Animal Farm which was support by Christchurch City Council. The colouring in station had over 150 completed drawings, the Harakeke station was a great opportunity for our community to reconnect in Te Ao Māori, to then learn the step-by-step process in making a putiputi (flower) to a paki. The mobile farm provided various animals such as chickens, guinea pigs, rabbits, geese, lamb, sheep and a pony. It was a great experience for whānau, providing an alternative option for tamariki who may want to engage in a calmer environment.

There was positive feedback and recommendations for our future events, here are a few highlights:

"Mauri Ora He Waka Tapa for putting on an awesome event for Whānau/community. My Whānau loved learning new skills by weaving putiputi, getting their own Ta Moko, enjoying the bouncy castle, feasting on a few sausages and also going away with a prize that my daughter had won. Considering the wet weather, the team did a phenomenal job and keeping the environment safe, fun, interactive and well organised. Ngā mihi nui".




"He Waka Tapu Whānau day was amazing! Thanks to the awesome staff who dedicate their time & Aroha to their community, my 5 tamariki loved every bit! They wanted a tāmoko like Dad, do the colouring in to get some Easter eggs, our baby girl loved the animals! Despite the wet weather, the organizing of the event was awesome. We look forward as a whanau to go to the next one ""."

"Was such a fun day, a bit crazy because of how packed and busy it was.. but I get that since it was raining! I loved how the sausage sizzle was free and how there was a lot for my children to do and even for myself. The animals were great! My daughter spent most of her time there, holding the chicken! Was her highlight of the day."

Our main purpose for the Easter Whānau Fun Day was to provide for our community, enabling whānau to have fun, attend at no cost, creating an environment of barrier free. We also provided this as the alternative 'give back' option for kaimahi partaking in our 4 Day working week incentive, meaning 100% of pay, for 80% of the time in exchange for 100% productivity.

Going forward we plan to ask whānau to complete surveys. This will enable He Waka Tapu to receive feedback ensuring these events are relevant for our community.
























- 3.2 Participation in and Contribution to Decision Making
  - 3.2.1 Report back on other Activities contributing to Community Board Plan [for items not included in the above table but are included in Community Board Plan]
    - Parklands Youth Drop-in Centre Update

The Parklands Youth Drop in Centre began in March two days a week based at the Parkview Lounge. The Youth drop-in Centre has been going really well, with a regular number of 10-15 youth attending. The programme ran through the April school holidays to provide some consistency for the youth. The Parkview Lounge is being refurbished from the 11-31 May so the programme will move on those days either to outdoor venues i.e. local parks or other local venues. They will also be joining the Youth Week in the East range of events between 15-21 May to offer a Disc Golf have a go day at the Queenspark Reserve.

• The Bridge Hub have organised for Te Reo Māori beginners courses to be run from their facility starting Monday 8 May for 6 weeks. They are offering two separate evenings, 5-6pm Monday and Wednesday their Kaiaki (tutor) Fern will be delivering for those with absolutely no experience and the other course for those with some experience.





• **Le Maota** invited the Census Stats NZ team to come down to their TALANOA + ACTION evening on Thursday 13 April 2023. *Let's Get Counted* was an opportunity for people to head along to Le Maota, meet the team and get help to complete the Census. With Pacific food and music on offer and prizes to be won, the hub was a hive of activity.

La Maota runs TALANOA + ACTION workshops every 2<sup>nd</sup> week on Thursday nights to help Pacific and Māori communities' access services, information and get support. For each session a different agencies, organization or service are invited to come and share information about what they can offer. Since Le Maota opened its doors in February they have hosted Pacific Energy Talanoa, Vanuatu Community Presidents and the Census Stats NZ team.











Climate Action Campus have just developed a new 'bug area' at their site at the
former Avonside Girls High School in the Red Zone. Provided by Christchurch City
Council's Environmental Education Team, the bug area will be used for teaching
about the importance of insects in growing kai, including worm farming.

The Climate Campus is a satellite of Ao Tawhiti School supported by the Ministry of Education. It aims to show young people ways in which they can directly take action to help mitigate climate change. The Campus offers lesson on bee-keeping, rearing chickens, growing kai and much more.

On 18 April, the former gym Annex was demolished, making room for more garden beds and teaching space which will enable the Campus to further expand their enterprise.

Te Whare Taonga O Ngā Iwi Katoa have partnered up with Para Kore to deliver **Upcycling & Ngā Rawa Māori Wānanga** workshop as part of Ōtautahi Learning Days Festival on Wednesday 10 May from 2-3pm at Linwood Resource Centre. Participants can make their own mini herb planters using up cycled materials and herbs grown in the community garden.

# Fiji Holi

Holi has always aimed to promote unity in Christchurch and is built on the traditional themes of forgiveness and togetherness. Fiji Holi 2023 held on 12 March 2023 held at the Parklands Community Centre and was organised for the first time by Sanatan Mahila Mandal Christchurch, a trust formed by women and run by women. These are the women who want to celebrate their community events but due to cultural differences they are or other women are not confident enough to do so. This event was an effort to bring all these families together and focus on building understanding of different cultures in Christchurch through showcasing traditional performances, food, games and stories.

#### Feedback received:

Keeping in mind the important learnings from this experience we have already started working on our future events. We thank Christchurch City Council for all the support. Playing colour and dance performances from different cultures was the main highlight of the event.







The Walking Festival (8-23 April 2023)
 Bringing together more than 55 walking events for people of all ages and abilities to explore, learn and connect across Ōtautahi, Selwyn and Waimakiriri.

11 of the 57 walks were located in the Waitai Coastal-Burwood-Linwood ward area, walk events are hosted by a range of partners, community organisations located in our ward area including He Waka Tapu, Eastern Community Sport and Recreation, The Pukeko Centre, Dallington Residents Association, as well as Council's Park Rangers. The Festival began in 2012 in the East of Christchurch and quickly grew to a Canterbury-wide event including walks in the Selwyn and Waimakariri districts.

Some highlights from this years Festival was a new walk hosted by Lily Peas Blossom and her fairy friends at Bottle Lake Forest Discovering the Fairies with close to 300 families enjoying a range of fairy activities and exploring the forest.







A Walk in time: Te Riu o Te Aika Kawa, one of the 57 walks as part of the Walking Festival 2023 was held the morning of Friday 14 April. Led by Christchurch City Council's Rangers Robbie Hewson and Warren Hunt, participants enjoyed taking a step back in time to see what Ōtautahi would have looked like pre European development walking the 3.5km stretch of the Lagoon Track between Brooklands and Spencerville. With lots of stops along the way to explain about the restoration work, participants also learned about the many species of birds feeding and nesting in the salt marsh environment the unique plants which grew there.

#### INTRODUCTION

The Waitai Coastal-Burwood-Linwood Community Board appreciates the opportunity to make a submission to the Christchurch City Council on the Draft Annual Plan 2023-24.

The Board wishes to be heard in support of this submission.

The Board commend staff and Council for a practical response to a significant change in macroeconomic conditions, but express concern that there will be little headroom in financial year 25-26 and delaying hard decisions using one-offs will mean the Long Term Plan will likely be fraught.

#### SUBMISSION

 What do you think of our proposed average rates increase of 5.68% across all ratepayer (which is higher than the 5.42% signalled in the Long Term Plan 2021-31) and an average residential rates increae of 5.79%?

The Board acknowledges that the rates increase will come as a shock to many households even though it is below the level of inflation. The effects of re-evaluation and resulting redistribution of the rates burden will be felt particularly in the East of Christchurch.

Do you have any comments about our proposed changes to revenue, spending and borrowing?

The Board is concerned about the lack of headroom in financial year 2026 and would not want to see any revenue-generating assets sold, or partially sold, to get over the bump in the road.

- 3. We want your feedback on our proposed alternatives for how we set the Uniform Annual General Charge (UAGC) – what do you prefer?
  - Our proposal (A): Our current proposed UAGC of \$153 in 2023/24. This is in line with the current proportion of your rates bill that forms the UAGC, and is in line with the overall rates increase.
  - The alternative (B): Setting the UAGC at a lower value of \$50, reducing the overall rates on properties with a lower capital value, but leaving a \$17 million shortfall in the Council's rates take, which would need to be made up by other ratepayers.

The Board asks if the Council could consider more measures to provide relief for people on low income, apart from the existing rates rebate scheme.

#### **Donnell Park Pathways**

#### 1. Purpose of this Memo

- 1.1 The information provided in this memo has been written to inform the Waitai Coastal-Burwood-Linwood Community Board on the Parks Unit response to the Burwood East Residents Association Committee (BERA) request for the pathways located at the Kingsbridge Drive end of Donnell Park to be repaired or replaced.
- 1.2 The information included in this memo is not confidential and can be made public.

#### 2. Update

- 2.1 The main areas of concern for BERA are related to unsafe footpaths, grass berms overtaking the pathways, uneven surfaces, broken seals and raised sump housing.
- 2.2 Information provided by the Parks Unit states that the pathways were last reviewed in 2018 with the condition rated as poor (4). See Asset Renewal Scope Hard Surfaces Attachment A.
- 2.3 The Residential Red Zone team, have reviewed the site, and created a Path Renewal and Ecological Improvement plan Attachment B. Expected works to happen in financial year 2023 (FY23).

#### 3. Conclusion

- 3.1 After further discussions between the Residential Red Zone team and the Storm Water team, repair works are expected to occur in FY23 through the oversight of Dave Little, Residential Red Zone Manager.
- 3.2 BERA have been informed by Community Partnerships Ranger, Annaliese Caukwell-Mills, of the plan to only repair one path leading from Kingsbridge Drive into Donnell Park in FY23, whilst the other two paths will be removed and planted in FY23/24 for ecological reasons that are in line with the Ōtākaro Avon River Corridor Plan.
- 3.3 BERA have confirmed that they accept the approach outlined in the Path Renewal and Ecological Improvement plan going forward.
- 3.4 Based off BERAs acceptance, the Red Zone Team will proceed with the works outlined in the attached plan.





# Rawhiti Domain - upcoming stakeholder engagement on sports lighting

#### 1. Purpose of this Memo

- 1.1 The purpose of this memo is to advise the Waitai Coastal-Burwood-Linwood Community Board of key stakeholder engagement coming up soon for a proposed track and field lighting upgrade on Rawhiti Domain.
- 1.2 Information in this memo is not confidential.

#### 2. Update

- 2.1 New Brighton Olympic Athletics Club Incorporated have made an application to upgrade the track and field lighting at Rawhiti Domain.
- 2.2 Three existing lighting poles have not been operable over the last two years so these lights will be removed. The proposal is for eight new light towers approximately 14 metres in height.
- 2.3 The new lights will provide improved illumination for winter evening training sessions on Tuesdays and Thursdays between the hours of 4.30pm and 9.00pm.
- 2.4 The applicant will be responsible for all costs associated with the installation, insurance, operation, maintenance, and any future removal, of the proposed lighting system.
- 2.5 The applicant is also responsible for acquiring all appropriate resource consents once they have Community Board approval to replace their lights.
- 2.6 The proposed lighting illumination plan has already been assessed by staff:
  - 2.6.1 The Council's Environmental Health Team found the application compliant with the District Plan Outdoor Lighting rules 6.3.6.1 for glare and light spill.
  - 2.6.2 The Building Consent Team's initial assessment indicates that a resource consent may be required for setback 18.4.2.2 and height rules 18.4.2.4 in the District Plan. The applicant has been informed they will need to apply directly to the Planning and Consents Team for those after they have Community Board approval to replace the lights.
- 2.7 Council staff will engage with key stakeholders on this proposal during May 2023. In keeping with the scale and significance of the proposal, the engagement process will include notification of other lessees and key users of Rawhiti Domain, and the immediately adjoining residential properties to the west of the athletic track.

- 2.8 On completion of engagement, staff will submit a report to Community Board for approval of the proposed new lighting which is likely to be June/July 2023.
- 2.9 The Rawhiti Domain aerial photo below indicates the approximate location of the eight proposed new light towers in red.



#### 3. Conclusion

3.1 Staff will commence with key stakeholder engagement on the proposed track and field lighting upgrade on Rawhiti Domain during May, and report back to the Community Board once this has been completed.
