# 3. Community Public Forum - Coleridge Street Parking

#### **Coleridge Street Parking**

Shaun Rolston of Happy Hire spoke to the Board regarding Coleridge Street parking and requested that the two parking spaces directly outside his business be restricted to P30. Mr Rolston discussed the safety issues when vehicles are double parked.

After questions from Board members, the Chairperson thanked Mr Rolston for his presentation.

The meeting was closed at 4.10 pm and reopened at 4.11 pm as a member of the community had arrived to give a Community Public Forum to the Board.

### 4. Community Public Forum - Microwave Tower and Vandalism

#### **Microwave Tower and Vandalism**

Jennifer Barrer, local resident, spoke to the Board regarding the microwave tower located next to a park and where Ms Barrer lives (within 100m) in Cashmere. The microwave tower was only allowed to be placed where it is on the provision that the Barrer property was protected by trees. Those trees have now been removed. Ms Barrer would like to see the microwave tower move further uphill away from residential properties.

Ms Barrer also discussed the vandalism that is occurring at 10 Barrer Lane and invited a Board member to visit the site.

After questions from Board members, the Chairperson thanked Ms Barrer for her presentation.

That the Waihoro Spreydon-Cashmere-Heathcote Community Board refers the issues raised about the microwave tower for staff advice.
