8. Greening the East - Approval for Tree Plantings and Parking Changes Project

Board Consideration

The Board received the attached presentation from staff at the meeting, and considered the deputation from Anna Melling on this item, having regard to her views, and those of other the submitters, before resolving to accept the Officer Recommendations only with update from staff around the tree species recommended to be approved incorporated into the first two resolutions.

 - b. the parking of motor vehicles be restricted to a maximum period of three minutes between the times of 8:15am and 9:15am, and between 2:30pm and 3:30pm, on school days only on the north-western side of Grants Road, commencing at a point 140 metres north-east of its intersection with Papanui Road and extending in a north-easterly direction for a distance of 49 metres.

 - The Council's Residents Survey results have been briefed to Councillors ahead of release.
 - The Council is holding hearings in regard to the city wide tranche of Safe Speed Neighbourhoods that were consulted on.
 - The upcoming AGM for Neighbourhood Trust.
 - Community acknowledgement of the great job on the St James Park path renewal work.
 - Ticket logged by resident in respect of Paddington Reserve sporting amenities.
 - Connection made with Norwest Sport and Community Hub.
 - Councillor resident meetings well attended, highlighting Snap Send Solve app.
 - That a resident with insightful enthusiasm around seeing more tree planting within cycleway designs, offered advice of the opportunity to feed into the Annual Plan and Plan Change consultations.
 - Anti-social driving behaviours observed by residents around Farquhars Road, St James Ave and Harris Crescent.
 - Discussion with Engagement about large print option for Long Term Plan engagement.
 - That the hard surface for cycling around Redwood Springs comes to an abrupt end in the vicinity of the CNC, with residents' interest in its extension.

The suburb of Mairehau was also named for Rose in 1916 after Rose Rhodes married George Hutton with the announcement serving as inspiration for the district, along with the Rhodes family's local influence.

Alternative Names

- 3.14 <u>Jackman Place</u> The Jackman family owned a large property in Innes Road. Their land was later subdivided, and three streets formed.
- 3.15 <u>Hutton Place</u> Rose Hutton nee Rhodes was the daughter of Arthur Rhodes. The Rhodes family owned land in the Marshland area.



Disc Golf supports a player's physical health and wellbeing, providing upper and lower body conditioning, aerobic exercise, and promoting a combination of physical and mental abilities that allow very little risk of physical injury.

Concentration skills increase by mastering shots and negotiating obstacles.

Players of limited fitness levels can start slowly and gradually increase their level of play as their fitness improves.

Staff Assessment

Christchurch Disc Golf Club (CDGC) is a Charitable Trust whose purposes are to promote, maintain, and develop the sport of Disc Golf. A sport that can be played from school age to old age.

Being such an easy sport to learn, no one is excluded from the opportunity to take part in a mainstream activity; players merely match their pace to their capabilities and proceed from there. Disc Golf is played much like traditional Golf, however instead of a ball and clubs, players use a flying disc, and throw it at elevated metal baskets.

CDGC established a Disc Golf course in Jellie Park in 2015. It was very successful and regularly gets 300-500 players on a busy Sunday. To increase participation across Christchurch, in 2021 they received permission from Christchurch City Council to install new courses in suburban parks close to residential areas.

CDGC are seeking funding towards replacing nine baskets at the 18-hole Disc Golf course at Jellie Park, due to theft (one basket was stolen), wear and tear, and vandalism.

Rationale for staff recommendation:

The project aligns strongly with the Physical Recreation and Sport Strategy Goal 1. Facilities and Environment and Goal 2. Availability and Accessibility.

The grant will directly impact the provision of essential facilities and services needed to participate in the sport.

CDGC is continuing to actively promote Disc Golf in Christchurch and New Zealand, to encourage people of all ages, genders, and fitness levels to be involved, bringing communities together, and benefitting individuals with improved health and wellbeing.

There is a huge potential for participation in Disc Golf, the ease of access to play and low cost makes it an activity that people all ages, genders and abilities can participate in and support.

This project increases the capacity of the Club to deliver quality recreation experiences for the children, youth and adults.

Nomads United Association Football Club Inc (Club) was established in 1910 making it one of the oldest football clubs in the city and membership has grown to 1043 players, with nearly 100 teams and over 140 volunteers who donate more than 3,700 hours each season for the benefit of the Club and members.

Project 1: Despite such a large membership base, girls and women currently only make up approximately 20% of the membership. This year the FIFA Women's World Cup Australia and New Zealand 2023 will shine a spotlight on Women's football in Aotearoa and the Club is excited at the opportunity to promote the sport to more girls and women than ever. It is for this reason that the Club is seeking funding support towards the payment of the girls' youth and women's coaches.

Guided by experienced and motivated coaches, the Club will be able to provide community-based programmes which enhance basic life skills in young girls. Through sport they will learn discipline, how to cooperate, listen to others, and allow them to make new friends and increase their social circle beyond their school connections.

Project 2: The clubrooms at Tullet Park offers members a place to belong and connect with their local community. The onsite bar run by volunteers is also a great fundraiser for the community to generate further funds which allows the Club to improve the facilities and resources.

Recently the dishwasher at the clubrooms stopped working and to ensure the health and safety of patrons the Club needs to be able to thoroughly clean the glassware before use at the clubrooms. This was an unexpected expense for the Club, it was not included in the budget for this season.

The Club's volunteer Funding Officer has recently stepped down and due to various other unforeseen circumstances, the Club missed the opportunity to apply for the Strengthening Communities Fund and it is for this reason they are applying to the Board's Discretionary Response Fund.

Edgeware Croquet Club (the Club) is a small club based in St Albans Park. The Club has been in existence since 1913 and currently has twenty-two members. The average age of club members is approximately 75 years old. The numbers have declined over the last few years and have correlated with the COVID pandemic. As things get back to normal, the Club intends to run promotional fun days and open days to increase their profile and hopefully attract new members. The Club competition days are Thursdays and Saturdays.

The Club has three croquet lawns and a small historic clubhouse. A significant ongoing cost for the Club is the maintenance of the clubhouse and lawns to keep them suitable for playing. The Club members spend approximately eight hours a week during the season to ensure the lawns are in good playing condition, however their ability to conduct maintenance is reducing because of age, disability and the small pool of members to call on.

The Belfast Sports and Community Centre Inc. (the Club) is based at Sheldon Park. The clubrooms provide a community hub and are the administration arm for Belfast Rugby Football Club and Belfast Touch. The Club has a close association with Waimak Gaels Gaelic Football Club, Rotary Club of Belfast/Kaiapoi and the Eclipse Marching Club. This year the Club has approximately 207 Juniors and 68 Seniors registered to play rugby, these players are complemented by 17 volunteers including Junior Rugby Coaches and Managers, Belfast Junior Rugby Committee members, and the Belfast Rugby Open Grade Coaches and Managers. Player registration income is directed towards replacing training and playing equipment. Subscriptions are kept to an affordable level for families.

The Club kitchen and the oven are vital for the delivery of hot food, for after match and club functions and for use by other local organisations. The kitchen is used by open grade rugby teams, visiting rugby teams, Rotary Club, Belfast touch modules, and the Belfast Netball Club. The purchase of a new oven would improve the preparation of food and meals for all who use the Club. The present oven is 15 years old, has been repaired three times and is not working well.

The Club is also seeking support for its volunteers via a request towards volunteer recognition. The amount of time, mileage, expertise, advice and mentoring to young players is vitally important to the Club and to the wider community.

Staff Assessment

The Christchurch High School Old Boys' Old Collegians Cricket Club (the Club) was established in 1977 and is located at Elmwood Park and is a member of the Elmwood Club Sports Hub.

The Club are seeking funding assistance towards coaching expenses for their coaching and development programmes.

Their coaching, development, and competition programme encompass supporting 55 junior teams with training and match play, school taster sessions, the Have-a-Go programme, Kiwi Teams coaching and training, the Schools Link Programme and Women's Club coaching.

The Albion Softball Club (Club) was established in 1984 and Incorporated in 2004, the Club aims to promote, foster, and develop the game of softball. Its home ground is located at Middleton Park. Previously, the Club used the Riccarton Workingmen's Club as their clubrooms but following their sale, they no longer had dedicated facilities.

To address this, the Club has partnered with Shirley Rugby League to establish its clubrooms there. This collaboration is beneficial as it allows opportunities for sharing resources and attracting new members.

Last season the Albion Softball Club consisted of one premier team, five senior teams, and one junior team. To support this project and maintain effective club operations, the Club is applying for assistance for support with accountancy, administration services and volunteer recognition.

A significant portion of the Club's membership comprises individuals from low-income families who often face difficulties in paying subscription fees. Supporting this project will enable the Club to keep them to a minimum, thereby removing barriers for children and families to participate in softball by offering affordable memberships.

Additionally, recognising and appreciating the efforts of volunteers is crucial in building and retaining a strong volunteer base for the Club. Volunteer recognition initiatives will help achieve this goal and ensure the Club's continued success.

Abberley Park was named by Thomas James Maling who built an original homestead in the 1860s and named it after his home village of Abberley in Worcestershire, England. After a series of different owners, the Council was offered the land in 1939 and it was decided to remove the homestead and turn the area into a public park and playground and make every attempt to retain the original 19th Century character of the parkland style gardens.

Friends of Abberley Park was formed in 2016 and is a voluntary community group who care about the use and protection of Abberley Park's environment and heritage. The aim is to improve the current state of the park and have it looking at its best for its 100th birthday in 2040.

St Albans Residents' Association Incorporated (SARA) Inc. has a number of mechanisms to reach and connect with the St Albans community. SARA supports the Friends of Abberley Park group through the provision of SARA's community resources and ensuring financial accountability for any funding they may receive.

Friends of Abberley Park is seeking funding to host four community events throughout the year: Halloween, the park's birthday, Easter, and Arbor Day. The group also organise a watering roster in the summer months, are involved in research on the park and the St Albans Creek as well as a waterway restoration project in the park, rat trapping, education of park users and consult with Council staff.



Waipapa Papanui-Innes-Central Community Board Plan

3.5 Governance Advice

3.5.1 Christchurch North Community Patrol

Noting the interest in information on community patrols, the Christchurch North Community Patrol is part of a network of over 150 community patrols around New Zealand, and part of the larger organisation, Community Patrols of New Zealand (CPNZ). Their key focus is on creating safe, resilient communities by: Patrolling residential, business and industrial areas to deter and discover criminal activity, reporting signs of suspicious activity, recording and gathering information for Police, assisting at accident and crime scenes, watching out for stolen cars, among other valuable service to the community.

Where suspicious vehicles and behaviour are observed this is passed on to the Police. The organisation also collaborates closely with the community who provide information about crime in their area particularly on social media. When this happens, these locations are added to routine patrols.



Volunteers have specialist training which means they can assist during vehicle crashes, major incidents, and disasters. Many volunteer patrollers are retired, and some are Police recruits. Patrollers are members of the public wanting to do their bit to keep communities safe from crime and they contribute around 14,000 hours of volunteer time to the organisation in a year.

Community Patrols are independent from the Police but receive regular Police guidance, training, tasking, and the Police meet most of their fuel costs. Over the past 29 years the Christchurch North Community Patrol have patrolled the largest area of all the patrols in New Zealand. The area covered includes Harewood, Belfast, Bishopdale, Burnside, Fendalton, Bryndwr, Strowan, Merivale, St Albans, Northwood, Casebrook, Redwood, Northcote, Mairehau, McLeans Island and the airport.






