1. Apologies Ngā Whakapāha

2. South Island National Rugby League Bid

Presenter: Frank Endacott, Darren Littlewood, and Poto Williams, Malcom Hunt

- Frank apologised on behalf of Tony who wasn't able to attend presentation.
- Councillor Gough Differentiation between the two south island bids confirmed they have had conversations with David Muffet but this did not fit. Would consider coming together, but believe strong enough without amalgamation.
- Councillor Barber Council's role point of contact with staff. David Bailey, Nigel Cox. Working with both Council staff and staff from CCHL. Noted they were getting good support from staff.
- Councillor McLellan Discussion regarding existing fanbase North Island/South Island rivalry would be beneficial.
- Councillor Scandrett would like to receive a better understand regarding combining the South Island.
- Councillor Keown noted that St Thomas' of Canterbury College won the national cup. Asked if presenters were happy for Council to support both bids. They confirmed that they are.
- Councillor Peters Dunedin stadium confirmed that they're in conversation with Dunedin already. Also in conversations with Wellington. Opening the pathway to the whole country.
- Councillor Harrison-Hunt difference between the two bids does the other bid have support from Canterbury Rugby League Board. Malcom confirmed they have approached the Board but not asked for support.
- Councillor Harrison-Hunt plan for growing the game in Otago and the West Coast.
 Anticipate sending coaches into the regions to push into those communities.
 Discussion on planned high performance centre. Supporting development of league and redevelopment of competition high importance.
- Councillor Johanson Discussion on establishment costs.
- Councillor Johanson Discussion on timeline. If successful, they would need a team ready November next year.
