Edwin Tiong, Traffic Engineer Traffic Operations presented to the Board giving information and staff advice on the following traffic operations projects:

- Governors Bay Dyers Pass Road, Zephyr Terrace and Governors Bay Road.
- Charteris Bay options for a footpath on Marine Drive.
- Akaroa Boart Parking Area.
- Akaroa Beach Road.

After questions and feedback from members, the Chairperson thanked staff for the presentation.

- 1. The Board agreed to request staff advice on the accident, speed and safety statistics for Governors Bay Road in the area of Cass Bay bus stop and Steadfast corner.
- 2. The Board agreed to request staff advice on the cost and funding options to continue the footpath on the seaward side of Beach Road, past the Akaroa Yacht Club and beyond the Lighthouse to enable safe pedestrian access.
- 3. The Board agreed to request signage be installed at the Akaroa Boat Park to clarify that it includes boat trailer and freedom camping parking.
- 4. The Board agreed to request staff advice on safety measures at the end of the newly formed shared use Cooptown pathway at the Puaha Road end where there is a blind corner in the road.
