2.1 Urumau Reserve - Tracks

Sarah van der Burch, local resident, spoke to the Board regarding Urumau Reserve track signage, lack of maps and dangers associated with lack of clarity around walking tracks, mountain bike tracks, and shared tracks.

After questions, the Board thanked Ms van der Burch for her presentation.

The Board agreed to request staff to investigate track signage to be installed in Urumaru Reserve to guide the users of the reserve on:

- the tracks that are for walking and which tracks are for mountain bikers or shared;
- rules on who gives way to whom on the tracks;
- the possibility of having track information panels available that show the different tracks.

2.2 2025 Canterbury 175th celebration – Pilgrim's Rock, Lyttelton

Julie Kruize, spoke to the Board regarding the planning stages for 2025 Canterbury 175th celebration in particular the idea around the installation of a new plaque near the Pilgrim's Rock in Lyttelton.
