#### Draft Ōtautahi Christchurch Future Transport 30-year strategy

Question: Overall, do you support Ōtautahi Christchurch Future Transport?

Comment: The Board considers that the second paragraph of the Vision Statement should include the words "efficiently" and "reliably" so that it reads:

"It shapes and connects Ōtautahi Christchurch and Te Pātaka-o-Rākaihautū Banks Peninsula and enables everyone to move around safely, easily, efficiently and reliably."

Question: Do you agree with the strategic challenges identified in Ōtautahi Christchurch Future

Transport?
Response: Yes
Comments:

- The Board considers that it is important to recognise the greater challenge with the growth of Neighbouring Districts and Financial support from Central Government
- The Board considers that there is a need for recognition that that future infrastructure demands will result in changes to transport patterns and demands and that there needs to be an ability to act and adapt in a timely manner.

#### **Draft Dog Control Bylaw and Policy 2024**

Question: Do you support the proposal to require dogs to be on a short leash on footpaths, shared

paths and formed tracks in greenspace areas where dogs are allowed?

Response: Yes

Question: Do you support the proposal to require dogs to be on a short leash on shared paths and

pedestrian areas on or near roads?

Question: Do you support the proposal for the Ōtākaro Avon River Corridor?

Question: Do you support the proposal to limit the number of dogs one person can be in control of in a

Question: Do you have feedback on any other parts of the Dog Control Bylaw or Policy?

Response: The Board considers that there needs to be education of dog owners, particularly new owners regarding the requirements of the Dog Control Bylaw especially around what constitutes effective control of dogs. The Board suggests that some form of literature that can be easily retained and referred to, be provided to dog owners as part of the dog registration process such as a pocket card.

#### **Draft Parks and Reserves Bylaw 2025**

Question: Do you have comments about the proposed changes to the parks and reserves bylaw?

#### Response:

- The Board notes that it is intended to update legislation, amend definitions (Aircraft, Authorised Officer, Vehicle, Park or Reserve) and add a new definition of Emergency Services. The Board considers that the definition of "Emergency Services" in Section 3 should include Civil Defence and Emergency Management so that the Section 18 exemption will extend to this group.
- The Board considers that in the Section 3 definition of "Park or Reserve" (c) the words should be prefaced by "for the purposes of this bylaw" so that it will read:

- (c) "for the purposes of this Bylaw does not include any such land, park, domain, foreshore or greenspace area which is subject to a lease that has been granted by the Council under the Local Government Act 2002 or the Reserves Act 1977."
- Section 15 includes the riding of electric bicycles, scooters and electric scooters as prohibited activities in the Christchurch Botanic Gardens. The Board would like to see provision of an exemption for riding of scooters by those under five years.
- The Board appreciates the form of the consultation documents that make it easy to identify the changes by clearly showing additions and deletions.

#### **Draft Trade Waste Bylaw 2025**

Question: Do you support the proposal to reduce the total suspended solids limit to 100g/m3 for discharges containing only inorganic mineral solids (the current total suspended solids limit of 600g/m3 for other discharges will remain).

Response: Yes

Question: Do you support prohibiting POPs (including PFAS, perfluorooctane sulfonate (PFOS) and perfluorooctanic acid (PFOA)) from any trade waste discharge?

Response: Yes

Question: For dewatering activities, do you support the proposed changes to clarify the need for a trade waste consent, in some circumstances?

Response: Yes

Question: Do you support these proposed changes to improve regulation of tankered waste discharges?

Response: Yes

Question: Do you support these proposed changes (application processing and consent expiries)

Question: Do you support introducing a maximum duration of up to 10 years for all permitted consents?

Response: The Board comments that it would have been more helpful to submitters for the consultation documents to have clearly shown the changes from the current to the proposed bylaw as in the recent consultation on the Draft Parks and Reserves Bylaw 2025.
