#### 2 December 2019

#### 1. Name of Committee

The Committee will be known as the "Akaroa Museum Advisory Committee".

#### 2. Status of Committee

The Committee will be a committee of the Banks Peninsula Community Board.

# 3. Purpose of Committee

The purpose of the Committee is to provide advice to the Community Board on the strategic issues facing the Museum and the matters arising from them.

# 4. Responsibilities

Responsibilities of the Committee are:

- To provide advice on the Museum's aims, objectives and policies and its role in the community.
- To provide a local link with the Museum's stakeholders including Friends of the Akaroa Museum, local Rūnanga and the wider community.
- To assist in obtaining local support and financial resources necessary to achieve the Museum's aims.

# 5. Composition of Committee

- The two Akaroa subdivision members of the Banks Peninsula Community Board
- Two representatives from the Friends of Akaroa Museum<sup>1</sup>
- One community representative <sup>2</sup>
- One representative from Ōnuku Rūnanga

In addition, a liaison member should be appointed from each of the Wairewa and Koukourārata Rūnanga, to attend meetings when matters of significance to their rohe (district) are being discussed.

<sup>&</sup>lt;sup>2</sup> The position of community representative will be publicly advertised, seeking expressions of interest.



The Community Board will appoint the Chairman of the Committee.

#### 6. Term of Committee

The Committee will be discharged three months from the coming into office of the members of the community board, elected or appointed at, or following each triennial general election.

#### 7. Administration

The Committee shall meet quarterly, or as required, and report to the Banks Peninsula Community Board following each Committee meeting.

A schedule of quarterly Committee meetings will be adopted annually.

As a committee of the Community Board the Committee shall be bound by the various Acts and Regulations governing the operation of a Local Authority and shall also be subject to the Council's Standing Orders.

The Akaroa Museum Advisory Committee will be assisted by the Museum Director and Community Board support staff.

# 8. Remuneration of Committee Members

Committee members will not be eligible to claim the Council's approved allowances for attendance at meetings.

# 1. Purpose and Origin of the Report Te Pūtake Pūrongo

- 1.1 The purpose of this report is to inform members of the Akaroa Museum Advisory Committee about activity at the Museum.
- 1.2 Lynda Wallace, Director.

# 2. Officer Recommendations Ngā Tūtohu

#### 3. Brief Summary

- 3.1 The Takapūneke exhibition, *He Ara Roimata ki te Anamata Takapūneke, our journey, our survivance*, ended its long and successful run in November. During the seven months it was displayed around 9,000 visitors viewed it, exposing this important story to a wide audience. There is a possibility the exhibition will be seen again, at Ōnuku Marae for Waitangi weekend 2025.
- 3.2 The Museum's summer exhibition, *The Measure of Things*, features objects used in the measurement of time, volume and space and looks at the impact that measuring and quantifying has had on human lives.
- 3.3 Prior to opening the summer exhibition new light track and lights were installed in the temporary gallery. This is the first stage of a gradual upgrade of all light track throughout the exhibition spaces, funded through the Museum's capital budget.
- 3.4 Lacking an acquisitions budget or fund, the Museum relies upon the generosity of donors or the financial support of the Friends of Akaroa Museum to develop its collection of historical art. Recently, two Will Watkins paintings were donated by a descendant of the artist, while the Friends bid on two works, a John Gibb and a Margaret Stoddart, in an (unsuccessful) attempt to acquire them for the Museum's collection.
- 3.5 With all of Akaroa's wharves undergoing modifications at present, and the 1888 main wharf due for demolition next year, the Museum is alert to the possibility of collecting relics relating to these structures. Recently council staff delivered an original wooden mooring cleat from Dalys Wharf and we have identified other small items from the main wharf as potential acquisitions.
- 3.6 The future of the BP Meats site, adjacent to the court house, is again being discussed. One of the documents included with the consultation referred to possible expansion of the Museum onto the BP Meats site. This was a purely speculative proposal that did not originate from the

- Museum and has now been removed from the consultation documents. Currently the Museum uses a container located on the site to store empty display cases only, not collection items.
- 3.7 This year is the Museum's 60<sup>th</sup> anniversary, a milestone celebrated in September at the Friends AGM. A panel of speakers with past involvement with the Museum shared their experiences and memories of the past six decades. The Akaroa Mail published a lengthy article to mark the event.
- 3.8 In early November the Museum collaborated with the Readers and Writers Akaroa (RAWA) festival by holding a curtain-raiser event at The Gaiety for members of FOAM and participants in the festival. This took the form of readings from fiction and non-fiction works about, or set in, Akaroa. The event was well attended and very favourably received.

# FRIENDS OF AKAROA MUSEUM Report to Akaroa Museum Advisory Committee – 4 December 2024

Since the last Akaroa Museum Advisory Committee meeting on 21 August 2024, here is a summary of events and issues significant to Friends of Akaroa Museum (FOAM).

- FOAM has paid for the \$1890 conservation cost of the John Gibb painting previously acquired by FOAM for the Akaroa Museum.
- FOAM's new constitution has been approved by the Companies Office.
- The Annual General meeting took place on 29 September attended by 39 FOAM members
  and community representatives. Graeme Curry stood down as President/Chair person, and
  John Curry was elected to the position. Graeme remains on the FOAM committee in the
  position of Vice President/Chairperson. The formal part of the meeting was followed by a
  panel discussion on the history of the Akaroa Museum since its founding 60 years ago.
- Three oral histories have been completed as part of FOAM's Oral History Project.
- FOAM has agreed to pay for the design and printing costs of a new book to be published by Akaroa Museum. The subject of the book is the photographic work of Don McKay, a prolific photographer on Banks Peninsula during the 1950s and 1960s. One hundred and fifty copies are to be printed at an estimated cost to FOAM of \$6,300.
- Planning and organising of FOAM's bi-annual fund-raiser, the Inside Out House and Garden Tour, are well underway. The public will be able to visit 16 locations over the weekend of 23-24<sup>th</sup> November. A significant number of tickets have already been sold.
- FOAM bid at a recent art auction on two artworks to purchase for the Akaroa Museum. One
  was a John Gibb painting of Hickory Bay, and the other was a Margaret Stoddart painting
  showing a Banks Peninsula landscape. The two works sold at prices beyond the upper limit
  that FOAM had budgeted.
- Planning is also underway for FOAM's other major fundraiser, the Akaroa Antiques Fair, to occur on the weekend of 4-5<sup>th</sup> January 2025.
- As part of the Readers and Writers Akaroa (RAWA) festival, on Friday evening, 1<sup>st</sup> November, FOAM hosted 'Love and Legacy' where talented presenters read from local literary works inspired by Akaroa and Banks Peninsula. Approximately 50 people attended the event.
