Outcomes that will be achieved through this project

Staff Assessment

The Vietnamese Society of Christchurch, an informal group active since 2013, aims to promote friendship and understanding among its members while celebrating Vietnamese culture and traditions.


The Society is seeking financial support to celebrate the Lunar New Year 2025, an annual event that unites the Vietnamese community in Christchurch. This event will feature traditional performances by Vietnamese talents in Christchurch, including traditional dances, singing, and piano recitals. Additionally, there will be food stalls and activities for children and families, such as fireworks, storytelling, a Banh Chung workshop, traditional letter and poem writing, and lucky envelopes. Approximately an attendance of over 200 people is expected. This includes members of the Vietnamese community as well as other Asian families in Christchurch and the wider Canterbury region who also celebrate the Lunar New Year and wish to explore and embrace our culture.

This event fosters cultural preservation and community cohesion through a variety of activities and cultural performances. The event will not only benefit the Vietnamese community by providing an opportunity to experience traditional New Year celebrations as they would back home, but also serves as a platform to introduce the Vietnamese culture, cuisine, and performances to the broader community.

Rationale for staff recommendation:

- The request aligns with the Multicultural Strategy, Goal 4, Christchurch is a city of cultural vibrancy, diversity, inclusion and connection and the SCT Strategy, Obj. 1.3 as by hosting the Lunar New Year Celebration, the Vietnamese Society aims to strengthen the sense of identity and belonging among the Vietnamese diaspora in Christchurch while promoting diversity and cross-cultural dialogue within the wider community.

- Although the Vietnamese Society has been advised that the Strengthening Communities Fund would be a more suitable fund to apply for, staff acknowledges that it can be challenging for smaller organisations and informal groups to navigate and fully understand the bureaucratic system of the Council's funding streams. Staff will assist the society in familiarising with the Council processes and developing its internal capacity.

Maui Maui Stuart and Nuk Korako and their whanau from Rāpaki Marae have guided us with blessings of our old and new sites and the positioning of our building with views to Adderley Head and the mountain Te Poho o Tamatea. Our new build has cost us \$2.6m; we have sourced these funds through generous sponsors, funding applications and fundraising. We are currently fundraising to pay for the fit out of the building as we do not want to move old appliances, tables and chairs into our new build. Caine has been an integral part of Coastguard in that he has overseen the design and chosen the colour palette for our new building for Coastguard Canterbury and kindly offered to carve us a taonga that will surround the front door, the main entrance to our building at a cost of \$5,000. This carving needs to be completed in time for the opening of the building on 15 March 2025 when the Governor General attends and opens the building. As you know Coastguard is a charity and we are all volunteers and unfortunately, we do not have the funds to pay Caine for his work; and through korero with Andrew Scott we are reaching out to you to see if there is a possibility you are able to pay for the funds for this taonga. Outcomes that will be achieved through this project

Staff Assessment

Coastguard Canterbury is applying funds towards a carving for the entrance to new Coastguard Building.

This taonga will show the community the partnership and support between Coastguard saving lives on the water and the local iwi. Too many of our Māori population, as well as Pasifika and Asian whanau are drowning as a result of

not having an awareness of water safety. More so now when whanau are struggling financially and accessing the moana to source kai. It isn't just boaties who are drowning unnecessarily, it is those fishing off rocks, white-baiting and diving. All these water tragedies are avoidable by education and supplying life jackets.

Promote water safety in a place where people feel safe and comfortable with their surroundings and environment.

Caine Tauwhare, who has been an integral part of this project has offered to carve a taonga that will surround the front door, the main entrance to building at a cost of \$5,000. This carving needs to be completed in time for the opening of the building on 15 March 2025.


The Coastguard have worked with Caine Tauwhare on the new build. Maui Maui Stuart and Nuk Korako and their whanau from Rapaki Marae have also guided the project with blessings of old and new sites and the positioning of the building with views to Adderley Head and the mountain Te Poho o Tamatea.

This project demonstrates the organisations continued commitment to partnering with Mana Whenua in a way that enhances the relationship and the project. The organisation shown an understanding of the importance of being Treaty Partners throughout which is a key strategic alignment for Council. By supporting this project, we are enabling a stronger cultural connection to local Mana Whenua for this facility and anyone who visits.

Rationale for staff recommendation:

- This project aligns with our strategic framework by enabling projects that support partnership.

- It supports partnership between Mana Whenua and key projects and ensures that this key project is aligned with our obligations under Te Tiriti o Waitangi.
- The new Coastguard building is a key project in the area in terms of supporting sport and recreation and this supports their cultural objectives.

It also supports young and upcoming musicians to showcase their talent and provides a space for local community organisations to fundraise. It creates economic and employment opportunities both in Lyttelton and Christchurch. Project Lyttelton strengthens the community by connecting people to share skills in waste, recycling, food, transport, and energy aiming to inspire action on climate change and build resilience together via events and educational opportunities. Discussion: Gary concerned about what we 'might be able to do' for that amount of money. If no funding for the traffic management plan they will be running at a big net loss for Project Lyttelton so the market may not run. Dane explained the request of \$50,00 and the benefit for the city and for Project Lyttelton. Is it something we want to maintain beyond the money it creates. Discussion about the future of the market going forward. Questioned whether anyone was being trained as an STMS? This would be more of a solution. Gary asked around the urgency of this application. He has more questions for Jo before we make a recommendation to Council. Decision to lay this on the table – to go to the March Council meeting. Feedback – they would like to see a more proactive approach to this issue rather than just a stopgap. Lunar New Year Celebration	Although the request aligns with the Multicultural Strategy, Goal 4, Christchurch is a city of cultural vibrancy, diversity, inclusion and connection and the SCT Strategy, Obj. 1.3 as by hosting the Lunar New Year Celebration, as the Vietnamese Society aims to strengthen the sense of identity and belonging among the Vietnamese diaspora in Christchurch while promoting diversity and cross-cultural dialogue within the wider community, the application fails to align with the purpose of the Discretionary Response Fund, which is to assist community groups with emergency or unforeseen situations.
	Having attended the Funding Expo organised in October 2024 for ethnic, cultural, and Pacific communities, the organisation was aware of the criteria guiding each of the Council's funding sources. Staff have reaffirmed to the organisation that, for business as usual, the appropriate funding is the Strengthening Communities Fund.
	Discussion: Viviana explained that there were Issues with the budget. This is business as usual. They are an informal group so can't apply for over \$2,000. She didn't feel the application met the criteria. Very small celebration with approx. 200 people. Others were supportive of funding this. There is a need to support these groups around the guidelines of our funding. They also need additional training, Panel was generally happy to support this group. Vivianna has suggested \$1,000 after looking at their budget which the panel agreed to. Change to P2.

However other groups have been asked for smaller unspent amounts to be returned. After discussion it was agreed for the group to keep the \$653 to spend on the last part of their unfinished project.
