1. Detail Te Whakamahuki

Timing	This information session is expected to last for 30 minutes.
Purpose / Origin of Briefing	<p>The purpose of this information session is to provide the Waipuna Halswell-Hornby-Riccarton Community Board an update on:</p> <ul style="list-style-type: none"> - The South West Dog Park project and present a preferred site location. - Proposed improvements to Halswell Quarry Park dog exercise area, including draft concept plan.
Background	<p>The Community Board Plan 2023-25, identified a fenced dog park as a priority for the ward, noting that,</p> <p><i>‘There are no fenced areas in the south-west of the city where dog owners can exercise their dogs off-leash in a dedicated space that allows dogs to socialise and play in a safe and controlled environment. This is particularly important for residents who may not have access to large open spaces or have large enough yards for their dogs to play in.’</i></p> <p>The Community Board requested that funding in the current LTP be moved forward (funding was allocated for 2031/32 financial year), and that staff investigate and report back to the Board with appropriate sites.</p> <p>Several community requests for a fenced dog park in the South West of Christchurch have also been received by staff.</p> <p>Staff have been investigating possible sites for a fenced dog park in the South West of Christchurch.</p> <p>A short list of sites has been identified by staff and assessed against site criteria. The preferred site is Carrs Reserve. For site selection criteria please see Attachment A.</p> <p>Carrs Reserve is located at 92 Carrs Road Halswell, south of the Southern Motorway. The Reserve is approx. 63,424m². Part of it was previously used by Canterbury Greyhounds, who have relinquished their lease, and the land now sits vacant. The site is adjacent to the Canterbury Kart Club, the future of the club’s occupation here is currently under investigation.</p> <p>This is the preferred site because:</p> <ul style="list-style-type: none"> • The site is large enough to host a dog park including agility training features and carpark. There is also space to consider a native forest patch, lizard relocation site, and potential recreational and neighbourhood park facilities. • It is located adjacent to a residential area and with strong connectivity to major arterial roads, the site is easily accessible for residents from Halswell, Wigram, and Hornby.

	<ul style="list-style-type: none"> • This development presents an opportunity to revitalize a currently vacant site. • The site features diverse topography, which, after appropriate clearing, can provide definition for different activity zones. <p>This site does however have contaminated land, is a known archaeological site of significance, and lizards are present on site. Therefore, further investigations and land management (in line with the Wildlife Act compliance) would be required.</p> <p>Halswell Quarry</p> <p>Halswell Quarry Park dog exercise area has seen a significant increase in visitor numbers and has been subject to several conflicts that are emerging due to the park's growing popularity. Due to the complex layout, Animal Control are finding it very difficult to monitor. Dogs are frequently getting lost and running around the picnic areas and off-lead dogs are running rampant around the park. There have also been several requests from the community to better manage dog use in the area.</p> <p>The proposed improvements include:</p> <ul style="list-style-type: none"> • Fencing of two dog exercise areas (funded.) • Walking path around the perimeter of the dog exercise area (unfunded - to be staged over two years as funds become available.) • Removal of the horse arena. Horses are no longer visiting the park as there is no parking for horse floats, the local paddocks are now houses, and the park is simply too busy to add a large animal into the equation. • Development of the lower paddock into a kahikatea forest and upper field as lowland native forest. Planting to be staged over several years. (Funded from existing regional parks and urban forest capital budgets.) • Extension of existing accessible track around the bottom of the park to complete a 2km loop to cater for people with mobility impairment (unfunded.) <p>The items that are funded are covered under existing regional parks budget and those that are unfunded will need to source funding through the next Long-Term Plan.</p> <p>For draft concept plan for Halswell Quarry Park dog exercise area please see Attachment B</p>
Key Issues	<ul style="list-style-type: none"> • There are current gaps in provision of dog parks in the South West areas of Christchurch. • Urban growth in the South West of Christchurch has increased the demand for dog park facilities. • Due to Halswell Quarry Park's complex layout, Animal Control are finding it very difficult to monitor. Dogs are frequently getting lost and running around the picnic areas and off-lead dogs are running rampant around the park.
Next Steps	<p>South West Dog Park</p> <ul style="list-style-type: none"> • If the Board are in support, staff can develop a landscape plan for the preferred dog park site.

	<ul style="list-style-type: none"> Community Engagement – informing and inviting the community to provide their feedback on the proposed site and landscape plan. When community engagement has been completed, staff will submit a report to the Community Board for approval of the landscape plan. Construction will be as per the current funding, unless there are changes in the Annual Plan. <p>Halswell Quarry Park Dog Exercise Area</p> <ul style="list-style-type: none"> Community Engagement – informing and inviting the community to provide their feedback on the concept plan. When community engagement has been completed, staff will submit a report to the Community Board for the approval of the concept plan.

Local Alcohol Policy Engagement

Q1.1 The Sale and Supply of Alcohol Act allows councils to develop local alcohol policies that set out rules and conditions about how alcohol is sold and supplied in their districts. If a council has a Local Alcohol Policy (LAP), licensing bodies must consider it when making decisions about alcohol licensing applications.

The purpose of a LAP is to help ensure that the sale, supply and consumption of alcohol is undertaken safely and responsibly, and to minimise alcohol-related harm. A LAP can set policies that restrict the number, location, and opening hours of licensed premises, such as bars, cafes and restaurants, supermarkets and bottle stores. The policies in a LAP can apply across either the whole city and district or only in identified local areas.

We're testing some ideas that could be included in a draft Local Alcohol Policy for Christchurch and Banks Peninsula. Give us your feedback here by 11pm Sunday 9 March 2025, or find out more about the project.

The Board accepts that reduction of hours will address alcohol related harm Xat night.

The Board is aware that some residents consider opening time for sales start later - 7 am too early. The Board prefers 8am-9pm opening hours and considers the reduced hours should apply across the city to Central City as well as Suburbs to all types of off licences.

The Board is aware that remote sales are outside the scope of LAP

Q2.5 On-licences and club licences allow venues to sell alcohol that is consumed on site such as cafés, restaurants, pubs, working men's clubs, sports clubs and night clubs. Currently the

Sale and Supply of Alcohol Act allows trading until 4am and a LAP can set conditions for maximum trading hours for all or some on-licences. Our research tells us there is alcohol related harm in locations where on-licenced venues are located. We have also identified in our district plan that we want to encourage a vibrant central city, so we are considering setting a reduced latest closing time for on-licenced venues in suburban areas.

A LAP can include a policy on whether licences can be issued at all, such as placing a freeze on new licences. It could be for a period of time for any or all types of licence or, in all or only some areas. *What would a freeze mean? A freeze would mean that licences could not be issued for a period of time for any or all types of licence or, in all or only some areas.* Our research

indicates availability of alcohol in areas of high deprivation is a concern for our communities, and residents in these areas are more likely to experience alcohol related harm. We are considering a temporary freeze on new licence applications for new venues and outlets in high deprivation areas for three years. Existing venues and outlets could still renew their licence and if they changed ownership, the new owner could still obtain a new licence. *What is a high deprivation area? High deprivation areas are generally considered to be locations that have a score of 9 or 10 on the New Zealand deprivation index. The index considers a range of factors – for example, numbers of people not living in their own home, unemployment numbers, households with no access to internet at home, numbers living in unhealthy homes, etc.)*

A 'one-way door' restriction means that people must be inside a venue, such as bar or nightclub, by a specific time, and that people cannot enter or re-enter any venue after that time. A LAP can apply a one-way door policy to on-licenced venues at a specific time during their operating hours.

A one-way door restriction aims to address alcohol related harm by encouraging alcohol consumption to take place in supervised venues and by reducing the risk of harm that can occur from people moving between venues after consuming alcohol for a long period of time.

One-way door restrictions can already be applied to on-licenced venues on a case-by-case

basis however, we could consider whether a LAP should apply a one-way door restriction for all on-licenced venues.

The Board is aware that there is some support among its residents for a one way door policy but accepts that there may be reasons to visit or revisit venues within a single night that are not related to purchasing alcohol for example for groups of people who have separated over the course of a night to meet at a single venue to travel home together.

The Board considers that there should be consideration of a cut off time for sale of alcohol at venues that is earlier than the closing time.
