Council Traffic Operations Officers in attendance presented to the Board in response to the Board's request at its 14 November 2024 meeting for a workshop to explore an alternate option that provides for a defined footpath and defined car parking areas on Richmond Hill Road.

Officers were joined by David Selman an independent design consultant from Beca that the Council engaged to investigate further options.

The options presented to the Board included marked parking bays, pedestrian access, speed management and signage.

Members raised questions about the budget available for safety improvements and the viability and cost implications of larger improvements.
