The agenda was dealt with in the following order.

### 1. Apologies Ngā Whakapāha

There were no apologies received.

#### 2. New Footpath Programme

**Presented by:** Jacob Bradbury – Manager Planning and Delivery, Transport, Trudy Jones, Transport Planner

- Note that the online version of the presentation is updated.
- Staff introduced the topic and provided some background. Discussed scope of the Multicriteria analysis. Discussed sources of data used, and exclusions. Note, does not include interim measures.
- Highlighted important points of appendices, ability to include and remove data, contingencies, and sensitivity testing.
- Note deliver first 15.
- Discussed exclusion of Main South Road.
- Discussion of masterplan. Staff confirmed that it's started. **ACTION:** Memo update to the board regarding the timeline of the masterplan.
- Discussion of ratings for specific roads. Staff explained the combination of the different aspects decide the rating. **ACTION:** Staff to provide full details of assessment.
- Discussion of interim measures.
- Discussion of Gardiners Road footpath. Staff confirmed still on programme, still part of the LTP. Confirmed upcoming briefing to the Community Board.
- Discussion of Ferry Road. Confirmed east of the State Highway. Discussion of inclusion for this to be done at the same time as other community requested changes or advancements.
- Discussion of Mount Pleasant Billy's track. Note can be added.
- Confirmed list can be extended. Note just about prioritisation, not selecting what can and can't be done.
- Discussion of Governor's Bay Road Cass Bay. Confirmed based off speed limit and traffic counts. Note important to feedback through.
- Note that where the footpaths will be located is data which Councillors would like to know.
   Confirmed will be discussed at board level.
- Discussion of Lower Styx Road note low use but high speed and no alterative options to stay off road. Confirmed low use will be lowering prioritisation.
- Discussion of whether when raising the works came from Community Board feedback/incorporated community board feedback, this can be feed into the commentary section of the matrix. ACTION: Staff to investigate whether this is possible.
- Discussion of Normans Road, whether these works could be tied in with Parks works.
   ACTION: Staff to confirm.
- Discussion of whether future development such as retirement villages about to open where considered. Confirmed.
- Discussion of Development Contributions.



# 3. Census 2023 Key Insights and Update on StatsNZ Modernising the Census programme

**Presented by:** Aimee Martin, Senior Data Analyst.

- Staff discussed the key findings of the 2023 census.
- Discussion of bedroom numbers for unoccupied dwellings. **ACTION:** Staff to investigate whether this data is available.
- Discussion and confirmation of what constitutes crowding.
- Staff discussed the future of the census, including timeframes for release, changes and implications. Discussed variables staff are currently concerned about.
- Discussion of requesting forward looking data. Staff confirmed staff doing some of this. Note that StatsNZ already do a range of projection data regarding demographics, unsure whether they can do this for transport matters.
- Discussion of whether this provides an opportunity to look at the data we are collecting. Aimee confirmed staff working on this. Noted that they were considering adding some of the variables into Life in Christchurch survey.
- Discussion of Māori housing changes.
- Discussion of use of housing quality data.
- Confirmation that staff should be able to pull housing quality changes data based by suburb.

Meeting concluded at 3.15pm.
