#### 3. Lyttelton Policing Update

#### **Community Board Information Session/Workshop Notes**

Senior Sergeant Roy Appley and Sergeant John Moody of the NZ Police provided an update regarding Lyttelton Policing.

During the presentation the following was noted:

- The Board discussed the recent concern of Women's safety in Lyttelton, the Police acknowledged that they have met with the relevant people and that a small working group is being implemented.
- Discussion was held regarding the issue of anti-social driving behaviour and the Police resources that are being put into that issue.
- The Police advised that the community needs to report any suspicious activity:
  - All calls for service are prioritised.
  - Police attendance depends on several factors, including the risk level, available resources and what's happening at the same time.
  - Just because Police don't attend, it doesn't mean that the Police are not acting.
  - Always report the Police can't act if the Police don't know.



# 4. Te Pātaka o Rākaihautū Banks Peninsula Public Toilets Community Board Information Session/Workshop Notes

Marie Adamski, Senior Parks Asset Planner, presented an update to the Board on the maintenance and renewal works currently underway and planned for public toilets across Te Pātaka o Rākaihautū Banks Peninsula.

During the presentation the following was noted:

- Every five years the public toilets in Te Pātaka o Rākaihautū Banks Peninsula are formally assessed.
- Little River Wairewa Public Toilets now have an alarm system to advise the Council when the toilet system is needing attention.
- The Board agreed to hold a strategic workshop in the new Board term on public toilets.
