Delegate the following responsibilities, duties, and powers to the Central City Parking Restrictions Subcommittee:

1. Parking and Traffic Bylaw 2017 or any substituted bylaw:

Delegation

With respect to that area of the Central Business District of Christchurch shown on Plan A (inclusive both sides of the street marking the boundary), and whether it relates to "on-street" or "off-street", under clause 7

- Prohibiting or restricting the stopping, standing or parking of vehicles, or any class of vehicles, on any road; or
- Limiting the stopping, standing or parking of vehicles on any road to any class of vehicles.
- Prescribing any conditions under clause 7.

With respect to that area of the Central Business District of Christchurch shown on Plan A (inclusive both sides of the street marking the boundary), and whether it relates to "on-street" or "off-street", under clause 8

- Designating an area to be a zone parking area and the restrictions that apply in that zone parking area ("zone parking controls"); and
- Reserving any area of land or any road or any part of a road or any building or any part of a building to be a parking place or transport station, subject to restrictions; and
- Specifying the vehicles or classes of vehicle that can use or must not use a parking place or transport station or zone parking area; and
- Prescribing the restrictions that apply including (without limitation) the times, manner and other conditions for the parking of vehicles or classes of vehicles in a parking place or transport station or zone parking area.
- Making provision for the efficient management and control of a parking place or transport station or zone parking area.

With respect to the district of Christchurch City, whether it relates to "on-street" or "off-street", under clause 8

- Prescribing any charges to be paid for the use of a parking place or transport station or in a zone
 parking area, subject to the limits set out in the Annual Plan or Long Term Plan as the case
 may be. (See limits set out below which may change each year the Annual Plan or Long term
 Plan is adopted)
- Prescribing the manner by which parking charges may be paid by the use of parking machines or in any other manner

- (iii) All Day meter rate 2021/2022 Annual Plan \$3 to \$10
- (b) Coupon Parking 2021/2022 Annual Plan \$3.70
- (c) Meter Hoods per day 2021/2022 Annual Plan \$30.00
- (c) Meter Hoods per month 2021/2022 Annual Plan \$450.00
- (d) Waiver of Time limit restriction 2021/2022 Annual Plan \$210.00
- (e) Residential Parking Permits 2021/2022 Annual Plan \$100.00

At Ground (or 'at grade') Off-Street Parking

Determination of fees on individual sites is delegated to the Parking Restrictions Subcommittee within the following range: - \$0 to \$25.00 per day or part thereof

Parking Buildings

The determination of fees on individual sites, including but not limited to, the following locations:

- (i) Art Gallery Car Park 2021/2022 Annual Plan up to \$5.00 per hour
- (ii) Lichfield Street Parking Building 2021/2022 Annual Plan up to \$5.00 per hour

With respect to that area of the Central Business District of Christchurch shown on Plan A (inclusive of both sides of the street marking the boundary), and whether it relates to "onstreet" or "off-street", under clause 10

- Reserving any specified parking place or places as
 - (a) residents' only parking area for the exclusive use of persons who reside in the vicinity; or
 - (b) residents' exemption parking area for the use of persons who reside in the vicinity.
- Prescribing -
 - (a) any fees to be paid annually or in any other specified manner, for the use of a residents' parking area or a residents' exemption parking area; and
 - (b) the manner by which any such fees may be paid for the use of a residents' parking area or a residents' exemption area; and
 - (c) which parking, stopping and standing restrictions permit holders are exempt from within a residents' exemption parking area.

With respect to that area of the Central Business District of Christchurch shown on Plan A (inclusive of both sides of the street marking the boundary), and whether it relates to "onstreet" or "off-street", under clause 11

• Allowing motor vehicles to stop, stand, or park in that part of the road in contravention of clause 11(1) or 11 (2).



- 1. Receives the information in the Antigua Street Proposed No Stopping / Parking Restrictions Report.
- 2. Notes that the decisions in this report are assessed as low significance based on the Christchurch City Council's Significance and Engagement Policy.
- 3. Revokes any previous resolutions pertaining to traffic controls made pursuant to any bylaw to the extent that they are in conflict with the parking or stopping restrictions described in resolutions 4-7 below, and as detailed on **Attachment A** to the report.
- 4. Approves that the stopping of vehicles be prohibited at any time on the western side of Antigua Street, commencing at a point 4 metres north of its intersection with Tuam Street and extending in a northerly direction for 8 metres, in accordance with Clause 7 of the Christchurch City Council Traffic and Parking Bylaw 2017, as detailed on Attachment A to the report.

This restriction is to apply on any day, from 6:00 am to 10:00 pm. This is detailed in **Attachment A** to the report on the meeting agenda (Plan TG150164 dated 14/04/2025)
- 5. Approves that in accordance with Clause 7 of the Christchurch City Council Traffic and Parking Bylaw 2017 that a taxi (or small passenger service vehicles) stand be installed on the south side of St Asaph Street commencing at a point 137 metres west of its intersection with Madras Street, and extending in a westerly direction for a distance of 40 metres. - 5. 5. Pīpīhihi Lane - Proposed Parking Restrictions - No Stopping (Except Authorised Vehicles)

1. Purpose and Origin of the Report Te Pūtake Pūrongo

- 1.1 The purpose of this report is to introduce a parking restriction that can be enforced by Christchurch City Council.
- 1.2 The restriction is to apply only to the area highlighted as Pīpīhihi Lane, see **Attachment A.**
- 1.3 This report has been written in response to drivers parking on Pīpīhihi Lane, which is currently unrestricted. Current driver behaviour could lead to access issues in the future where deliveries of goods and services to support the activities of the Court Theatre are blocked by parked vehicles.
- 1.4 The proposed restriction, and accompanying signage, is expected to deter drivers from parking in the lane. Non-compliance with the restriction can also be penalised by issuing appropriate parking infringements, which should also curb the non-compliant behaviour.

2. Officer Recommendations Ngā Tūtohu

That the Central City Parking Restrictions Committee:

- 1. Receives the information in the Pīpīhihi Lane Proposed Parking Restrictions No Stopping (Except Authorised Vehicles) Report.
- 2. Notes that the decisions in this report are assessed as low significance based on the Christchurch City Council's Significance and Engagement Policy.
- 3. Revokes any previous resolutions pertaining to traffic controls made pursuant to any bylaw to the extent that they are in conflict with the parking or stopping restrictions described in resolution 4 below.
- 4. Approves that, in accordance with Clause 7 of the Christchurch City Council Traffic and Parking Bylaw 2017, the stopping of vehicles be prohibited at any time on Pīpīhihi Lane, as detailed on Attachment A, plan TG151615, Issue 2, dated 24/07/2025, subject to the following exceptions and conditions:
 - a. Goods Service Vehicles, for the purposes of loading /unloading activities relating to properties within, or requiring access from, Pīpīhihi Lane only.
 - b. Street cleaning & rubbish collection vehicles operated by the Christchurch City Council or its nominated contractor.
 - c. Trade and other vehicles (including those operated by service authorities) of any class of vehicle, if authorised to do so by the Council Officer who holds the position of Head of Transport at that time.
 - d. Emergency vehicles.



- e. Any vehicle or specified class of vehicle that has entered Pīpīhihi Lane under the above provisions must not be parked for longer than is necessary for its driver to carry out their business or for the period of any emergency.
- 5. Approves that these resolutions take effect when parking signage and/or road markings that evidence the restrictions described in this report are in place (or removed in the case of revocations).

3. Background/Context Te Horopaki

- 3.1 Pīpīhihi Lane has recently been developed as part of the Performing Arts Precinct Laneways around the Court Theatre. It is a new lane.
- 3.2 The Laneway names were approved by the Waipapa Papanui-Innes-Central Community Board meeting dated Thursday 12 December 2024.
- 3.3 The Court Theatre is currently using this lane for establishment and fitout, including deliveries of goods and services to support the activities of the theatre.
- 3.4 Currently there are no signs or restrictions to stop drivers from parking in this lane.
- 3.5 The lane is to be managed by Christchurch City Council's Transport Unit, and it is not private property where other restrictions to parking could be imposed.
- 3.6 The lane has been temporarily chip sealed until a decision is made about the storage shed, yet to be built in the Court Theatre's yard.
- 3.7 Currently drivers are parking in the lane, as shown in Figure 1 below.
- 3.8 The proposed recommendation is based on existing restrictions within the South Frame Laneways (i.e., Mauri Ora Lane, Lava Lane, Te Pohue Lane, Sugarloaf Lane, Mata Lane and Nurseryman Lane).
- 3.9 The proposed recommendation is considered the best solution in terms of communicating the restriction to drivers and being enforceable by Council officers. The existing situation is not acceptable for the future operation of Court Theatre and the Performing Arts Precinct as a whole.



1. Purpose and Origin of the Report Te Pūtake Pūrongo

- 1.1 The purpose of this report is to seek approval of the Central City Parking Restrictions Committee to introduce a new parking restriction outside The Youth Hub at 109 Salisbury Street.
- 1.2 This report has been written in response to a request for this restriction from The Youth Hub in consultation with the Community Liaison Group.
- 1.3 The proposed time restriction is five minutes, active between 8am to 6pm only. The restrictions will enable visitors to The Youth Hub to undertake pick-up/drop-off activities outside the facilities.
- 1.4 It also enables courier, taxi, rideshare and delivery drivers to perform similar activities.
- 1.5 The recommended option is to install a P5 time restriction as shown on **Attachment A**.

2. Officer Recommendations Ngā Tūtohu

That the Central City Parking Restrictions Committee:

- 1. Receives the information in the 109 Salisbury Street Proposed Parking Restrictions P5 Report.
- 2. Notes that the decisions in this report are assessed as low significance based on the Christchurch City Council's Significance and Engagement Policy.
- 3. Revokes any previous resolutions pertaining to traffic controls made pursuant to any bylaw to the extent that they are in conflict with the parking or stopping restrictions described in resolutions 4 below.
- 4. Approves that **the parking of all vehicles be restricted to a maximum period of 5 minutes**, in accordance with Clause 8 of the Christchurch City Council Traffic & Parking Bylaw 2017, on the north side of Salisbury Street commencing at a point 118 metres east of its intersection with Durham Street North and extending in an easterly direction for a distance of 18 metres as detailed on **Attachment A** (TG151614, Issue 2, dated 24/07/2025). This is to apply between 8am and 6pm only.
- 5. Approves that these resolutions take effect when parking signage and/or road markings that evidence the restrictions described in this staff report are in place (or removed in the case of revocations).



3. Background/Context Te Horopaki

- 3.1 The request was raised by The Youth Hub in consultation with the Community Liaison Group.
- 3.2 The Community Liaison Group was established with representatives of the Victoria Neighbourhood Association (or subsequent resident association). The Group was established as part of the resource consent conditions to be a forum for the dissemination of information from the consent holder (i.e., the Youth Hub) and affected neighbours.
- 3.3 The basis for the P5 restriction is from a resource consent condition (RMA/2024/3268):
 - All car parking spaces within the Salisbury Street car park, with the exception of any parking space for the disabled, shall be marked as P5 time restricted. This condition shall cease to apply if P5 parking spaces become available on Salisbury Street adjacent to the site.

Figure 1: RMA/2024/3268 - Condition 8.

- 3.4 The cessation of the above condition would allow the Youth Hub to operate their off-street park with longer stay parking. Long stay parking is needed for the operation of the facility, as it provides more space on-site for important visits (e.g. police officers).
- 3.5 Staff carried out a site visit on 6 May 2025 to help assess the request.
- 3.6 The proposed P5 time restriction aligns with Christchurch City's Central City Parking Policy¹, in particular: to encourage short stay parking within the 'Residential Central City'.
- 3.7 The short stay parking (i.e. P5) at this location is considered to have several benefits to the community:
 - 3.7.1 Youth Hub gets a pick-up/drop-off facility that is directly outside the facility, which encourages visitors to use it and thereby generate a higher turnover at this location.
 - 3.7.2 The higher turnover is more likely to keep the space clear for drivers, when they need to use it.
 - 3.7.3 A space that is kept clear, or one with a higher turnover than the current situation (i.e. long stay parking), has the added benefit of improving sightlines for drivers exiting Gracefield Avenue.
 - 3.7.4 The short-stay parking can be used by multiple users (e.g. delivery drivers, rideshare, taxi drivers).
 - 3.7.5 The restriction is only taking up three spaces, a relatively small footprint.
 - 3.7.6 The restriction is only applicable between 8am to 6pm. Outside these hours the space is unrestricted and can be used by residents and visitors to the area.
- 3.8 No other options were considered. The P5 restriction is considered the most efficient solution to meet the needs of the request.


