1. Detail Te Whakamahuki

Timing	This information session is expected to last for 30 minutes.		
	A street renewal project has been initiated to renew and enhance transport assets within the Amyes Road corridor, addressing the poor condition associated with the carriageway, kerb and channel, deep dish channel, and footpath.		
Purpose / Origin of the Information Session	The project has progressed through early engagement as part of the project's scheme design phase. This session is an opportunity for Staff to present the feedback received from the public, as well as the high-level scheme options developed following the engagement.		
	Staff are requesting direction from the Waipuna Halswell-Hornby-Riccarton Community Board in terms of priorities as the scheme design option is developed further.		
	Amyes Road Street Renewal aims to renew and upgrade the transport infrastructure along Amyes Road between the Springs Road intersection and the rail crossing near Shands Road. This includes the road carriageway, deep dish kerb and channel, and footpath.		
	Other objectives include:		
	 Enhancing pedestrian access and safety through upgraded footpaths and road crossings, including school crossing points 		
	Review carriageway width and ensure the width supports the nature of the street as a minor arterial road with residential land use and schools		
Background	 Implement a design speed that aligns with the desired operating speed of 40- 50km/hr and achieve Safe System speeds at key conflict points such as pedestrian crossings and intersections 		
	 Incorporate appropriate cycle facilities consistent with the NZTA Cycling Network Guidance for a road of this type. The street has been listed as a planned local cycleway under the Ōtautahi Christchurch Future Transport Plan 		
	Implement Council tree policy		
	The project team has received feedback from the public through Early Engagement and used this to develop three high-level scheme options. The team are meeting with the Waipuna Halswell-Hornby Riccarton Community Board to discuss the feedback received and the options generated. We are requesting a steer regarding which of the scheme options to develop further over the coming months.

Key Issues	 Early engagement feedback Spatial constraints – unable to fit cycle lanes and parking in current road corridor Undergrounding of power or relocation of Orion/Chorus poles Crossing point at Te Manu Tukutuku South Hornby School
Next Steps	 Further develop scheme options in accordance with Waipuna Halswell-Hornby-Riccarton Community Board advice. Deliver a decision report to the 2025-28 Board to approve a scheme design.

Purpose / Origin of the Workshop	The purpose of this workshop is to: Gain insights from the Community Board to inform future processes and development of the following policies: • Free Waste Dumping • Litter and Illegal Dumping
Background	 On 19 February 2025 a Notice of Motion was raised to: Explore options, in addition to those outlined in the Free Waste Dumping Policy 2003, to allow community groups and citizen volunteers to dispose of waste (including green waste) at no cost. Investigate the possibility of green waste disposal in city transfer stations at no cost for Banks Peninsula residents. The current Free Waste Dumping Policy was adopted in 2003 and is due for review. The notice of motion has triggered a policy review for free waste dumping, littering and illegal dumping.

1. Detail Te Whakamahuki

Timing	This would have in some at all the last for 20 min.
i	This workshop is expected to last for 30 minutes.
Purpose /	The purpose of this workshop is to present the Community Parks Rolling Renewal Programme for the current year and the next three years, and to gather feedback. Considerable effort has been made to ensure renewal projects are distributed fairly across all Wards, with a strong emphasis on prioritising assets in poor (Condition 4) or very poor (Condition 5) condition.
Origin of the Workshop	Individual project budgets are not included in the presentation. Costs are allocated at the programme level once work has been competitively priced.
	To strengthen the engagement process, staff will return to the Waipuna Halswell-Hornby-Riccarton Community Board in the new term with an updated Community Parks Rolling Renewal Programme for resolution, incorporating any changes proposed by the Board.
Background	During the deliberation of the FY2024–25 Annual Plan, elected members expressed concerns about the lack of visibility into individual renewal candidates within the Parks Rolling Renewal Programmes. In response, the Parks Unit committed to visiting all Community Boards annually to gather feedback on the proposed Rolling Renewal Programmes.
	The renewals programme for the current financial year (FY26) has been scoped and is ready to deliver, for that reason we recommend no change to this year as it will impact deliverability.
Key Issues	 The programmes across the next three financial years (FY27, FY28 and FY29) are indicative, and elected members can provide feedback and requests for changes. Any changes made to the renewals programme will likely require substitution and reprioritisation of renewals across the reserves to remain within the budget envelope.
	Elected members must provide feedback and any requests for changes or substitutions to their Community Board Advisor, who will compile and send them to staff for investigation. All feedback and requests must be submitted by 5 September 2025. Investigate proposed changes/substitution and re-prioritise rolling renewals programmes for FY27 to FY29.
Next Steps	Staff will investigate the proposed changes and substitutions and re-prioritise the rolling renewals programmes for FY27 to FY29.
	Present a decision report to the Waipuna Halswell-Hornby-Riccarton Community Board early in the new term reflecting the changes put forward by the board members for resolution.
