## 2. Amyes Road Street Renewal - Scheme Design and Early Engagement

Nic Catto, Project Manager, Krystle Anderson, Senior Engagement Advisor and Barry Hayes, Team Leader TSD outlined the project objectives and early engagement feedback received from 118 responses.

Staff explained the three design options and answered questions from members. Following discussion, the Board gave staff direction with the preference of option 3, noting the additional cost of moving Chorus electrical infrastructure underground.
