- 3. Revokes any previous resolutions pertaining to traffic controls made pursuant to any bylaw to the extent that they are in conflict with the parking or stopping restrictions described in resolutions 4-5 below.
- 4. Approves that, in accordance with Clause 7 of the Christchurch City Council Traffic and Parking Bylaw 2017, the parking of vehicles be restricted to a maximum period of 30 minutes between 8:00am and 4:30pm, on the southern side of Riccarton Road, commencing at a point 7 metres west of its intersection with Wharenui Road and extending in a westerly direction for a distance of 45 metres as detailed on Attachment A, drawing TG150137, dated 31/7/2025 to the report on the meeting agenda.
- 5. Approves that in accordance with Clause 7 of the Christchurch City Council Traffic and Parking Bylaw 2017, the stopping of vehicles be prohibited between 4:30pm and 6:00pm, on the southern side of Riccarton Road, commencing at a point 7 metres west of its intersection with Wharenui Road and extending in a westerly direction for a distance of 45 metres as detailed on Attachment A, drawing TG150137, dated 31/7/2025 to the report on the meeting agenda.
- 6. Approves that these resolutions take effect when signage and/or road markings that evidence the restrictions described in 3, 4 and 5 are in place (or removed in the case of revocations).
